Getting Up to Speed



EP Police Academy recruits trained last week on the Emergency Vehicle Operations Course (EVOC) in Kingston. EVOC is a 40hour class and recruits are instructed in the legal aspects of law enforcement driving, non-emergency response driving, emergency response driving, and pursuit driving. During the EVOC course, recruits are required to complete practical exercises such as a timed-skill course, skid control methods, collision avoidance methods, and serpentine steering, as well as demonstrate vehicle dynamics and minimizing potential loss of vehicle control. There are currently 20 recruits in the 7-month academy and graduation will be held on Jan. 6, 2017.

Spotlight On Safety

Lightning Safety

Did you know that if you can hear thunder, or see an oncoming storm, this means that lightning is close enough to strike? Recently our area has experienced rain storms with lightning strikes. Often overlooked as an occupational hazard, lightning strikes can be a serious risk to those who work outdoors on or near tall objects. with or near metal scaffolding, and with metal equipment or machinery, utility lines, water, water pipes, and plumbing.

It is important to stay aware of daily forecasts to ensure workers will not be outside during a storm. If you see high winds, dark clouds, or distant thunder or lightning, you should take shelter in a building or a hard-topped vehicle with the windows up. Do not return outside until 30 minutes after the thunder has stopped. If you are caught outside in a storm and cannot get inside, retreat to an area that is at a lower elevation than the surroundings. Keep clear of tall, isolated objects such as trees or flagpoles and stay away from bodies of water.

Remember, lightning victims DO NOT carry an electrical charge and are safe to touch. If a coworker is struck by lightning, they need urgent medical attention and you should call 911 immediately.

Special Guest Commissioner's Corner

The continued development of innovative, cost-efficient programs that help to protect public health and the environment has made DEP a leader in our industry and I'd like to use this space to tell you about one of our most recent initiatives. Recently, two separate DEP programs have come together to help conserve water and improve the health of New York Harbor in a sustainable manner. Over the last few weeks we have begun a pilot program that utilizes recycled porcelain from inefficient bathroom fixtures to help our curbside rain gardens absorb stormwater!

DEP is in the midst of a \$50 million project to replace older, inefficient bathroom fixtures in 500 public school buildings across the city. The project is expected to conserve 4 million gallons of water every school day. Already, more than 10,000 outdated fixtures have been replaced with new, high-efficiency fixtures. Rather than send those older porcelain fixtures to a landfill, as part of the pilot project, they have been cleaned, broken into small pieces and are being used to help ensure that curbside rain gardens can absorb up to 2,500 gallons of stormwater during each rainfall. Typically, during construction of a rain garden, after excavating to a depth of five feet, each site is backfilled with layers of stone and engineered soil. These layers contain void spaces that store the stormwater and promote infiltration. In the pilot project, the recycled porcelain is taking the place of the stone. By absorbing stormwater before it can drain into the combined sewer system, rain gardens help to reduce overflows and improve the health of local waterways. DEP will study the pilot rain gardens to determine how well the recycled porcelain performs while looking for other opportunities for their re-use. More photos are available here.

I'd like to acknowledge the staff that have worked so hard to plan, design and execute this work, including Pinar Balci and Vlada Kenniff for having the determination to recycle the fixtures from the onset of the conservation project, Ben Huff for coordinating the work between agencies and private partners, Phil Simmons and his team for securing the necessary permits, and Derrick Tonning and Andres Garcia for managing the work with the pilot rain gardens. Also thanks to John McLaughlin and Jackie Chan for their efforts in this endeavor.



New Boat Launch on the Pepacton



Since it opened on May 27th, the new boat launch site at Miller Hollow, along Pepacton Reservoir, has been a big hit with visitors coming from Downsville, Roscoe and other points to the south and west of the reservoir. DEP's recreational boating program led to 1,463 visits in 2015, an all-time record and the largest year-over-year increase in participation since it began in 2012. That increase was largely driven by the success of the rental program, which allows visitors to rent pre-cleaned and registered kayaks and canoes from 10 launch sites along the reservoirs.
