#### DEPARTMENT OF DOCKS.

Co. of New Jersey, for permission to extend the platform to be erected between Piers 13 and 14, North river, under resolution of the Board adopted 28th ultimo, to the new bulkhead line as now established; and, being read, on motion it was

Resolved, That the resolution adopted by this Board on 28th November, 1877, whereby permission was granted to the Central R. R. Co. of New Jersey, to erect a platform in front of bulkhead between Piers 13 and 14, N. R., be and is hereby altered and amended, so as to permit the said platform to extend about 125 feet westerly from said bulkhead, instead of 30 feet, and to fix the rent to be paid to this Department for the use of the land under water to be covered by said platform, at the sum of \$800 per annum, payable quarterly in advance, from and after 1st January, 1878, instead of at \$200 as provided therein.

Resolved, That permission be and is hereby granted to the Morrisania Steamboat Company to erect and maintain, free of cost and expense to the City, a pier 25 feet in length, by about 60 feet in width, at the bulkhead at Fifty-first street, East river, to be used for commercial purposes and as a passenger landing; with the privilege of erecting and maintaining on the northerly portion of said structure a small one-story shed for the protection of passengers, and a fence to secure the taking of tickets, but to remain open when not required for such purpose; provided that the said Company shall pay to this Department, as rent for the land under water to be covered by said structure, the sum of \$50 per annum, payable annually in advance, from and after 1st January, 1878; that the said pier and shed will be constructed upon plans first approved by the Engineer-in-Chief of this Department, and that all the work will be done under his supervision, and that the said shed will be constructed subject to the regulations of the Superintendent of Buildings, and that all the said improvements shall revert to and become the property of the Corporation of the City of New York at the expiration, on 1st July, 1887, or sooner termination of the lease for said bulkhead, free of all claim tor cost or otherwise; and provided further, that it be expressly understood and agreed that the issuing of this permit shall not be construed as granting to said Company any right to establish, maintain, or continue a ferry, nor as a recognition, either by the Mayor, Aldermen and Commonalty of the City of New York, nor by this Department, of the right of said Company to establish, maintain or continue a ferry, nor of the right of said Company to continue to run their boats between different points in the City of New York without first having obtained a ferry franchise therefor from the Commissioners of the Sinking Fund.
