

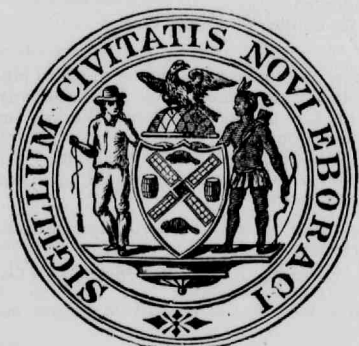

By the President—
Whereas, The failure of the city authorities to provide means to celebrate each recurring anniversary of "Independence Day," for several years, is to be deplored, and steps should be taken to avoid a repetition of an omission that is a reflection on both the government and people of this city. These celebrations tend to renew affection for the great and pure-minded men who controlled and guided this Republic in its infancy; revives among the people patriotic recollections of the struggle for independence; tends to transmit to succeeding generations a more abiding interest in the trying scenes that preceded and accompanied the advent of our country into the family of nations; instills into the public mind a deeper respect for the sage instructions and wise counsels of the men who pledged their lives, their fortunes, and their sacred honor, for the liberty of the people, and excites a desire to emulate the example of those who perilled all that men hold dear in the cause of human freedom; and,
Whereas, While this Board is averse to the indiscriminate use of fire-works and other explosives, in the streets of this city, yet it is clearly of opinion that all our citizens would not only uphold but applaud the city authorities in making ample provisions for properly commemorating the anniversary of an event so pregnant with patriotic memories; be it therefore

Resolved, That the Department of Public Parks be and is hereby requested to include in its departmental estimate for the year 1881 the sum of ten thousand dollars, to be expended for a display of fire-works in the Central Park (now easy of access to all the people of this city), on the evening of the fourth day of July, 1881, and to include a like sum for a like purpose for each succeeding year; and the President of this Board, who is a member of the Board of Estimate and Apportionment, is hereby instructed to aid in securing the appropriation of the amount above named for the purpose specified.

To Hon. JOHN J. MORRIS, President of Board of Aldermen:

The owners of lands in the City of New York, situate on the westerly side of Fourth avenue, between Eighteenth street and Nineteenth street, and on the northerly side of Eighteenth street, between Fourth avenue and Broadway, hereby protest against the allowance of any encroachment upon either the Fourth avenue or upon Eighteenth street by the owner of the premises situate on the northwesterly

corner of Eighteenth street and Fourth avenue, adjoining both on the Fourth avenue and Eighteenth street the lands of the undersigned or some of them.

Hon. JOHN J. MORRIS, President Board of Aldermen:

The foregoing (see original copy) diagram is copied from the proposed plan of the building to be erected on the northwest corner of Fourth avenue and Eighteenth street, on file with the Department of Buildings, and shows a proposed encroachment on Eighteenth street beyond the street-line, of three towers six stories in height, each encroaching beyond the street-line, the first three stories, four feet by fourteen feet, and the three upper stories two feet by fourteen feet, and also the proposed encroachment on the Fourth avenue beyond the avenue line of one tower, six stories in height encroaching beyond the avenue line, the first three stories four feet by fourteen feet, and the three upper stories two feet by fourteen feet.

All the owners of lands on the north side of Eighteenth street, lying between the proposed new building and Broadway, and also all the owners of lands on the west side of Fourth avenue, lying between the proposed new building and Nineteenth street, as shown by the foregoing writing, protest against any encroachment whatever, either on Eighteenth street or on Fourth avenue.

CHAPTER 123.

AN ACT in relation to arrears of taxes in the City of New York, and to provide for the reissuing of revenue bonds in anticipation of such taxes.

Passed April 15, 1880; three-fifths being present.

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. At any time after the passage of this act, and before the first day of October, eighteen hundred and eighty, any person may pay to the Comptroller of the City of New York the amount of any tax upon real property belonging to such person, heretofore laid or imposed and now remaining unpaid, together with interest thereon at the rate of seven per centum per annum, to be calculated from the time that such tax was imposed to the time of such payment, provided, also, that the time when such payment may be made on the amount of any such tax laid or imposed in the years eighteen hundred and seventy-seven, eighteen hundred and seventy-eight, and eighteen hundred and seventy-nine shall extend to the first day of April, eighteen hundred and eighty-one. The Comptroller shall make and deliver to the person making any such payment a receipt therefor, and shall forthwith cancel the record of any such tax on the books of the finance department; and upon such payment being made such tax shall cease to be a lien upon the property and shall be deemed fully paid, satisfied and discharged, and there shall be no right to any further interest or penalty by reason of such tax not having been paid within the time heretofore required by law, or by reason of any statute passed requiring the payment heretofore of any penalty or interest over seven per centum per annum upon any unpaid tax.

Sec. 2. Any revenue bond heretofore issued in anticipation of the taxes in the first section specified which may fall due and become payable before said taxes are collected, may be reissued by the comptroller of said city, in whole or in part, for such period as he may determine, not exceeding one year.

Sec. 3. This act shall take effect immediately.
