

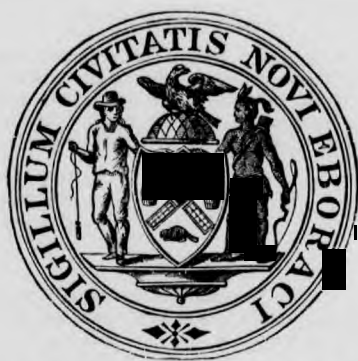

The Committee on Streets, to whom was referred the annexed petition from the unemployed laborers of this city, asking that all available money shall be used for the improvement of water-works, parks, and streets, etc., respectfully

REPORT:

That your Committee visited the Departments of Public Works, Parks, Docks, Charities and Correction. At the Department of Public Works a detailed statement of all moneys appropriated, and the balances on hand September 28, was given your Committee, and is hereto attached. Your Committee was informed that no additional labor would be employed, as the appropriation would barely suffice to carry on the improvements now in progress of completion. At the Department of Docks Mr. Wales, the President, stated that while that Department had all the money they needed, and experienced no difficulty whatever in raising the same, still all the work that could be possibly done along the river-front was under way at the present time. At the Department of Parks a detailed statement was also given your Committee, from which it appears that there only remains the sum of \$33,357.01, applicable for salaries, labor, and materials for three and a half months.

In the opinion of your Committee more money is unnecessarily expended in the Departments of Public Works and Parks for salaries of clerks and other officials, which could be used to advantage in employing mechanics and laborers.

Your Committee believe that some means should be devised by his Honor the Mayor, and the various Departments, to relieve the suffering, starving classes of this city by employing them upon different public improvements, in order, as the petitioners truthfully state, "to save the honest laborers from death and starvation."

The following resolution is respectfully offered for adoption:

Resolved, That his Honor the Mayor be and he is respectfully requested to convene the heads of Departments of the city government, in order that some lawful means may be devised to provide employment for the unemployed laborers of this city.

The Committee on Law Department, to whom was referred the resolution hereto annexed, which was unanimously adopted by your Honorable Body on the 30th day of March, 1876, respectfully beg leave to

REPORT:

We have carefully examined the report of the Commissioners of Accounts (Document No. 6), and find therein evidence of the most conclusive character—mainly documentary—tending to prove that Andrew H. Green, during his connection with the Park Department, in most instances by the aid and connivance of Thomas C. Fields, now a fugitive from justice, did illegally and corruptly appropriate to his own use large sums of the public moneys.

Under this condition of facts, we cannot do otherwise than advise that action be speedily taken to recover back the amounts thus illegally and fraudulently obtained from the City Treasury.

We regret that this matter has not received earlier attention, as the statute of limitations if pleaded might defeat a portion of the city's claim.

However, as this statute is required to be specially pleaded, to be available as a defense, and as such plea is properly regarded as an admission of the charge, we think that the matter should be pressed to an issue at the earliest possible moment.

We therefore recommend the adoption of the following resolution:

Resolved, That the report of the Commissioners of Accounts, together with the resolution unanimously adopted by your Honorable Body, and the report of this Committee be and they are hereby referred to the Counsel of the Corporation, with instructions to immediately institute proceedings on behalf of the city to recover from Andrew H. Green the moneys illegally converted to his own use, and more particularly set forth in the said report of the Commissioners of Accounts, and that he report the action taken by him at the meeting of this Board next after the approval of this resolution by his Honor the Mayor.

And be it further Resolved, In view of the urgent necessity of prompt action in this matter, that his Honor the Mayor be and he is hereby most respectfully requested to act upon this resolution before the next meeting of this Board.

To the Honorable the Board of Aldermen:

GENTLEMEN—Upon looking over the "Departmental Estimate" of the Comptroller for the year 1877, a copy of which he sent to the Board of Aldermen, under date of September 4, 1876, and which was published in the CITY RECORD of September 15, 1876, we find that after enumerating certain leases to the city he appends a list of three leases which he says are filed in his office, but which he does not recognize as legal and binding upon the city. The annual rent reserved in these leases amounts to \$16,000, and the effect of mentioning them in this way, though probably unintentional, is to convey the impression that there are no other leases so filed which the Comptroller does not recognize, and that therefore \$16,000 will be sufficient to meet all such leases should your Board desire to provide for them. The fact is that there is another lease for five years from May 1, 1875, which has been duly executed by the Comptroller and filed in his office, which he does not recognize and which reserves an annual rent of \$9,500, namely, that from the New York Dispensary. Upon inquiring at the Comptroller's office why the mention of this lease was omitted from the schedule, we were informed that it was because the rent under that lease would be payable out of the appropriation to the Department of Charities and Correction and not out of the general appropriation for rents, because the premises were leased for a hospital; but upon examining the estimate for that Department we find no reference to a provision for that lease at all. We beg, therefore, to call the attention of your Honorable Board to the fact that the sum required in 1877, to pay rent received in leases, which the Comptroller does not recognize as legal (though two of them, those from Mrs. Schanck and the New York Dispensary, were executed by the Comptroller himself, pursuant to the direction of the Court of Appeals), is at least \$25,500, instead of \$16,000. We desire also, in this connection, to call attention to another apparent injustice in the Comptroller's estimate, which is the recognition in his list of valid leases, of one from Mr. Benjamin Wood, of the premises 19 Chatham street. This was one of five leases authorized by the Board of Aldermen, in the spring of 1875, but which the Comptroller refused to execute, and was the fourth upon the list, as appears from the annexed exhibit taken from his sworn answers in the proceedings taken by us, to compel the execution by him of the Schanck and Dispensary leases. He now

recognizes this lease as valid (though we never before knew that it had been executed at all), and refuses to recognize the first, second, third, and fifth ones authorized, though the first and fifth were executed under the express directions of the Court of Appeals, and the fourth, if executed at all, was executed by him, so far as we know, voluntarily.

EXECUTIVE DEPARTMENT—CITY HALL,

To the Honorable the Common Council:

GENTLEMEN—I herewith return to you, without my signature or approval, General Order 297. The Commissioner of Public Works advises me that the work by this ordinance proposed is premature and unnecessary. I do not find that the work has been petitioned for by property-holders

affected, and, as One Hundred and Forty-fifth street has been but recently paved with macadamized pavement, affording a continuous and excellent thoroughfare from river to river, I cannot perceive any reason for approving this ordinance.

As a sample of the many communications which reach me, protesting against such undertakings as this would be, I annex one for your information, which refers to this particular measure.

The undersigned further represents, that he is the owner of the block of ground bounded by One Hundred and Forty-fifth and One Hundred and Forty-sixth streets and Seventh and Eighth avenues.

That One Hundred and Forty-fifth street (100 feet wide) has recently been regulated, graded, curb and gutter set, sidewalks flagged and paved, thus securing a continuous lateral thoroughfare from river to river; and that the improvement of an adjoining lateral street in that location is premature and wholly unnecessary.

The undersigned further states, that assessments have already been levied upon his said lots, for Seventh avenue, St. Nicholas avenue, One Hundred and Forty-fifth street, etc., and that said assessments already amount, in some cases, to more than the present value of his said lots.

The authority hereby given shall continue only until the first day of September next."

And whereas, For divers reasons the work as authorized herein was not commenced until on or about the 15th day of August, so that sufficient time does not remain to complete the said work on the 1st day of September, 1876; therefore

Resolved, That the date for the completion of the work authorized in said resolution, and specified in the last clause thereof, be extended until the 1st of November, inclusive.
