City residents interested in filing their taxes online using the City's new service should visit <u>nyc.gov/OnlineFreeTaxPrep</u> and make sure they have the following information:

- W-2 forms from all employers
  - All 1098 and 1099 forms
- Proof of any other income, e.g. lottery winnings
- Total paid for child care provider and the provider's Taxpayer Identification Number or SSN (if claiming the New York City Child Care Tax Credit)
  - Bank account and routing numbers (if direct depositing a refund)
- Name, address, and phone number of landlord (if claiming the Renter's Credit)

When preparing tax returns online, City residents should type in "NYC" not "New York" when prompted to fill in their locality from Box 20 on the W-2 form.
