

Ordinances, Resolutions, etc., approved by the Mayor during the week ending December 23, 1876.

Resolved, That John C. Hickie be and he is hereby appointed a Commissioner of Deeds in and for the City and County of New York, in place of Henry Goldschmith, whose term of office has expired.

Adopted by the Board of Aldermen, December 7, 1876. Approved by the Mayor, December 20, 1876.

Resolved, That the name of James Francis Roesch, recently appointed as a Commissioner of Deeds, be and is hereby corrected so as to read George Francis Roesch. Adopted by the Board of Aldermen, December 7, 1876. Approved by the Mayor, December 20, 1876.

AN ORDINANCE to amend section 5 of Article IL, and section 1 of Article V. of "Au ordinance to amend chapter XL. of the Revised Ordinances of 1866, relative to Hackney Coaches and Cabs," adopted March 16, 1876.

The Mayor, Aldermen, and Commonalty of the City of New York do ordain as follows : Section 1. Section 5 of Article II. of the above-entitled ordinance is hereby amended and shall read as follows

read as follows: Section 5. Any driver who may be licensed under section 1 of this article may drive and use any coach or cab belonging to his employer; and no owner of any hackney coach or cab shall allow any person to drive such coach or cab who is not licensed as aforesaid, under penalty of five dollars. Sec. 2. Section 1 of Article V. of the above-entitled ordinance is hereby amended by inserting in the 10th and 11th subdivisions thereof, before the word "south" the word "north," so that the subdivisions, when so amended, shall read as follows: (15) and No. 10. North, south, and west vide of Union senses?)

Subivisions, when so antended, such read as only ?:
"Stand No. 10—North, south, and west side of Union square."
"Stand No. 11—North, south, and west side of Madison square."
Also, by adding to said section 1, subdivisions 20 and 21, as follows :
"Stand No. 20—Broadway, opposite St. Paul's Church from 5 P. M. until sunrise."
"Stand No. 21—On all street corners, from 10 P. M. until sunrise."
Sec. 3. All ordinances or parts of ordinances inconsistent or conflicting with the provisions of this ordinance are hereby repealed.
Sec. 4. This ordinance shall take affect immediately.

Resolved, That gas-mains be laid, lamp-posts erected, and street-lamps lighted in One Hundred and Sixth street, from the Second avenue to the East or Harlem river, under the direction of the Com-missioner of Public Works.

Adopted by the Board of Aldermen, December 7, 1876. Approved by the Mayor, December 20, 1876.

Resolved, That the sidewalk in Fifty-eighth street, from the southeast corner of Ninth avenue to house No. 344, be paved with stone flagging pavement, under the direction of the Commissioner of Public Works; and that the accompanying ordinance therefor be adopted.

Adopted by the Board of Aldermen, December 7, 1876. Approved by the Mayor, December 20, 1876.

Resolved, That the Common Council of the City of New York deeply deplore the terrible calamity that has recently visited our sister city, in the almost unprecedented loss of life in the burn-ing of the Brooklyn Theatre, on the night of the 5th instant, and particularly sympathize with the unfortunate families who, on the threshold of what probably will be an inclement winter, have been d prived of those upon whom they had in a great measure depended for their support ; therefore Resolved, That his Honor the Mayor be and is hereby requested to call upon our citizens to con-tribute, by all means in their power, toward alleviating the distress which will surely grow out of this appalling visitation. appalling visitation.

Resolved, That permission be and the same is hereby given to Henry Sherlock to erect a storm-door in front of No. 155 West Forty-first street, the work to be done at his own expense, and to remain only during the pleasure of the Common Council.

Resolved, That permission be and the same is hereby given to the Consumers' Ice Company to remove their scales from the corner of Horatio street and Thirteenth avenue to the Thirteenth avenue entrance to their office, the work to be done at their own expense, under the direction of the Commissioner of Public Works ; such permission to continue only during the pleasure of the Common Commission Council.

Resolved, That permission be and the same is hereby given to Maturin Livingston to place and keep a bridge over the gutter in front of his premises Nos. 2 and 4 East Fifty-third street, the work to be done at his own expense, under the direction of the Commissioner of Public Works; such permission to continue only during the pleasure of the Common Council. Adopted by the Board of Aldermen, December 18, 1876. Approved by the Mayor, December 20, 1876.

Resolved. That permission be and the same is hereby given to Charles H. Tucker to place and keep a watering trough in front of No. 256 Spring street, the work to be done and water supplied at his own expense, under the direction of the Commissioner of Public Works; such permission to continue only during the pleasure of the Common Council.

Adopted by the Board of Aldermen, December 18, 1876, Approved by the Mayor, December 20, 1876.

Resolved, That permission be and the same is hereby granted to the Shiloah Shelter for Destitute Men, corner of Prince and Marion streets, to erect a storm-door in front of their entrance to the building on Prince street, nine by sixty leet, the work to be done at their own expense, and under the direction of the Commissioner of Public Works.

Whereas, It is apparent that the several gas-light companies in this city have entered into a combination or conspiracy, by which the expense of lighting the city lamps will be largely increased over former years, and this, too, in view of the present depression in all descriptions of business, a general shrinkage in all kinds of values, and a great reduction in the proice of coal and all other commodities that enter into the production of illuminating gas ; and Whereas, It is adverse to the public interests to yield to the exactions of these gas companies, who are or should be under the control, absolutely, of the local authorities, in so far, and at least, as the cost of the gas used in lighting the streets, if not in respect to the gas consumed by private individuals ; and, as it is beyond question that the power of the city authorities should be exercised to control these monopolies, or to provide, in the same manner, for furnishing light to our citizens as is now used for supplying water ; be it therefore. Resolved, That the Mayor, Comptroller, and Commissioner of Public Works, who are now authorized to make arrangements with the gas companies of the city for lighting our streets, be and they are hereby respectfully requested to take into consideration the propriety of inaugurating a system for the production and supply of illuminating gas for public and private purposes, similar to that now in use for furnishing our citizens above named be and they are hereby requested to substitute oil, or other illuminating material on the city lamp-posts now erected on the Fifth avenue, from Washing the streets of this city by other means than by the use of illuminating gas, the results of the pro-posed experiment, and the propriety of the manufacture of gas by the city, to be reported to this board, when deemed of public interest to do so.

Adopted by the Board of Aldermen, December 14, 1876. Received from his Honor the Mayor, December 22, 1876, without his approval or objections thereto; therefore, as provided in section 11, chapter 335, Laws of 1873, the same became adopted.

Whereas, The recent terrible calamity which took place in Brooklyn by reason of the burning of the Brooklyn Theatre, in which over three hundred people lost their lives, makes it incumbent upon the authorities of this city to be guarded against a similar fate happening to the people of this city; therefore be it

Resolved, That the Superintendent of Buildings be and he is hereby directed to furnish this Board, at its next regular meeting, with a list of the theatres and other places of amusement in this city which, in his opinion, are not constructed in such a manner as to afford immediate egress from ame in fire.

Resolved, That permission be and is hereby given to all incorporated Gas-light Companies to lay gas-mains and pipes in the streets, avenues, and public places in this city for the purpose of supplying gas to the city and its inhabitants, upon such conditions as may be first prescribed and approved of by his Honor the Mayor, the Comptroller, and the Commissioner of Public Works, who are now by law authorized to make provision for lighting the streets of the city.
