

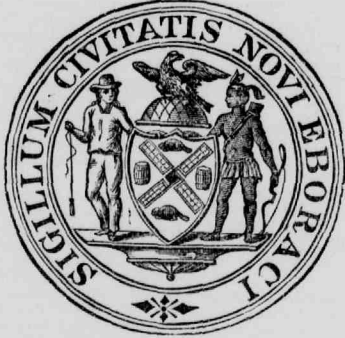

BOARD OF ESTIMATE AND APPORTIONMENT.

BOARD OF ESTIMATE AND APPORTIONMENT—CITY OF NEW YORK,
MAYOR'S OFFICE, CITY HALL,
WEDNESDAY, December 22, 1880—3 o'clock P. M.

The Board met in pursuance of an adjournment.

Present—All the members, viz.:

Edward Cooper, the Mayor of the City of New York; Allan Campbell, the Comptroller of the City of New York; John J. Morris, the President of the Board of Aldermen; Henry E. Howland, the President of the Department of Taxes and Assessments.

Hon. EDWARD COOPER, Mayor, and Chairman of the Board of Estimate and Apportionment of the City of New York:

Resolved, That the Commissioners of Public Parks be requested to submit to the Board of Estimate and Apportionment, in writing, on or before Tuesday, December 28th, the detailed statement or estimate upon which the several items of appropriations included in the Departmental Estimate of the Department of Public Parks for the year 1881 was based, and also a specification in as much detail as practicable, of the amounts required for each of the several objects and purposes included under each head of expenditure stated in the Departmental Estimate, and especially in respect to expenditures required for "Labor, Maintenance, and Supplies," "Harlem River Bridges," "Maintenance Twenty-third and Twenty-fourth Wards," "Bronx River Bridges," "Surveying, Laying Out, and Monumenting Twenty-third and Twenty-fourth Wards," "Maps of the Twenty-third and Twenty-fourth Wards for the use of the Department of Taxes and Assessments," "Walks—Central Park," and "Walks—City Parks," also a statement in writing of the reasons for the several appropriations asked for.

Which was agreed to.

The President of the Board of Aldermen moved that when the Board adjourn, it do so to meet to-morrow (23d), at 1 o'clock, P. M.

LAW DEPARTMENT,

To the Honorable the Board of Estimate and Apportionment:

GENTLEMEN—I respectfully request that the sum of three thousand two hundred dollars (\$3,200), be transferred from the appropriation for "Salaries of Assistants, Clerks, and Messengers, Office of Counsel to the Corporation," for 1880, which is in excess of the amount required for the purposes and objects thereof, to the appropriation for "Contingencies—Office of Counsel to the Corporation," 1880, which is insufficient.

The Board took a recess for half an hour.

Mr. Vincent C. King, President of the Fire Department, appeared and made a statement in relation to the Fire Department.

The Chairman presented the following communication:

DEPARTMENT OF PUBLIC WORKS,
COMMISSIONER'S OFFICE, ROOM 19, CITY HALL,
NEW YORK, December 23, 1880.

Hon. EDWARD COOPER, Mayor and Chairman Board of Estimate and Apportionment:

SIR—At the time when the departmental estimate of the Department of Public Works for 1881 was prepared and submitted to your Board, proceedings were pending in the Supreme Court to determine the question whether the Fulton Market building, which had been condemned as unsafe, should be taken down or repaired. The Court having recently decided and ordered that the building be repaired, I respectfully submit an estimate of the amount required to repair and reconstruct it in such manner as to render it entirely and permanently safe, as required by the order of the Court; to have as little interference as possible with the market business during the progress of the work, and to provide the most suitable and convenient accommodations for such business on the completion of the work.

The present market is in two distinct portions—the old market proper, two stories high, facing on Fulton, Front, and Beekman streets—and the inner and more recent portion, on a different level, facing on South street. The older portion is in much more need of repair than the latter.

It is proposed to rebuild the walls of the older portion in sections, the standholders to be removed in turns to a temporary shed to be erected in Burling slip; the floor to be on a level with the present floor of the inner portion; the building to be one story high, except on the corners and in the centre of the part facing on Front street, where a second story is to be added for offices, closets, and wash-rooms; the walls to be of such design as to afford complete light and ventilation, and of sufficient strength to carry upper stories, if desired to be added in the future, or an iron and glass roof over the central portion; the roof to be of such construction as to insure a more equable temperature than at present; the present roof over the central part, which was recently repaired, to be retained; a suitable drain to be laid under the floor in place of the present surface drainage; an iron shed on brackets to be built around the market over the sidewalks in place of the present sheds; the exterior to be without unnecessary ornamentation, but of a dignified and attractive design; the whole improvement to be of a permanent character, and to include necessary repairs to the inner market. This plan abolishes the cellar shops on Fulton, Front, and Beekman streets. The expense is estimated at \$100,000.

I therefore respectfully ask that this amount be included in the final estimate for 1881, and set apart for this purpose for the use of this Department. I transmit herewith a plan of the improvement, and will be glad to furnish further details in reference thereto, if desired.

Where more than one person is interested, it is requisite that the verification be made and subscribed by all the parties interested.

Each bid or estimate shall be accompanied by the consent, in writing, of two householders or freeholders in the City of New York, with their respective places of business or residence, to the effect that if the contract be awarded to the person making the estimate, they will, on its being so awarded, become bound as sureties for its faithful performance; and that if he shall omit or refuse to execute the same, they will pay to the Corporation any difference between the sum to which he would be entitled on its completion, and that which the Corporation may be obliged to pay to the person or persons to whom the contract may be awarded at any subsequent letting; the amount in each case to be calculated upon the estimated amount of the work by which the bids are tested. CHAPTER 123.

AN ACT in relation to arrears of taxes in the City of New York, and to provide for the reissuing of revenue bonds in anticipation of such taxes.

Passed April 15, 1880; three-fifths being present. The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. At any time after the passage of this act, and before the first day of October, eighteen hundred and eighty, any person may pay to the Comptroller of the City of New York the amount of any tax upon real property belonging to such person, heretofore laid or imposed and now remaining unpaid, together with interest thereon at the rate of seven per centum per annum, to be calculated from the time that such tax was imposed to the time of such payment, provided, also, that the time when such payment may be made on the amount of any such tax laid or imposed in the years eighteen hundred and seventy-seven, eighteen hundred and seventy-eight, and eighteen hundred and seventy-nine shall extend to the first day of April, eighteen hundred and eighty-one. The comptroller shall make and deliver to the person making any such payment a receipt therefor, and shall forthwith cancel the record of any such tax on the books of the finance department; and upon such payment being made such tax shall cease to be a lien upon the property and there shall be deemed fully paid, satisfied and discharged, and there shall be no right to any further interest or penalty by reason of such tax not having been paid within the time heretofore required by law, or by reason of any statute passed requiring the payment heretofore of any penalty or interest over seven per centum per annum upon any unpaid tax.

Sec. 2. Any revenue bond heretofore issued in anticipation of the taxes in the first section specified which may fall due and become payable before said taxes are collected, may be reissued by the comptroller of said city, in whole or in part, for such period as he may determine, not exceeding one year.

Sec. 3. This act shall take effect immediately.
