

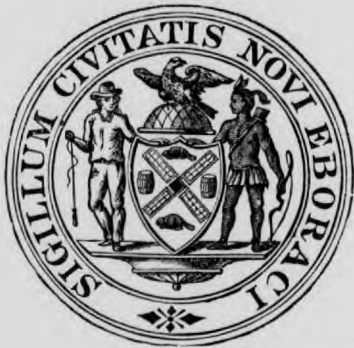

APPROVED PAPERS.

Ordinances and Resolutions passed by the Common Council during the week ending Nov. 13, 1886.

Resolved, That permission be and the same is hereby given to Keller Brothers to place and keep an ornamental lamp-post and lamp on the sidewalk near the curb in front of No. 70 Avenue A, provided such post shall not exceed the dimensions prescribed by law (eighteen inches square at the base), and that the work be done and gas supplied at his own expense, under the direction of the Commissioner of Public Works; such permission to continue only during the pleasure of the Common Council.

Adopted by the Board of Aldermen, October 27, 1886.
Approved by the Mayor, November 9, 1886.

Resolved, That the resolution and ordinance to regulate and grade One Hundred and Forty-first street, from the Boulevard to a point three hundred and twenty-five feet west of the Boulevard, which was approved by the Mayor, September 25, 1886, be and the same is hereby annulled, rescinded and repealed.

Adopted by the Board of Aldermen, October 27, 1886.

Resolved, That permission is hereby given to James Morgan to pave with stone blocks the sidewalks in front of Nos. 309 and 311 Front street, at his own expense and under the direction of the Commissioner of Public Works.

Resolved, That a crosswalk of two courses of blue stone be laid across Second avenue, south side of Fifteenth street, under the direction of the Commissioner of Public Works, the expense to be paid from the appropriation for "Repairs and Renewals of Pavements and Grading."

Adopted by the Board of Aldermen, October 27, 1886.
Approved by the Mayor, November 9, 1886.

Resolved, That the carriageway of Eighty-fourth street, from the curb-line on the east side of Avenue A to the curb-line on the west side of Avenue B, be paved with Belgian or trap-block pavement, except that at or near the intersections of said avenues with said street and within the lines of the sidewalks thereof, on the east side of Avenue A and the west side of Avenue B, crosswalks of three courses of blue stone be laid across said street, under the direction of the Commissioner of Public Works; and that the accompanying ordinance therefor be adopted.

Approved by the Mayor, November 9, 1886.

Resolved, That gas mains be laid, lamp-posts erected and street-lamps placed thereon and lighted, in One Hundred and Fifth street, from Fourth to Fifth avenue, under the direction of the Commissioner of Public Works.

Resolved, That a crosswalk of two courses of blue stone be laid across First avenue, at or near the northerly, and another like crosswalk at or near the southerly intersection of One Hundred and Fifteenth street, and within the lines of the sidewalks of said street, under the direction of the Commissioner of Public Works, the expense to be paid from the appropriation for "Boulevards, Roads and Avenues, Maintenance of."

AQUEDUCT COMMISSION.

Minutes of Stated Meeting of the Aqueduct Commissioners, held at their office, No. 209 Stewart Building, on Wednesday, November 3, 1886, at 3 o'clock P. M.

Present—Commissioners Spencer, Dowd, the Commissioner of Public Works, Commissioners Baldwin, Barnes, Ridgway and Fish.

Also, Chief Engineer Church and Consulting Engineer Fieley; and Chief Engineer Birdsall of the Department of Public Works.

The minutes of the meeting of October 27 were read and approved.

The Committee of Finance and Audit reported their examination and audit of bills contained in Vouchers Nos. 2108 to 2134, inclusive, amounting to \$4,088.72; and, on motion of Commissioner Dowd, the same were approved and ordered certified to the Comptroller for payment.

The Committee on Construction recommended the adoption of the following resolution:

Resolved, That the President, the Chairman of the Committee on Construction and the Chief Engineer, or either of them, are hereby authorized to issue permits to visit and inspect the work on the New Aqueduct, or any part thereof, to persons requesting the same, whose applications are approved by them or either of them.

On motion of Commissioner Ridgway, the same was adopted.

The Committee on Real Estate presented the following report:

The Committee on Real Estate make the following report and recommendation concerning the additional lands to be obtained at the Pocantico Open Cut No. 8, and at the Ravensdale road for Shaft No. 15½.

At the Pocantico Cut there are six additional parcels of land to be acquired. These lands belong to four different owners, all of whom have been conferred with, and it is apparent that no agreement with them, as to compensation, can be reached which this Committee could recommend, or the Board of Estimate and Apportionment would approve. There are also other obstacles in the shape of mortgages, tenancies, etc., which complicate matters and militate against an adjustment by agreement.

There is the same difficulty in coming to an agreement with the owners of the lands for Shaft No. 15½.

We therefore recommend that proceedings to condemn the property be immediately taken, and that the initiatory public hearing in the matter be given at as early day as possible.

From the conferences with the owners and their attorneys, this Committee has reason to believe that these new proceedings being once under way, all the parties will then consent to an immediate amendment of former proceedings and thus shorten the time of obtaining possession of the lands by at least one month. We recommend the adoption of the following resolution:

Resolved, That public hearing be given to all persons interested in the additional lands to be acquired in fee at Shaft Site No. 8, and for the additional Shaft No. 15½, as the same are shown upon the plans now before this Commission; that said hearing be given at this office on Wednesday, November 10, 1886, at 2 o'clock P. M.; and the Secretary is hereby directed to give notice thereof by publication in the CITY RECORD. Adopted.

The Secretary submitted a communication with reference to the agreement to be executed by the Aqueduct Commissioners and the firm of Coldwell, Wilcox & Co., for the iron work, etc., for the blow-offs and waste weirs at Pocantico, Saw Mill river, and Tibbett's brook; and in connection therewith presented the following resolution:

Resolved, That the President of this Commission be and he is hereby authorized to execute an agreement on behalf of the Aqueduct Commissioners with the firm of Coldwell, Wilcox & Co., for furnishing the iron work, and the labor and material necessary for putting the same in place for the blow-offs and waste weirs at Pocantico, Saw Mill river and Tibbett's brook at the prices named in their bid, and heretofore accepted by this Commission.

Commissioner Barnes moved the adoption of the resolution. Adopted.
 Commissioner Fish offered the following resolution:
 Resolved, That the authority given to the Chief Engineer and Secretary of this Commission on the 23d of June last to grant to the employees of their respective Departments half-holidays on Saturdays, be and the same is hereby rescinded. Adopted.
 Commissioner Barnes moved that the leave of absence granted to Thomas Franklin, Assistant Engineer, on the 19th of October by the Chief Engineer, be approved of; and that such leave of absence be extended indefinitely. Carried.
 On motion of Commissioner Fish, the Committee on Construction was requested to report on or before the 1st of December next, in regard to the Quaker Bridge and Muscote Dams.
 Commissioner Dowd moved that the President of the Commission, the Chairman of the Committee on Construction, and Commissioner Ridgway be appointed a Committee to confer with the Civil Service Supervisory and Examining Board with regard to the rules and regulations to be established for the examination of persons applying for positions under the Aqueduct Commission; and that they be authorized to invite such persons as they may desire to accompany them.
 Commissioner Baldwin moved as an amendment that the Committee consist of the President of the Commission and the Chairman of the Committee on Construction. Carried.
 The Commissioners then adjourned.

NUMEROUS APPLICATIONS HAVE BEEN made to this Department by citizens claiming reduction or rebates on bills for water supplied through meters, on the alleged ground of leakage caused by defective plumbing and worn-out service pipes, or by willful waste of water by tenants allowing the faucets to be turned on in full force in water-closets, sinks, etc., without the knowledge or consent of the owners of the premises.

The main object of the use of water-meters is to enable this Department to detect and check the useless and unwarrantable waste of an element so valuable and essential to the health and comfort of all the citizens, and this object can only be accomplished by enforcing payment for the water wasted.

Under the law all charges for water supplied through meters are a lien against the respective premises, and the law therefore holds the owner of the premises responsible for the amount of water used or wasted.

Notice is therefore given to all householders that, in all further applications for reduction of water rents, no allowance will be made on account of waste of water occurring through leaks, from defective service pipes or plumbing, or wasteful use of water by tenants or occupants of buildings, though such leakage or waste may have occurred without the knowledge or consent of the owners of the buildings.

House-owners are further notified that whenever their premises become vacant, and are likely to remain vacant, they must notify this Department in writing, and that unless this requirement is complied with no deductions in extra water rents will be allowed for any portion of one year.
