The Commission also gives its approval with the understanding that the Parks Department will (1) use high-friction coefficient recycled plastic lumber (RPL) with a 10' concrete carriage lane on Riegelmann Boardwalk moving forward, noting the importance of a consistent aesthetic treatment; and (2) if the slip resistance proves effective for non-vehicular uses, test the RPL for vehicular use with the goal of eliminating the concrete carriage lane altogether.

The Commission also encourages the Parks Department to continue to work with RPL manufacturers to improve/test slip resistance as well as explore other sustainable materials for boardwalks, as they are developed.
