



Feasibility of Allowing Online Submission of Applications for City-Issued Permits, Licenses, and Registrations

Pursuant to Local Law 61 of 2017

Mayor's Office of Operations

Department of Information Technology & Telecommunication

June 1, 2018

Legislation Background

Local Law 61 of 2017 requires a review of the feasibility of allowing online submission of applications for all permits, licenses, and registrations issued by City agencies. The review also requires an evaluation of the feasibility of creating and maintaining a single web portal to access such applications and a plan and timeline for creating such web portal.

The Mayor's Office of Operations (Operations), in collaboration with the Department of Information Technology & Telecommunication (DoITT), has undertaken this review as outlined above, the findings of which are included in the following report.

Census of all City-Issued Permits, Licenses, and Registrations

Operations worked with 104 New York City mayoral agencies and offices to develop a comprehensive list of all permits, licenses, and registrations issued by the City, and to determine which of these may currently be applied for online and which may not.

Twenty-one agencies and offices confirmed that they issue a total of 562 permits, licenses, or registrations. Of these, 233 can currently be applied for online. A further 281 cannot currently be applied for online, but the issuing agency has plans to allow online submission within the next one to five years, which Operations deemed a suitable timeline to reflect ongoing agency work in this area. The remaining 48 cannot currently be applied for online, and the issuing agency has no plans to allow online submission. A full list of all permits, licenses, and registrations and information about whether they can be applied for online can be found in Appendix A.

Appendix B lists the plan and timeline provided by agencies for those 281 permits, licenses, and registrations that cannot currently be applied for online but the issuing agency has plans to allow online submission within the next one to five years. The vast majority of these are planned to launch in the next three years or earlier and many of these online applications represent a small portion of a much larger system redesign effort that is currently underway. For example, roughly 80% of these credentials are issued by the Department of Buildings or the Fire Department, both of which are undertaking comprehensive, multi-phase projects to fully replace their legacy Information Technology (IT) systems.

Feasibility of Allowing Online Submission of Applications

In conjunction with DoITT, Operations engaged the relevant agencies to evaluate the operational and technical feasibility of allowing online submission of applications for the 48 permits, licenses, and registrations where issuing agencies currently have no plans to do so. This review concluded that there were no technical barriers to allowing online applications for these credentials, but there are

¹ For the purposes of this study, "online submission" is defined as a process by which an applicant enters data in an online web form and/or submits an electronic version of an application form via e-mail. This does not guarantee that an application will be approved online or that the applicant will be notified online of such an approval. Many applications require the submission of additional documents via mail or in-person, an in-person interview or exam, or additional background checks before final approval.

operational barriers to doing so. These operational barriers are outlined in seven broad categories below, and more detail is included in Appendix C.

- 1. The number of licensees/permit holders is limited by law. For example, the Department of Health and Mental Hygiene can issue a finite number of Mobile Food Vending Permits. DOHMH is not currently accepting new applicants for this permit type, but instead will contact applicants from an existing waitlist.
- 2. The documents accompanying an application must be inspected in person, and/or an application must be submitted in-person for security reasons. For example, the process for issuing a new medallion license requires that the applicant meet with the Taxi and Limousine Commission, in order to ensure the legal transfer of medallion ownership from seller to buyer.
- 3. Agencies reach out to applicants directly to initiate the application process, having received applicant information from a state agency or other type of permitting body. For example, to apply for the Department of Sanitation's (DSNY) Private Transfer Station Permits, applicants must first be permitted by the New York State Department of Environmental Conservation (NYSDEC.) NYSDEC then contacts DSNY with a list of permitted stations, and DSNY reaches out directly to applicants to ensure they fulfill additional DSNY requirements.

Operations and DoITT have concluded that there is no benefit to allowing online application submission for permits, licenses, and registrations in the above categories – which applies to a total of 14 permits, licenses, and registrations.

- 4. The volume of applications is too low to warrant a change in the current process. For example, the Department of Parks and Recreation offers two permits, the Lawn Bowling Permit and Croquet Permit, which each receive around 75 applications per year.
- 5. The issuing agency's IT staff does not have the capacity to build new application workflows.
- 6. The application requires information from another agency for approval. For example, the Mayor's Office for People with Disabilities (MOPD) offers applications for Accessibility Waivers. In order to approve waiver applications, MOPD must coordinate with the Department of Buildings (DOB) and the Department of Transportation (DOT) to review construction plan sets and scopes of work submitted to DOB and DOT, respectively.
- 7. The issuing agency doesn't have the technical capability to receive documents, technical drawings or similar that accompany an application. For example, applications for the Department of Environmental Protection's Groundwater Discharge Approval Permits require laboratory analytical results, diagrams, and/or engineering plans that must be signed and stamped by an engineer.

Operations and DoITT believe it is feasible to allow online application submission for the 34 permits, licenses, and registrations that fall into these last four categories. To accomplish this, DoITT will partner with relevant agencies to confirm this assessment for each individual system. Should electronic capture be operationally feasible, DoITT will assist in identifying a solution for implementing that capture, and where necessary, work with the agency to identify resources for implementation.

DoITT will begin this assessment in August 2018, with the expectation that the assessment phase will be completed by January 2019. Depending on the results of the initial assessment, the solutions surfaced, and the timeliness of execution by the agencies, the electronic capture should be completed within 24 months.

Existing City-Managed Application Web Portals

Operations and DoITT compiled a list of web portals and web forms used to accept online applications, as well as a technical description of the technology supporting these portals. This list can be found in Appendix D.

Feasibility of Single Web Portal

In consultation with DoITT, Operations has determined that maintaining a single online application portal for the City is feasible. The infrastructure for such a portal already exists within 311 Online. Operations, DoITT and 311 have begun conversations to ensure that all City-issued permits, licenses, and registrations are accessible via 311 Online.

311 is the source for all public-facing information as it relates to the City, which makes it the logical home for a single entry point for all users looking for information about City-issued permits, licenses, and registrations. Currently 311 Online is transitioning to a new customer relationship management (CRM) platform. This new CRM platform will improve user experience and allow 311 to be more responsive to its customer base.

As part of that upgrade, Operations and DoITT will work with 311 to introduce a landing page on 311 Online that contains application information about all City-issued permits, licenses, and registrations, as well as links to access the online application for each credential, where possible. Operations will also work with 311 to ensure that accurate information is available to users about each credential type via search on 311 Online. This work could serve as a complement to the NYC Business Portal managed by the Department of Small Business Services, which provides application information and links to all business-related permits, licenses, and registrations issued by the City.

This approach is comparable to that taken by other city governments. In 2017 Denver won first place in the Center for Digital Government's (CDG) Government Experience Awards. Its online applications portal consists of a webpage listing links to all applications and payments the city offers. These links lead users to pages hosted by specific agencies, where users can access and submit information for the relevant application.

San Diego, second place winner in the City Portal Category in CDG's Best of the Web 2016 Awards, takes a similar approach to the concept of a single web portal. Users are first directed to a webpage with dropdown menus, where they can enter information about what they are trying to do (e.g. - Apply for a Fishing License.) From there they are directed to the relevant application, hosted on the licensing agency's website.

Given the existing online infrastructure and application processing workflows within each agency, and the practices of similar cities, leveraging 311 Online as the City's single web portal is the optimal solution. It allows agencies to maintain their current online application portals and workflows, saving time and money on re-building existing portals and re-training staff. At the same time, users of the website will still benefit from a more unified experience with the creation of a single "front door" through 311 Online.

Operations and DoITT are committed to working with 311 Online to ensure that it can serve as single web portals for all users. 311 has estimated that they will be able to begin setting up a single content page with information for all applications in early 2019. Operations, DoITT, and 311 will also work together to establish a process to regularly update all application information on 311 Online to ensure that it remains accurate moving forward.
