

WEEKLY INCIDENT BRIEF - COVID-19

06/01/2020 – 06/08/20

Purpose of Weekly Incident Brief This Weekly Incident Brief provides resources for businesses seeking economic relief, information for workplaces, and guidance for donating services or supplies. In comparison, the Daily Brief provides more detailed information about the evolving COVID-19 situation, including travel and transit impacts and the number of COVID-19 cases in the City by borough.

Incident Summary

NYC Emergency Management continues to coordinate with our partners at the City, State, and Federal levels as well as the private sector in response to COVID-19. As of May 26, 2020, there are 192,845 COVID-19 positive cases in New York City. Additionally:

- Governor Cuomo announced all NYS on Pause restrictions and closures will be extended until May 28th.
- All non-essential gatherings of individuals of any size for any reason are temporarily banned.
- Per [CDC guidance](#), employers should not require a positive COVID-19 test result or a healthcare provider's note for employees who are sick to validate their illness, qualify for sick leave, or to return to work.
- Governor Cuomo [released a guide](#) to the state's "NY Forward Reopening" Plan, along with the state's [regional monitoring dashboard](#).
- In accordance with the New York State Executive Order, every New Yorker must stay at home from work, unless they are an essential worker. More information regarding the New York State Executive Orders can be found [here](#).
- In coordination with neighboring states, public and private beaches will open with certain restrictions on May 22, ahead of Memorial Day weekend.

There are no specific vaccines or treatments available for this novel coronavirus, or any other coronavirus. However, medication and vaccine research continues.

Test and Trace: Mayor de Blasio Builds Out Tracing and Isolation Operation

- With the goal of testing 20,000 New Yorkers per day citywide by May 25th, the City will open 12 new NYC Health + Hospitals COVID-19 testing sites. Two of these sites, in Washington Heights and Midwood respectively, will open the week of May 18th. The remaining 10 sites in the following neighborhoods will open by May 25th.
