## COMMISSIONERS OF THE SINKING FUND.

Abstract of the Proceedings of the Commissioners of the Sinking Fund, at the meeting held April 27, 1881:

Present—Hon. William R. Grace, Mayor (Chairman); Hon. Frederick Smyth, Recorder; Hon. Allan Campbell, Comptroller; J. Nelson Tappan, Esq., Chamberlain, and Joseph J. McAvoy, Esq., Chairman Finance Committee Board of Aldermen.

The minutes of the last meeting were read and approved.

The Comptroller submitted the following resolution, which, on motion, was adopted, viz.:

Resolved. That the Comptroller, in accordance with subdivision II of section 6 of the act, chapter 574, of the Laws of 1871, be and hereby is directed to prepare and issue from time to time, as he may deem necessary to the requirements of the Dock Department, one hundred and fifty thousand dollars (\$150,000) Dock Bonds of the City of New York, for the purpose of raising moneys necessary to carry out the provisions of said act relating to the Department of Docks, its powers and duties, the said amount being the balance of the requisition of the Department of Docks, dated March 16, 1881, for two hundred and fifty thousand dollars (\$250,000).

The Comptroller submitted the following reports, viz.:

CITY OF NEW YORK—FINANCE DEPARTMENT, COMPTROLLER'S OFFICE, April 27, 1881.

To the Commissioners of the Sinking Fund:

Gentlemen—Herewith I submit an application of S. V. R. Cruger, Colonel commanding the Twelfth Regiment, N. G., S. N. Y., and of Lorenzo T. Baker, Captain commanding the Battery "E," N. G., S. N. Y., for armories to be used by the companies of said regiment and battery, both duly certified by Adjutant-General Townsend, as prescribed and required by the Military Code of

The leases of the premises now occupied by said regiment and battery expire on May 1, 1881.

Battery "E" was formerly an organization known as the "Washington Gray Troop," whis now equipped with a battery of gatling guns, requiring more extensive accommodation.

Twelfth Regiment also requires additional room for its accommodation.

I have endeavored to make an agreement with the owner for a new lease of the premises at a rent which I consider fair and reasonable, taking the additional room required into consideration, but he asks more than I feel justified in approving.

The premises occupied by the Twelfth Regiment and Battery "E" are portions of the building on the east side of Broadway, between Forty-fourth and Forty-fifth streets, in addition to which other portions of the same building are required to be leased.

The owners ask \$18,000 rent per annum, and I consider the sum of \$16,000 as fair and reasonable, and submit a resolution authorizing the preparation and execution of a lease of said premises to be used as an armory by said regiment and battery for the term of one year, from May 1, 1881, at

GENTLEMEN—In conformity with a resolution of the Commissioners of the Sinking Fund, adopted on the 13th day of April, 1881, approving and confirming the terms and conditions of settlement of suits of the Mayor, Aldermen, and Commonalty of the City of New York against the Union Ferry Company, agreed upon between the Committee appointed by the Commissioners of the Sinking Fund on the 6th instant, and a Committee of the Board of Directors of said company, such terms of settlement have been signed by the President thereof. The Counsel to the Corporation will immediately discontinue said suits and the Ferry Company pay into the Treasury the sum agreed upon in the settlement, to be in full of all claims for and against each of the parties by reason of a lease of certain ferries by the Mayor, Aldermen, pany, which expires on May 1, 1881.

The franchise of the ferries operated by the Union Ferry Company, together with the lease of the wharf property belonging to the city used for the purposes of said ferries, was sold by the Comptroller on April 21st, at public auction, to the highest bidder for the term of five years from the first day of May, 1881, as authorized and directed by resolutions of the Commissioners of the Sinking Fund, adopted April 6th and 13th, subject to the terms and conditions of sale therein approved and provided for

The highest bidder or purchaser was the Union Ferry Company, at the upset or minimum price of twelve and one-half per cent. upon the gross receipts from ferriage at said ferries during the term of the lease, payable quarter yearly.

On the same date, the franchise of a ferry across the Harlem river, from a point near the intersection of Second avenue and One Hundred and Twenty-ninth street, to a point on the opposite shore, at or near the New York, New Haven and Hartford Railroad Depot, was sold by the Comptroller at public auction to the highest bidder, as authorized and directed by a resolution of the Commissioners of the Sinking Fund, adopted April 13, for the term of five years from the first day of May, 1881, subject to the terms and conditions therein approved and provided for.

The highest bidder or purchaser of said franchise was William H. Morrell, at the upset or minimum price of five per cent. upon the gross proceeds of ferriage at said ferry during the term of the lease, payable quarterly.

Section: If any taxes of any year shall remain unpaid on the first day of November, after the assessment-rolls and the warrants to collect such taxes have been delivered to the Receiver of Taxes in the City of New York, it shall be the duty of said Receiver to give public notice, by advertisement for at least ten days in two of the daily newspapers, and in the City Record, printed and published in said city, respectively, that unless the same shall be paid to him at his office on or before the first day of December, in any such year, he will immediately thereafter proceed to collect such unpaid taxes, as provided in the following section of this act:

Section 2. If any such tax shall remain unpaid on the said first day of December, it shall be the duty of the said Receiver of Taxes in said city to charge, receive, and collect upon such tax so remaining unpaid on that day, in addition to the amount thereof; and to charge, receive, and collect upon such tax so remaining unpaid on the first day of January thereafter, interest upon the amount thereof at the rate of seven per centum per annum, to be calculated from the day on which said assessment-rolls and warrants shall have been delivered to the said Receiver of Taxes to the date of payment. date of payment.

The same rate of interest shall be so charged and collected upon any tax levied in the year eighteen hundred and eighty, remaining unpaid at the date of the passage of this act.

and eighty, remaining unpaid at the date of the passage of this act.

Section 3. All existing provisions of law which impose a charge and require the collection of interest at the rate of twelve per centum per annum upon arrears of taxes on real and personal estate within the City of New York, upon arrears of assessments for local improvements and street openings in said city, and upon arrears of Croton water rents in said city, are hereby repealed; and in lieu of such charge of interest at the rate of twelve per centum per annum, there shall be charged and collected by the officer authorized to collect and receive any such arrears of taxes and assessments and Croton water rents, interest upon the amount thereof at the rate of seven per centum per annum, to be calculated for the same period as interest at the rate of twelve per centum per annum is now required by law to be calculated thereon. This provision shall apply to taxes, assessments, or Croton water rents remaining unpaide and due, for the non-payment of which the lands and tenements liable therefor shall be hereatter sold at public auction as now provided by law; provided, however, that nothing in this act shall be construed to affect the rights of purchasers at sales for taxes, assessments, or Croton water rents, heretofore made, or to authorize the redemption of lands and tenements from sales heretofore made for any lesser sums than the sums collectible for such redemption under the provisions of existing laws.

Section 4.
