

REPORTED MORTALITY * for the week ending February 26, 1887, together with the ACTUAL MORTALITY for the week ending February 19, 1887.

W. De F. Day, M. D., Sanitary Superintendent and Register:

Sir—There were 679 deaths reported to have occurred in this city during the week ending Saturday, February 26, 1887, which is a decrease of 63, as compared with the number reported the preceding week, and 18 less than were reported during the corresponding week of the year 1886. The actual mortality for the week ending February 19, 1887, was 758, which is 45.8 above the average for the corresponding week for the past five years, and represents an annual death-rate of 26.88 per 1,000 persons living, the population estimated at 1,466,398.

Fourth.—That our report herein will be presented to the Supreme Court of the State of New York, at a Special Term thereof, to be held at the chambers thereof, in the County Court-house, at the City Hall, in the City of New York, on the eighteenth day of March, 1887, at the opening of the Court on that day, and that then and there, or as soon thereafter as counsel can be heard thereon, a motion will be made that the said report be confirmed.
