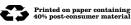

Statutory Authority

This rule is promulgated pursuant to sections 389(b) and 1043(a) of the New York City Charter. Section 389(b) provides that "heads of mayoral agencies shall have the power to adopt rules to carry out the powers and duties delegated to the agency head or the agency by or pursuant to federal, state or local law." Section 1043(a) similarly provides that each "agency is empowered to adopt rules necessary to carry out the powers and duties delegated to it by or pursuant to federal, state or local law." Local Law 69 of 2009 (L.L. 69), which amended the New York City Administrative Code to restrict the sale of flavored tobacco products, delegates to the Department of Health and Mental Hygiene ("the department") the authority to promulgate regulations necessary for the purposes of carrying out its provisions.

Statement of Basis and Purpose

L.L. 69 amended Title 17 of the Administrative Code, adding §§17-713 – 17-718 (regulating the sale of flavored tobacco products). Section 17-715 makes it illegal for any person to sell or offer for sale any flavored tobacco product except in a tobacco bar. Section 17-713(e) defines flavored tobacco products to mean "any tobacco product or component part thereof that contains a constituent that imparts a characterizing flavor" and further provides that a "public statement or claim made or disseminated by the manufacturer of a tobacco product, or by any person authorized or permitted by the manufacturer to make or disseminate public statements concerning such tobacco product, that such tobacco product has or produces a

characterizing flavor shall constitute presumptive evidence that the tobacco product is a flavored tobacco product." L.L. 69 provides that the department and the Department of Consumer Affairs shall enforce the provisions of §§17-713 – 17-718, and authorizes the agencies to promulgate regulations as may be necessary for purposes of carrying out the provisions of the law.

These rules define the scope and applicability of the law and provide guidance for sellers of tobacco products about how to determine whether a tobacco product is flavored and therefore subject to restricted sale. Section 28-03 of the rule provides that a tobacco product will be presumed to be flavored if its label, labeling, or packaging includes a statement or claim that such product has or produces a taste or aroma relating to any fruit, chocolate, vanilla, honey, candy, cocoa, dessert, alcoholic beverage, herb or spice. Section 28-04 sets forth the procedure by which the department will establish a Restricted Flavored Tobacco Product List comprised of flavored tobacco products that are subject to restricted sale, notwithstanding the fact that their label, labeling and/or packaging do not include statements that the products are flavored.

In order to facilitate enforcement of the law, section 28-06 requires the on-site maintenance of the original labels, labeling and packaging of all tobacco products, and nontobacco products that are consumed through the inhalation of smoke, that are sold or offered for sale by the establishment outside of the original packaging provided by the manufacturer.

§28-01 Definitions and construction of words and

- (a) Act. "Act" shall mean the Regulation of the Sale of Herbal Cigarettes and Flavored Tobacco Products, as provided in Chapter 7, Title 17 of the New York City Administrative Code ("the Administrative Code"), as amended by Local Law 69 of 2009.
- (b) Aroma. "Aroma" shall mean a quality that can be perceived by the sense of smell.
- (c) Characterizing Flavor. "Characterizing Flavor" shall have the meaning set forth in §17-713(b) of the Act.
- (d) Commissioner. "Commissioner" shall mean the Commissioner of the New York City Department of Health and Mental Hygiene.
- (e) Department. "Department" shall mean the New York City Department of Health and Mental Hygiene.
- (f) Department of Consumer Affairs. "Department of Department of Consumer Affairs.
- (g) Distinguishable. "Distinguishable" shall mean detectable by either the sense of smell or taste.
- (h) Flavored tobacco product. "Flavored tobacco product" shall have the meaning set forth in §17-713(e) of the Act and shall include dual or multiple flavored products unless they impart only the taste or aroma of menthol, mint or wintergreen.
- (i) Label. "Label" shall mean a display of written, printed, or graphic matter upon the immediate container of any tobacco
- (j) <u>Labeling</u>. "Labeling" shall mean all labels and other written, printed, or graphic matter upon any tobacco product or any of its packaging, or accompanying such tobacco
- (k) Manufacturer. "Manufacturer" shall mean any person, including any repacker or relabeler, who manufactures, fabricates, assembles, processes, or labels a tobacco product; or imports a finished tobacco product for sale or distribution into the United States.
- (l) Packaging. "Packaging" shall mean a pack, box, carton, or container of any kind or, if no other container, any wrapping (including cellophane) in which a product is offered for sale,

- sold, or otherwise distributed to consumers.
- (m) Rules. "Rules" shall mean Chapter 28 of Title 24 of the Rules of the City of New York.
- (n) Tobacco bar. "Tobacco bar" shall have the meaning set forth in subdivision jj of section 17-502 of the Administrative
- (o) Tobacco products. "Tobacco product" shall have the meaning set forth in §17-713(j) of the Act. Tobacco products shall include, but not be limited to: cigars, pipe tobacco, smokeless tobacco, dissolvable tobacco, snuff, shisha, blunts, and blunt wraps. For purposes of this chapter, tobacco products shall not include cigarettes.

$\S 28-02$ Sale or offer for sale of flavored tobacco products restricted.

- (a) Flavored tobacco products shall only be sold or offered for sale to or in a tobacco bar.
- (b) Tobacco products that impart a distinguishable taste or aroma of menthol, mint or wintergreen, and do not also impart a characterizing flavor, are not subject to the restriction on sale set forth in section 17-715 of the Administrative Code or these rules, and may lawfully be sold by any retail dealer or wholesale dealer licensed to sell $\underline{tobacco\ products,\ regardless\ of\ whether\ such\ sale\ occurs\ to\ or}$ in a tobacco bar.

§28-03 Presumptively flavored tobacco products.

- (a) A tobacco product is presumed to be flavored if its manufacturer, or any person authorized or permitted by its manufacturer to make or disseminate public statements or claims concerning such tobacco product, has made a statement or claim on the tobacco product's label, labeling or packaging that such tobacco product has or produces a characterizing flavor.
- (b) As used in §17-713(e) of the Act and these rules, a "public statement or claim" includes text and/or images used to communicate information about the flavor, taste or aroma of a tobacco product.
- (c) Any tobacco product for which the label, labeling, or packaging of such product includes a public statement or claim that such product has or produces a taste or aroma relating to any fruit, chocolate, vanilla, honey, candy, cocoa, dessert, alcoholic beverage, herb or spice, or any other flavor other than menthol, mint or wintergreen, shall be presumed to be a flavored tobacco product subject to the restrictions on sale set forth in §17-715 of the Act.

§28-04 Restricted Flavored Tobacco Product List.

- (a) A tobacco product that is not presumed to be flavored because of a statement or claim on its product label, labeling or packaging may nevertheless be a flavored tobacco product if it has or imparts a characterizing flavor. The Department shall establish a list of such tobacco products, entitled the "Restricted Flavored Tobacco Product List," set forth in Appendix A to these rules. Products on the Restricted Flavored Tobacco Product List shall only be sold or offered for <u>sale to a tobacco bar or in a tobacco bar.</u>
- (b) The Department shall develop the Restricted Flavored <u>Tobacco Product List as follows:</u>
- $(1) \quad \underline{\text{If the Department determines that a tobacco}}$ product has or imparts a characterizing flavor, it shall in writing notify the tobacco product's manufacturer of such determination and of its intent to include the product on the Restricted Flavored Tobacco Product List. The Department's notification shall state the basis for its determination that such tobacco product has or produces a characterizing flavor.
- (2) A manufacturer may within thirty (30) days of service of the notification described in §28-04(b)(1) of these rules object to the inclusion of its product on the Restricted Flavored Tobacco Product List. An objection shall be in writing, and shall include all information and evidence a manufacturer deems relevant to a determination of whether the tobacco product has or imparts a characterizing flavor. Manufacturers that fail to submit an objection within thirty (30) days of service of the notification described in §28-04(b)(1) of these rules shall be deemed to have waived their right to do so and the Department shall add the tobacco product(s) named in the notice to the Restricted Flavored Tobacco Product List.
- (3) Subject to the provisions of the Freedom of Information Law, N.Y. Pub. Off. Law § 87, a manufacturer may request that information it submits to the Department pursuant to §28-04(b)(2) of these rules be designated as confidential. Any portion of a manufacturer's submission for which such privilege is asserted shall be treated as confidential until such time as a Freedom of Information Law request is made for that information. If a request is made for confidential information submitted by a manufacturer, the Department shall promptly notify the manufacturer of the request.
- (4) Within sixty (60) days of receipt of a $\underline{manufacturer's\ submission\ pursuant\ to\ \S 28\text{-}04(b)(2)\ of\ these}$ rules, the Department shall either grant or deny the manufacturer's request to exclude the tobacco product from the Restricted Flavored Tobacco Product List. The Department shall make findings of fact in support of its determination to grant or deny such request

§28-05 Enforcement.

(a) The Department and the Department of Consumer Affairs shall enforce the provisions of the Act and these rules.

- (b) Violations of this Act shall be punishable as provided by the Act. Violations of these rules which are not also violations of the Act shall be subject to a penalty not to exceed one thousand dollars (\$1,000), in accordance with §555(b)(2) of the New York City Charter.
- (c) Where a person is found to have violated the Act or these rules, the Department or the Department of Consumer Affairs shall commence a proceeding to recover any civil penalty authorized pursuant to section 17-716 of the Act by the service of a notice of violation returnable to the administrative tribunal established by the board of health where the Department issues such a notice or to the adjudication division of the Department of Consumer Affairs where such department issues such notice.

§28-06 Original labels, labeling and packaging of outof-package sales required.

(a) Every owner, operator, manager or other person in control of an establishment that sells or offers for sale tobacco products, or non-tobacco products designed for consumption through the inhalation of smoke, shall maintain on site the original labels, labeling and packaging provided by the manufacturer for all such products that are sold or offered for sale by the establishment separately from its original packaging. The original labels, labeling and packaging from which the contents are sold separately shall be maintained during such time as the contents of the package are offered for sale, and may be disposed of upon the sale of the entire contents of such package.

§28-07 Construction.

(a) If any provision of this Chapter is adjudged invalid by any court of competent jurisdiction, such judgment shall not affect or impair the validity of the remainder of this chapter.

Notice is hereby given pursuant to the authority vested in the Commissioner of the Department of Housing Preservation and Development ("Department") by Chapter 61 of the New York City Charter and in accordance with the requirements of New York City Charter §1043 that the Department hereby promulgates amendments to the rules pertaining to the Tenant Interim Leasing Program. The rule was published as a proposed rule on February 12, 2010, and a public hearing was held on March 18, 2010.

Section one. Subdivision b of section 34-05 of chapter thirtyfour of title 28 of the rules of the city of New York is amended to read as follows:

- (b) Disposition. HPD will not convey a Building to an HDFC unless:
- (1) the Tenant Association has, in the judgment of HPD, satisfactorily managed the Building during the term of the Tenant Interim Lease; and
- $(2) \quad Tenants \ of \ at \ least \ eighty \ percent \ (80\%) \ of \ the \ Occupied$ Units have signed subscription agreements to purchase the shares in the HDFC attributable to their dwelling units; and (3) HPD has notified the Tenants of the Disposition Rent Increase; and
- (4) if required by HPD, the HDFC has executed a regulatory agreement which may contain, without limitation, restrictions on renting, subletting, and sales of units, and requirements for transfer fees, primary residency, and establishment of reserve accounts to be serviced by HPD for a fee equal to 0.25% of the average monthly balance in the reserve account over the previous 12 month period.

STATEMENT OF BASIS AND PURPOSE

The rule amends the provisions regarding disposition of buildings in the Department of Housing Preservation and Development's (HPD) Tenant Interim Leasing Program (TIL). The amendment adds that HPD may require the Housing Development Fund Corporation (HDFC) to enter into a regulatory agreement as a condition of disposition of the TIL building to the HDFC, and that the agreement may contain restrictions on actions concerning individual units, and requirements regarding establishment of a reserve account and a fee for servicing of such accounts by HPD. HPD has determined that HDFCs require guidance and limited supervision in financial, management, and organizational practices. The regulatory agreement provides the basis for this supervision and an agency controlled reserve fund is considered an important aspect of the agreement

Whereas, pursuant to the EDPL, the City is required to hold a public hearing to determine whether the public would be better served by the proposed acquisition of the abovementioned properties and the impact of such an acquisition on the neighborhood where the project is to be constructed; and

Whereas, the City held a public hearing pursuant to EDPL Section 204 in relation to this acquisition on Friday, January 22, 2010 in the borough of Staten Island. Having given due consideration to the complete hearing record, which includes, among other things, all documents submitted and all public comments, the City makes the following determination and findings concerning the above and below described acquisitions and project:

(1) The public use and benefit of this project is for the reconstruction of roadways, sidewalks and curbs at certain portions of Albee Avenue, from Amboy Road to approximately 155 feet north of Amboy Road; Amboy Road from Alvine Avenue to approximately 20 feet east of Poillon Avenue; Annadale Road from Amboy Road to approximately 104 feet northeast of Furman Street; Community Lane from Amboy Road to approximately 10 feet south of Amboy Road; Furman Street from Annadale Road to approximately 18 feet southeast of Annadale Road; Philip Avenue from Amboy Road to approximately 10 feet south of Amboy Road; Poillon Avenue from Annadale Road to approximately 97 feet southeast of Annadale Road; Poillon Avenue from Amboy Road to approximately 8 feet south of Amboy Road in the Borough of Staten Island (the "Project").

(2) The properties to be acquired are shown on the City's Tax

Map for the Borough of Staten Island and include the following properties:

- Block 6469, part of Lots 30, 37, 39, 43, 46
- Block 6247, part of Lots 1, 10, 20, 29, 34, 37
- Block 6246, part of Lots 21, 30Block 6245, part of Lot 108
- Block 6249, part of Lots 21, 25, 30, 33, 38, 174, 200, 207,

The proposed acquisition shall consist of the following locations in the Borough of Staten Island:

Albee Avenue, from Amboy Road to approximately 155 feet north of Amboy Road; Amboy Road from Alvine Avenue to approximately 20 feet east of Poillon Avenue; Annadale Road from Amboy Road to approximately 104 feet northeast of Furman Street; Community Lane from Amboy Road to approximately 10 feet south of Amboy Road; Furman Street from Annadale Road to approximately 18 feet southeast of Annadale Road; Philip Avenue from Amboy Road; Poillon Avenue from Annadale Road to approximately 97 feet southeast of Annadale Road; Poillon Avenue from Amboy Road to approximately 8 feet south of Amboy Road.

The City selected these locations based on a need for the installation of storm and sanitary sewers.

(3) The general effect on the neighborhood will be to improve current living conditions. The proposed Project involves the reconstruction of roadways, sidewalks and curbs and will have no significant adverse effect on the environment. The proposed property acquisition locations were included in an Environmental Assessment Study (EAS) completed on April 2009 by the New York City Department of Transportation (NYCDOT). Based on the recommendations contained in the EAS, necessary mitigation measures will be included in the design for this and other projects in the area covered by the

(4) Comments and concerns raised by the property owners at the public hearing and through subsequent written submissions are currently being reviewed by the City. Issues and concerns raised by the property owners include: 1) saving some old trees at the corner of Poillon Avenue and Annadale Road: 2) the need for construction meetings with the contractors and subcontractors; 3) proper consideration to be given to the residents during the construction period, as it relates to access to their homes; 4) traffic detours to include school bus stops to public schools and the Tottenville High School; and 5) traffic signal timing to allow for a normal flow of traffic. The City will work with all public and private parties involved in the project to minimize the impact of construction activities on the street, residents and environment. The City has also reviewed all potential alternate locations and has determined that no other sites are feasible for the Project. The City continues to review its plans and will make modifications addressing these issues whenever possible. DDC will also work with DOT, other agencies and the community in order to review the situations and address the concerns.

DETERMINATION

Based upon due consideration of the record and the foregoing findings, it is determined that the City of New York should exercise its power of eminent domain to acquire the above-described properties in order to promote and permit the purposes of the project to be achieved.

NOTICE:

Pursuant to EDPL Section 207, property owners have thirty (30) days from completion of the publication of this "Determination and Findings" to seek judicial review of this determination. Expected dates of publication are March 29, 2010 to March 31, 2010.

The exclusive venue for the judicial review of this determination pursuant to EDPL Sections 207 and 208 is the Appellate Division of the Supreme Court in the Judicial Department where any part of the property to be acquired is located.

Notice of Opportunity to Participate in a Pilot Program to Test Livery Stands at Select Locations

We have extended the DEADLINE for responses to the Livery Stand Pilot Program to give additional time to interested parties to submit responses to the pilot. The new deadline is June 1, 2010.

The New York City Taxi and Limousine Commission ("TLC") invites interested parties to submit a request to participate in a pilot program to pilot livery stands at select locations throughout the five boroughs of New York.

The Livery Stands Pilot Program will designate livery stands at privately owned locations throughout the five boroughs. The pilot program, which will be one year in duration, will allow owners or operators of private property at locations

within shopping centers, Business Improvement Districts, and other well-trafficked locations to contract with livery bases to provide transportation services on-site via a "satellite base." This pilot program will test the use of licensed livery vehicles and livery stands to enhance service to passengers, providing for more prompt, efficient, accountable and reliable dispatched service from satellite base locations. Please note, participation in a TLC pilot program in no way guarantees Commission approval for the proposer's livery stand after conclusion of the pilot program.

On May 28, 2009, the Commission voted to approve this pilot program without limit to the number of participants; it is anticipated that there will be multiple locations citywide, with a tentative goal of at least two stands in each borough. In order for your proposal to be considered for participation in this pilot program, your proposal should include the requirements listed in the Business Requirements or Section (A), Proposal Content Requirements or Section (B) and please carefully read the Evaluation Guidelines or Section (C), and MOU requirements for reporting performance and success of Program Section (D) of this document.

SECTION A Business Plan Requirements for Pilot Proposal

- Applicants must include a representative or be the owner(s) of private property (or must be a partner, contractor, licensee, permitee, tenant or subtenant that has the express consent, legal authority and approval of all property owners); for example, a representative of a Business Improvement District (BID) that partners with a shopping mall owner. The applicants may be in any legally recognized and authorized organizational form e.g., not-forprofit, for-profit, publicly or privately held companies, sole proprietorships, partnerships, Limited Liability Companies, etc.
- (2) Applicants must be capable of executing a contract with a TLC-licensed FHV base that will agree to offer dispatch service at a location other than the base location on file with the TLC. Applicants must submit a base name and letter of commitment from said base signed by an officer of the base for which a partnership is desired. TLC will grant approval to one or more bases at each selected location to provide all livery dispatch services contracted via a dispatcher program. Only vehicles affiliated with the partner base may be dispatched from the stand.

Additional required information that should be included in the Business Plan proposal:

- (1) Names of partners (if any) in the business;
- (2) Contact information of the business;
- (3) Insurance information for the business and for the location of the proposed FHV stand;
- (4) The number of base employees expected to provide dispatching service at the selected location;
- (5) The number of vehicles expected to be on-call at the selected location;
- (6) The approximate number of rides expected per hour for weekdays and weekends, separately;
- (7) Proposed hours of operation;
- (8) How the applicant intends to display fare information for common destinations from the selected location and how fees will be conveyed to the passenger as per the "FHV Passenger Bill of Rights";
- (9) How the dispatch records will be maintained and recorded.

PLEASE NOTE — No base will be permitted to participate that does not have:

- (1) Current base markings on all licensed affiliated vehicles; and
- (2) Active, licensed status with TLC, including no active suspensions or outstanding fines at the time of selection.

SECTION B Proposal Content Requirements

(a) Applicants should provide a brief narrative and description of the location and businesses in the area where proposed services are to be provided. The narrative should include demonstration of a need for livery services at the proposed location; for example, the lack of availability of alternative modes of transportation, such as medallion taxis and appropriate mass transit and/or the presence of significant utilization of livery vehicles.

(b) Applicants must propose a specific, fixed location for the livery stand. The location should be a well-trafficked, easily accessible spot. Please include an aerial or other appropriate map showing the exact location. TLC may accept or reject proposed locations in its sole discretion, and applications without a proposed location that is acceptable to TLC will be considered incomplete.

(c) Applicants must describe in detail how they plan to provide "dispatched" transportation services at the proposed location. This should include hours of operation, on-site dispatch staffing levels, and on-site non-staffed dispatching methods (e.g., courtesy telephones, etc.). Since all rides require dispatch, TLC will look more favorably upon programs that offer staffed dispatching during all hours of the facility's operation.

(d) Applicants must demonstrate the capability to provide sufficient off-street vehicle space to allow for orderly dispatching.

(e) Applicants must provide a signage plan that will direct people to the stand and clearly explain the services provided and hours of operation.

(f) Applicants must provide a fare chart for common destinations from the dispatch location. This fare chart will remain in effect for the duration of the pilot and must be available for viewing at the stand.

READER'S GUIDE

The City Record (CR) is, published each business day and includes notices of proposed New York City procurement actions, contract awards, and other procurement-related information. Solicitation notices for most procurements valued at or above \$100,000 for information technology and for construction and construction related services, above \$50,000 for other services, and above \$25,000 for other goods are published for at least one day. Other types of procurements, such as sole source, require notice in the City Record for five consecutive days. Unless otherwise specified, the agencies and offices listed are open for business Mondays thru Fridays from 9:00 A.M. to 5:00 P.M. except legal holidays.

NOTICE TO ALL NEW YORK CITY CONTRACTORS

The New York State Constitution ensures that all laborers. workers or mechanics employed by a contractor or subcontractor doing public work are to be paid the same wage rate that prevails in the trade where the public work is being done. Additionally, New York State Labor Law §§ 220 and 230 provide that a contractor or subcontractor doing public work in construction or building service must pay its employees no less than the prevailing wage. Section 6-109 (the Living Wage Law) of the New York City Administrative Code also provides for a "living wage", as well as prevailing wage, to be paid to workers employed by City contractors in certain occupations. The Comptroller of the City of New York is mandated to enforce prevailing wage. Contact the NYC Comptrollers Office at www.comptroller.nyc.gov, click on Labor Law Schedules to view rates.

New York City's "Burma Law" (Local Law No. 33 of 1997) No Longer to be Enforced. In light of the United States Supreme Court's decision in **Crosby v. National Foreign** Trade Council, 530 U.S. 363 (2000), the City has determined that New York City's Local Law No. 33 of 1997 (codified in Administrative Code Section 6-115 and Charter Section 1524), which restricts City business with banks and companies doing business in Burma, is unconstitutional. This is to advise, therefore, that the language relating to Burma contained in existing New York City contracts may

The City of New York is committed to achieving excellence in the design and construction of its capital program, and building on the tradition of innovation in architecture and engineering that has contributed to the City's prestige as a global destination.

VENDOR ENROLLMENT APPLICATION

New York City procures approximately \$7 billion worth of goods, services, construction and construction-related services every year. The NYC Procurement Policy Board Rules require that agencies primarily solicit from established mailing lists called bidder/proposer lists. To register for these lists--free of charge-, prospective suppliers should fill out and submit the NYC-FMS Vendor Enrollment application.

Attention Existing Suppliers:

Even if you already do business with NYC agencies, be sure to fill out an application. We are switching over to citywide, centralized Bidders Lists instead of the agency-specific lists previously used to issue notices about upcoming contract opportunities. To continue receiving notices of New York City contract opportunities, you must fill out and submit a NYC-FMS Vendor Enrollment application.

PRE-QUALIFIED LIST

New York City procurement policy permits agencies to develop and solicit from pre-qualified lists of vendors, under prescribed circumstance. When it is decided by an agency to develop a pre-qualified list, criteria for pre-qualification must be clearly explained in the solicitation and notice of the opportunity to pre-qualify for that solicitation must be published in at least five issues of the CR.

Information and qualification questionnaires for inclusion on such list may be obtained directly from the Agency Chief Contracting Officer at each agency, (see Vendor Information Manual). A completed qualification Questionnaire may be submitted to the Chief Contracting Officer at any time, unless otherwise indicated and action (approval or denial) shall be taken by the agency within 90 days from the date of submission. Any denial or revocation of pre-qualified status can be appealed to the Office of Administrative Trials and Hearings, (OATH), Section 3-11 of the Procurement Policy Board Rules describes the criteria for the general use of prequalified lists.

NON-MAYORAL ENTITIES

The following agencies are not subject to Procurement Policy Board rules and do not follow all of the above procedures: City University, Department of Education, Metropolitan Transportation Authority, Health & Hospitals Corporation, Housing Authority. Suppliers interested in applying for inclusion on bidders list should contact these entities directly (see Vendor Information Manual) at the addresses given.

PUBLIC ACCESS CENTER

The Public Access Center is available to suppliers and the public as a central source for supplier-related information through on-line computer access. The Center is located at 253 Broadway, 9th floor, in lower Manhattan, and is open Monday through Friday from 10:00 A.M to 3:00 P.M. For information, contact the Mayor's Office of Contract Services at (212) 788-0010.

ATTENTION: NEW YORK CITY MINORITY AND WOMEN OWNED BUSINESS ENTERPRISES

Join the growing number of Minority and Women Owned Business Enterprises (M/WBEs) that are competing for New York City's business. In order to become certified for the program, your company must substantiate that it: (1) is at least fifty-one percent (51%) owned, operated and controlled by a minority or woman and (2) is either located in New York City or has a significant tie to New York City's business community. PROMPT PAYMENT

It is the policy of the City of New York to pay its bills promptly. The Procurement Policy Board Rules generally require that the City pay its bills within 30 days after the receipt of a proper invoice. The City now pays interest on all late invoices. The grace period that formerly existed was eliminated on July 1, 2000. However, there are certain types of payments that are not eligible for interest. These are listed in Section 4-06 of the Procurement Policy Board Rules. The Comptroller and OMB determine the interest rate on late payments twice a year, in January and in July.

HOW TO READ CR PROCUREMENT NOTICES

Procurement Notices in the CR are arranged by alphabetically listed Agencies, and within Agency, by Division if any. The notices for each Agency (or Division) are further divided into three subsections: Solicitations, Awards; and Lists & Miscellaneous notices. Each of these subsections separately lists notices pertaining to Goods, Services, or Construction.

Notices of Public Hearings on Contract Awards appear at the end of the Procurement Section. At the end of each Agency (or Division) listing is a paragraph giving the specific address to contact to secure, examine and/or to submit bid or proposal documents, forms, plans, specifications, and other information, as well as where bids will be publicly opened and read. This address should be used for the purpose specified UNLESS a different one is given in the individual notice. In that event, the directions in the individual notice should be followed. The following is a SAMPLE notice and an explanation of the notice format used by the CR.
