Summarised Statement of Work Done during the Quarter ending March 31, 1893.

BRICK SEWER.

.85 linear feet of 6 feet by 6 feet 10 inches ; 2.19 linear feet of 4 feet 6 inches by 5 feet 8 inches ; 1.01 linear feet of 3 feet 6 inches by 4 feet 8 inches ; 228.22 linear feet of 26 feet by 36 feet (egg-shaped) ; 86 linear feet of 3 feet diameter (circular), making a total length of 318.27 feet of brick.

PIPE SEWER.

179.3 linear feet of 18-inch pipe sewer; 546.95 linear feet of 15-inch pipe sewer; 3,423.7 linear feet of 12-inch pipe sewer, making a total length of 4,149.05 linear feet of pipe sewer. 10 linear feet of 6-inch iron drain pipe; 428 spurs for house connections; 39 ordinary man-holes, complete; 4 receiving-basins, complete; 5,467.7 cubic yards of rock excavated and removed; 5.3 cubic yards of concrete for foundations; 2.3 cubic yards of rubble masonry in mortar; .3 cubic yards of broken stone for foundations; 3,145.94 linear feet of piles driven and cut off; 500 feet (B. M.) of lumber for foundations; 30,959 feet (B. M.) of lumber for sheeting; 9 preliminary surveys and rock soundings made for sewers and appurtenances; 6 plans, profiles, etc., and preliminary estimates for sewers and appurtenances completed; 13 field books, with sketches, etc., prepared for preliminary surveys; 7 field books, with maps and details prepared for construction work; 6 tracings of plans and details made of sewers and appurtenances; 6 plans for sewers and appurtenances completed; 6 assessment lists completed; 3 assessment lists in progress; 16 contracts, specifications, forms of bid prepared; 18 printed proofs of contracts, specifications and forms of bid read, compared and corrected.

The total length of sewers in the Twenty-third and Twenty-fourth Wards is 264,650.79 linear feet of 50,123 miles at the close of the quarter ending March 31, 1893, of which 4,468.22 linear feet or .850 miles were constructed during this quarter.

TOPOGRAPHICAL BUREAU.

SURVEYING, LAYING-OUT, MAPS AND PLANS, AND THE PREPARATION OF FINAL MAPS AND PROFILES OF THE TWENTY-THIRD AND TWENTY-FOURTH WARDS, AUTHORIZED BY CHAPT R 545 OF THE LAWS OF 1890.

I.—OFFICE WORK.

"A."—Maps Forwarded for Adoption.

1. Map and plan showing the revision of the street system in that portion of the Twenty-third and Twenty-fourth Wards bounded on the south by the Harlem river, on the west by Jerome avenue and an unnamed avenue running northerly from the first curve in Jerome avenue north of Kingsbridge road on a prolongation of said avenue to Mosholu Parkway and Van Cortlandt Park, on the north by the Gun Hill road, and on the east by Webster avenue and the New York and Harlem Railroad.

2. Map and plan showing change of location and of grade of Cammann street, from Fordham road westerly of the New York Central and Hudson River Railroad to Fordham road, near Sedgwick avenue, in the Twenty-fourth Ward.

"B."—Maps Forwarded for Filing.

1. Three copies of plan and profile showing change of grade of Intervale avenue, between East One Hundred and Sixty-seventh street and East One Hundred and Sixty-ninth street, and of Wolf street, between Sedgwick avenue and the Harlem River Channel line, in the Twenty-third Ward.

2. Three copies of map and plan showing the classification of Dawson street, from Westchester avenue to Prospect avenue, in the Twenty-third Ward.

3. Three copies of plan and profile showing Tiffany street, from the East river to Longwood avenue, and Longwood avenue, from Tiffany street to the Southern Boulevard, in the Twenty-third Ward.

"C."—Preparation of Final Maps.

The preliminary plans on a scale of three hundred feet to one inch, which were reported completed in the last quarterly report, were modified at various places at the suggestion made by property owners, and a hearing was given by the Commissioner of Street Improvements of the Twenty-third and Twenty-fourth Wards, on January 31, 1893, to all persons interested in the plan of streets lying between Third avenue, Westchester avenue, Prospect avenue, Hunt's Point road, Mohawk avenue, the Bronx river, the northern line of the City of New York, the Hudson river, the Spuyten Duyvil Creek, and the Harlem river, comprising, approximately, 10,176 acres.

The central portion of it, lying between Jerome avenue, the Gun Hill road, Webster avenue, the New York and Harlem Railroad and the Harlem river, was presented to the Board of Street Opening and Improvement for its concurrence on February 24, 1893, and the action thereon was postponed to a future meeting of the said Board. This section is now being remodeled, embodying the ideas suggested by the Board of Street Opening and Improvement.

The calculations of dimensions of blocks and studies of grades were progressed for such parts of the whole district as will not probably be changed.

The triplicate set of copies of title page, index page and seventeen map and profile pages adopted and ordered to be filed by the Board of Street Opening and Improvement on December 9, 1892, was commenced and is about two-thirds finished.

One field party was engaged on surveys preliminary to setting monument stones and bolts to define avenues and streets in the section adopted on December 9, 1892.

Resume of Calculations.

Calculations for determining dimensions of blocks, angles, studies of grades, etc., for sections 6, 7, 10, 11 and 12 are in progress.

Calculations to fix the location of the Concourse from East One Hundred and Sixty-first street to Mosholu Parkway, a distance of 21,939 feet or 4.15 miles, by co-ordinates, were completed.

Record maps for the above-mentioned five sections are in progress—record map (1st) showing the assumption on which the location of the avenues and streets were based; record map (2d) showing traverse surveys made for such sections; record map (3d) showing the results of calculations distances between monuments, bearings of avenues and streets, co-ordinates of monuments and references to former calculations; and record map (4th) showing the grades of avenues and streets previously established and of those changed, also surface levels which were taken for determining the grades.

Miscellaneous calculations were made for change of lines of Cammann street, from Fordham road westerly of the New York Central and Hudson River Railroad to Fordham road, near Sedgwick avenue and adjoining streets, determining 1,125 feet of street.

Final calculations, examinations, searches and comparisons of surveys were completed for that portion of Volume XI. of the Twenty-fourth Ward at Kingsbridge, bounded by Broadway, Spuyten Duyvil Creek and Tibbett's Brook, comprising ninety-five parcels and covering an area of 1,102.9 city lots.

Calculations are in progress for that portion of Volume XI. of the Twenty-fourth Ward, known as the Village of Spuyten Duyvil.

The records and search sheets giving dates of conveyances and descriptions of lots sold which are necessary for location of properties were kept up to date for Volumes XI. and XII. of the Twenty-fourth Ward.
