

The tollowing number of contagious diseases were reported for the week endingAugust 30th, 1873: Typhoid fever, 12; scarlet fever, 23; measles, 2; and diptheria, 22.

The Disinfecting Corps have visited during the past week 66 premises where contagious diseases were found and have disinfected and fumigated 64 houses, 66 privy sinks, together with clothing, bedding, &c. One case of typhoid fever was removed at night by the Ambulance Corps, from the 22d precinct Station House.

In addition to the regular duties performed by the Disinfecting Corps, 190 miles of street gutters, 700 privies, 68 yards and 44 cellars were disinfected.

During the week ending August 30, 1873, there were issued from this Bureau 613 burial permits for city deaths, 75 for bodies in transitu, and 45 for the interment of still-born infants. There were 26 searches of the registers of births, marriages and deaths, and 3 transcripts of marriage record and 34 of death were issued from this Bureau. to believe that there are sources of unhealthiness existing in the cellars or underground rooms and areas of private residences even of the wealthiest classes of citizens, which demands the attention of this Board. It has come to our knowledge in of this Board. It has come to our knowledge in several instances recently that these underground rooms were wet, and that not unfrequently gar-bage and kitchen refuse of various kind, were stored in the cellars of their residences for a long period. In many cases there were pools of stag-nant water throughout the year. This water

areas, too often the servants have found it con-venient to make these concealed places the receptacles of all kinds of kitchen refuse, where it is allowed to remain for indefinite periods, and diffuse its noxious emanations through the kitchen, dining room, and even the sitting and sleeping rooms of the house. And, finally, the servants' water closets are generally located in the cellar or area. the cellar or area, and are rarely properly constructed or attended to. It too frequently happens that this portion of the house receives but little attention from the landlord or landlady, or if these conditions are known, the dangerous influence which they exert upon the health of the family is not fully appreciated. Damp or wet cellars and areas are so common that people in general believe this state essential to the very existence of such underground rooms. And, for circulation among truck-men.

Whereas, it appears by reports forwarded to this Board by the Sanitary Superintendent that the cellars in the buildings hereinafter named

existence of such underground rooms. And, what is more serious, housekeepers and servants sometimes regard those places as suitable receptacles of filth.

Existence of such underground rooms. And, not so cleanly as in former weeks. Of those especially dirty he mentions the unpaved streets sometimes regard those places as suitable receptacles of filth.

Assistant Inspector Strong (upper part 22d Ward) reports that all the paved streets in his

health of the inmates of the house are most dis-astrous. Many phases of ill health are the results, especially to children, as also serious, or fatal diseases like rheumatism, fevers, &c., These evils are all susceptible of complete remedy. Ever damp and foul cellars may be thoedy. Ever damp and foul cellars may be thoroughly cleaned, and rendered thereafter permanently dry. But to secure such improvement the sources of the evil must be sought for by skilled persons, and when found, the most approved measures for correcting the evils must be rigidly enforced. The Committee recommend the adoption of the following resolution:

Resolved, That the Sanitary Superintendent be, and is hereby directed to cause an inspection to be made of the cellars, basements and areas of private residences, or residences not classified as tenement houses, and report in writing upon all premises found in a condition detrimental to health, and requiring the action of this Board.

SIR-I have the honor to submit the following report on the condition of the streets and avenues

report on the condition of the streets and avenues of the city in regard to cleanliness for the week ending August 30, 1873, compiled from the usual weekly reports of the Inspectors and Assistant Inspectors connected with this Bureau.

Inspector Judson (1st, 3d and 5th Wards) reports that he finds no improvement in the condition of the streets of his district, save that the lower portion of South street, Pearl street, near Whitehall, the lower portion of Whitehall street and York street contained rather less street manure than the other portion of the district. manure than the other portion of the district. Carlisle street was found less filthy than Morris

Assistant Inspector Lockwood (2d and 4th Wards) reports that during the past week the streets in his district have been in an unsually

cleanly condition.

Inspector Tracey (6th Ward) reports that during the past week the streets of his district have been cleaner than for many previous weeks, with the exception that Walker street, from Broadway to Baxter, Centre, from Canal to Walker, Courtland alley and Leonard street, from No. 153 to Centre street, were all dirty with dirt and rubbish.

Assistant Inspector Emerson (7th Ward) reports Assistant Inspector Emerson (7th Ward) reports that during the past week the condition of the streets in his district has been even worse than during the previous week. He says: "The storms of the last fortnight have made havoc with the cobble-stone pavements, digging deep holes where the pavement was broken, in which water has stood and garbage has accumulated." The portions of streets that were found in a filthy condition in the early part of the week were found later to be more cleanly; but, as a rule, soon after the streets are cleaned they are again defiled by garbage and refuse animal and again defiled by garbage and refuse animal and regetable matter, deposited by the inmates of the

Inspector Morr.'s (oth and 15th Wards) reports that the streets in his district are much cleaner than for some weeks past, with the exception of Sullivan street, above Bleecker, and Downing

Sullivan street, above Bleecker, and Downing street. This latter street was dirty with garbage which had evidently fallen from the receptacles as they were emptied by the garbage collector.

Inspector Bryant (10th and 13th Wards) reports that Mangin, Goerck, Ridge and Essex streets contain coarse garbage and rubbish; Rivington and Division give evidences of imperfect sweeping, and the remaining streets show improvement in cleanliness.

Inspector Munde (11th Ward) reports that the streets in his district are pretty well cleaned twice

streets in his district are pretty well cleaned twice a week; but that they soon become defiled with new accumulations of garbage and gutter filth. He repeats his recommendation that the streets

Pre repeats his recommendation that the steels be cleaned oftener.

Assistant Inspector Fowler (upper part 12th Ward) reports that the streets in his district are clean and in good condition, with the exception of those unpaved streets of which he has before complained.

Assistant Inspector Hamilton (16th Ward) re-

Assistant Inspector Hamilton (16th Ward) reports that the streets in his district are generally in a cleanly condition. The exceptions during the past week were 16th street, between 6th and 7th avenues, 17th street, between 9th and 10th avenues, and parts of 7th avenue, which were not properly cleaned.

Assistant Inspector Atwater (17th Ward) reports that the streets in his district are well swept, with the exception of 9th street, between 1st avenue and Avenue A, 11th and 12th streets, between 1st avenue, B, and portions of Suffolk and Stanton streets, all of which were offensive with garbage and street filth.

Inspector Russell (18th Ward) reports that the streets in his district are in a very fair condition

as regards cleanliness. Assistant Inspector Walker (20th ward) reports the streets in his district in good condition.

Inspector Roberts (21st Ward) reports that all of the streets in his district have been swept dur-

of the streets in his district have been swept during the past week, and that the well paved ones
are in a fair sanitary condition, while little can
be said of those which are poorly paved. First

M., 700 crates and 800 baskets of peaches; at 105 Barclay street, 2 barrels of pears, removed at the expense of the owner; at 99 Barclay street, 5 boxes of pears; at 100 Barclay street, 5 crates of apples; at 238 Greenwich street, 3 barrels of apples, 3,000 ears of corn, and 5 barrels of potatoes; and at 65 Murray street, 2 barrels of pears.

On the first day of September, the same officers visited and condemned fruit, etc., as follows: Schooner West Wind, from Bay Shore, 6 barrels of melons; schooner Gordon, from Red Bank, 15 barrels of melons; schooner Emily A. Fuller, from Keyport, 5 barrels of melons.

SIR: In the week ending on the 30th of August 613 deaths were reported in this city. During the previous week the actual number of deaths was 626: Upon that number, and for the third week in August the comparisons are made. Compared with the records of the corresponding week of 1872 the total number of deaths was week of 1872 the total number of deaths was less by 119 in the third week in August, this year. The number of deaths of children under 5 years of age was 68 less, and the mortality by diarrhoeal diseases was 91 less. In like manner

the mortality last week and the week previous presented a favorable decrease from the average of the corresponding period in the past five of the corresponding period in the past five years. The city continues free from epedemic diseases. The death-rate last week was equivalent to 31.87 annually in the 1,000 living in the city, and, in the previous week, it was at 32.55 per 1,000. The death-rate in the twenty-one city, and, in the previous week, it was at 32-59 per 1,000. The death-rate in the twenty-one chief cities of Great Britain, the second week of August, was at 27 per 1,000; in London it was at 25; in Liverpool 35; Manchester 36, aml Portsmouth 14; while in Paris the rate was equal to 24; in Brussels 25, and in Vienna it went up to 56 per 1,000, a result of great increase of cholera. The steady decrease of mortality in New York the past five weeks gives signal encouragement to sanitary efforts.

It is now ten weeks since the summer maladies of young children began to swell the bills of

It is now ten weeks since the summer maladies of young children began to swell the bills of mortality in this city; and in the nine weeks that ended last Saturday 3,976 children under 5 years of age died, and the total mortality at all ages was 6,644. The mortality in the corresponding period of the summer of 1872 was, in the nine weeks, 7,788, and of those deaths the number of children under 5 years was 4,540; the excess in 1872 being 1,144, while the excess in the infant mortality was only 564. In the week ending July 5th, of the present year, under a mean temperature of 78.04° Fahr., the number of deaths went up to 683, being an increase of 113 deaths in a single week, and that exclusively of infants under 2 years of age. SUDDEN DEATHS, AND DEATHS OF STRANGERS WITHOUT MEDICAL ATTENDANCE.

With its million of inhabitants, and with the daily arrival of greater numbers of emigrants and strangers than arrive in any other city in the world, the city of New York necessarily receives a considerable addition to its mortality records from these non-resident classes.

In the great cities of Europe the deaths of non-residents are not counted in the summary of weekly mortality. But in New York we include all such deaths in the record of the Health De-partment. The sudden death of Edwards, a cornish miner at an emigrant ledging in Feart partment. The sudden death of Edwards, a cornish miner, at an emigrant lodging in Front street, the morning after landing, became the subject of much comment, though from a disease that had continued for weeks. Careful investigation and the autopsy in that case showed that it was not cholera, but the destructive lesions of typhoid fever that killed him. As required by law, the Coroner notified the Health Department of this sudden death, and the inquiries law, the Coroner notified the Health Department of this sudden death, and the inquiries which were immediately made by Sanitary officers proved that no pestilence was connected with the case. But had this been, as reported, a case of cholera, the keeper of the lodging house had already, as he informed me, received many days ago and put in practice the proper instructions and materials for keeping his premises and water-closest disinfected. It is an instance that illustrates the correct plan of preventing cholera. illustrates the correct plan of preventing cholera, or in the words of Prof. von Pettenkofer, "What to do against Cholera before it comes."

That no person shall boil, heat, dry, keep, store or manufacture any offal, swill, blood, bones, fat, tallow or lard, or any decaying animal or vegetable matter; nor shall the business of bone crushing, bone boiling, bone grinding, bone or shell burning, lime making, gut cleaning, skanning, or making glue from any parts of dead animals, heating, drying, storing, shipping or transporting any blood, scrap, fat, grease, or offensive animal or vegetable matter, or manufacturing materials for manure, be allowed or conducted in the city of New York, or in its waters, without a special permit from this Board, to be applied for in writing, specifying the nature and precise location of the proposed business.

Section 130. That no ship, boat or other vessel or article shall be taken or allowed by any person to come into or lay to, or at, or within any dock, pier, bulkhead or slip, or be placed thereon for the purpose of the shipment or removal of any offal, garbage, rubbish, blood or offensive animal or vegetable matter, dirt or dead animals, or for the use of any contractor about the removal of any of the foregoing substances, without a permit from this Department.
