Orainances, Resolutions, etc., approved by the Mayor during the week ending October 9, 1875. Resolved, That four lamps of the Bartlett pattern be substituted for the ordinary street-lamps in front of the church in Norfolk street, between Broome and Grand streets, under the direction of the Commissioner of Public Works.

Whereas, From the result of the deliberations of the State Board of Equalization, based on the estimates of the valuation of the State Assessors, it is evident, that under the present system no relief will be afforded the City and County of New York, but the unequal ratio of State taxes, burdened

will be afforded the City and County of New York, but the unequal fails of State taxes, burdened upon it for years, continued; and Whereas, It is well known that the value of real estate in the City of New York, as estimated for the years 1873 and 1874, and on which the State Assessors have based their ratios of assessment, has depreciated full twenty-five per cent., if not more, in the city, while the same cannot be said of the counties, and the State Assessors, as far as it concerns the City of New York, have wholly disre-garded this fact, and its enunciation as expressed in the estimates of our local assessors, showing the full value of the city property to be one billion three hundred and ninety-four million four hundred and eighty-eight thousand nine hundred and sixty dollars, against one billion nine hundred and thirty-five million twenty-one thousand five hundred and forty dollars, as in the table of the State Assessors : and

thirty-five million twenty-one thousand five hundred and forty dollars, as in the table of the State Assessors ; and Whereas, The exhibit of the State Assessors, made before the State Board of Equalization, shows that, while they have added to the full valuation of property as presented by our local assessors not less than five hundred and forty million five hundred and thirty-two thousand five hundred and seventy-four dollars, they at the same time have diminished the valuation of local assessors in other cases, as, for instance, in Cayuga County, the home of State Assessor Fowler, from forty-six million two hundred and twenty-five thousand seven hundred and nine dollars to thirty-eight million seven hundred and forty-two thousand and ninety-three dollars; in Seneca County, the home of State Assessor Hadley, from twenty-two million eight hundred and forty-four thousand and twenty-five dollars to nineteen million six hundred and seventy-seven thousand five hundred and ten dollars; and in Albany, Erie, Onondaga, Steuben, Washington, and other counties, the homes of one or another member of the State Board of Equalization, reductions from the valuation of the local assessors have been made by the State Assessors amounting to from seven, to ten and seventeen millions of dollars in several single cases; and

been made by the State Assessors amounting to from seven, to the number of the rotat assessors in verse several single cases ; and
Whereas, By this arbitrary, unjust, and self-interested proceeding of the State Assessors, and a majority of the State Board of Equalization—Lieutenant-Governor Dorsheimer, State Treasurer Raines, and State Assessor Briggs, from Kings County, only voting in favor of justice and fairness—one million two hundred and fifty-four thousand four hundred and seventy-six dollars more taxes have been put upon this city than could be justly claimed by the State, while the rest of the State has been unduly relieved from the same amount of taxation, burdening on the city for the value of its assessed property eight million twelve thousand three hundred and eighty-six dollars, where it should have been six million seven hundred and fifty seven thousand nine hundred and the dollars, and telling off the balance of the State with seven million seven hundred and fifteen thousand five hundred and seventy-two dollars; therefore be it
Resolved, That this Board, as the representative of the citizens and taxpayers of the City and County of New York, do earnestly protest against the continued unjust treatment this overburdened community, in spite of all protestations, is receiving at the hands of the State Assessors and the State Board ot relieve this city from a continuance of such unwarranted extortion;
Resolved, That the Committee on Finance be and is herewith instructed to give this matter of State taxation their due consideration, in order to suggest to this Board such remedies as in their opinion may tend to relieve this Board, and of the citizens at large, are due to the Commissioners, George H. Andrews, Wilson G. Hunt, and Isaac Sherman, appointed agreeably to a resolution of this Board by his Honor the Mayor, and with a view of convincing the State Assessors and the State Board of Equalization.

AN ORDINANCE to amend an ordinance entitled "An ordinance to amend an ordinance to regulate permits for street-stands, show-cases, signs, stairways, hoistways, and deliveries," approved February 24, 1866, which became adopted July 27, 1874. The Mayor, Aldermen, and Commonalty of the City of New York do ordain as follows : Section I. Section I of the ordinance of 1874, amending section 5 of the ordinance of 1866, is hereby amended by striking from the last clause in the said section 5 the words, "use the street beyond the stoop line," and inserting in lieu thereof the following, "place any sign upon the top of any building that shall project into the street, or over the sidewalk from any such building, in any street or avenue in the City of New York," so that said section 5, when so again amended, shall read as follows: as follows: \S 5. Every grantee of a privilege under this ordinance for a show-case, signs, stairways, or hoistways, shall pay a sum of one dollar for each, and grantees of all other privileges the sum of one dollar, towards the expense of executing this ordinance, to be accounted for among other fees of the Mayor's office. It is hereby understood and expressed that for the receiving and delivering of goods no fee shall be charged, and the Corporation Attorney shall not hereafter institute suits for alleged obstructions occasioned by the receipt or delivery of merchandise in the ordinary course of business, but no person shall deposit any article or articles upon any street or sidewalk in the city in such manner as to obstruct the free use thereof by the public. The aggregate sum for any one permit containing all or any portion of the privileges expressed in this section shall not exceed the sum of three dollars, and all may be granted for that fee; but in no case is permission to be given to place any sign upon the top or from in front, above the second floor of any building that shall project into the street or over the sidewalk from any such building in any street or avenue in the City of New York. as follows York. Sec. 2. All ordinances or parts of ordinances inconsistent or conflicting with the provisions of this ordinance are hereby repealed. Sec. 3. This ordinance shall take effect immediately. Adopted by the Board of Aldermen, September 30, 1875. Approved by the Mayor, October 4, 1875.

On the 22d of September I addressed the following communication to the Police Commissioners of this city :

OFFICE OF THE BOARD OF EDUCATION, NEW YORK CITY, Sept. 22, 1875

To the Police Commissioners of the City of New York: GENTLEMEN-I beg leave to call your attention to section 8 of chapter 421 of the Laws of 1874, also to section 11 of the Rules and Regulations of the Board of Education, made in conformity there-with, and request that you have an order issued by the Superintendent of Police that will embrace the following points :

following points : That each police officer, when he finds children upon the streets between the hours of nine and three o'clock "of any school day of the public schools of the City of New York," shall obtain their names, together with the names of their parents and their place of residence, and report the same daily to the Captain of his Precinct. That each Captain of Police shall make a special written daily report of such children found on the streets to the Superintendent of Police, which report shall be open to the inspection of the Super intendent of Truancy, with authority to take a copy of the same if required. Also, that your officers on duty be required to disperse boys that are over 14 years of age (over whom I have no jurisdiction) when found congregating in crowds on the streets or at public places, as they tend largely to encourage truancy among the younger boys who otherwise would attend school regularly.

regularly. If you will have the above enforced, I feel that much good will result therefrom; it cannot in any way, I think, interfere with the duties of an officer on post, and will greatly assist me in enforcing the Compulsory Educational Law, as I will then be able to find just the class of children the law is aimed at.

In response to my communication, the Police Commissioners, at their meeting held October 5, 1875, adopted the following rules, which have to-day been promulgated by the Superintendent of Police to the force under his command :

RULE 390. Whenever any officer of the Police Force, while on patrol duty, shall find children between the ages of eight and fourteen years in the streets between the hours of 9 A. M. and 3 P. M. of any school day of the Public School days of New York, they shall obtain their names and the names of their parents or guardians, and place of residence, and report them to the Captain of his Precinct. The officer shall, on taking the names of the children, direct them to go to school, and warn them, if found on the street again quiring school hours they will be liable to arrest found on the street again during school hours, they will be liable to arrest.

RULE 391. Each Captain or Sergeant of Police in command of a Precinct shall make a daily report to the Superintendent of such children so reported to him, a copy of which shall be furnished to the Superintendent of Truancy.

RULE 392. It shall be the duty of all officers of a Precinct, while on patrol duty, to disperse all crowds of boys over 14 years of age who may be found loitering at the corners or upon the streets or near public places, obstructing the highway or the entrance to public or private buildings. SUPERINTENDENT OF TRUANCY.

The President laid before the Board the report of the Superintendent of Truancy, as follows :

OFFICE OF THE SUPERINTENDENT OF TRUANCY, } NEW YORK, October 6, 1875.

To the Board of Education :

GENTLEMEN-I have the honor to submit the following report of the transactions of the Depart-ment of Truancy from September 15 to October 5, inclusive. The total number of cases investigated by the agents is 873. Of this number 278 were kept from school by various minor causes, and 194 whose residence could not be found, leaving 401 truants and non-attendants, of which number 365 have been placed in school, 8 committed to care of Commis-sioners of Charities and Corrections, 1 committed to care of Society for Reformation of Juvenile Delinquents, and 27 withdrawn from school.

Of the children above reported as having been withdrawn from school 10 have gone to work, 11 left the city, 4 been placed in Juvenile Asylum, and 2 placed in Catholic Protectory. Appended will be found a detailed statement.






