

APPROVED PAPERS.

Ordinances, Resolutions, etc., approved by the Mayor during the week ending December 1, 1877.

Resolved, That the lands bounded by George street on the north, Union avenue and White's lane on the east, Delmonico and Concord avenues on the west, and thence southerly to Long Island Sound, be drained by other means than by sewers, as provided in chapter 566, Laws of 1871, as amended by chapter 549, Laws of 1875, under the direction of the Department of Public Parks; and that the accompanying ordinance therefor be adopted.

Resolved, That an additional street lamp be placed and lighted in front of the Headquarters Building of the Fire Department, Nos. 155 and 157 Mercer street, under the direction of the Commis-sioner of Public Works.

acts amendatory thereof; and be it further Resolved, That the salary of the said Physician to the County Jail be and is hereby fixed at the sum \$600 per annum, payable monthly.

The Secretary presented the Quarterly Report for the quarter ending November 30, 1877, which was approved and ordered forwarded to his Honor the Mayor.

Sanitary Bureau.

The following is a record of the work performed in the Sanitary Bureau for the week ending November 24, 1877 :

The total number of inspections made by the Sanitary and Assistant Sanitary Inspectors was 1,989, as follows, viz.: 8 public buildings, 930 tenement-houses, 170 private dwellings, 38 other dwell-ings, 19 manufactories and workshops, 23 stores and warehouses, 46 stables, 41 slaughter-houses, 15 milk inspections, 2 piers, I brewery, 2 public sewers, 2 fat rendering establishments, 2 manure dumps, I garbage dump, I pond, 86 sunken and vacant lots, I roadway, I fat house, I dangerous building, 56 yards, courts and areas, 63 cellars and basements, 170 waste-pipes and drains, 156 privies and water-closets, 93 streets, gutters and sidewalks, 10 dangerous stairways, I cess-pool, 2 dangerous chimneys, I piggery, 4 violations of the Code, 26 other nuisances, together with 19 visits of the Sanitary Inspectors to cases of contagious disease. The number of reports thereon received from the Inspectors was 722. During the past week 67 complaints were received from citizens, and referred to the Sanitary The total number of inspections made by the Sanitary and Assistant Sanitary Inspectors was 1,989,

During the past week 67 complaints were received from citizens, and referred to the Sanitary and Assistant Sanitary Inspectors for investigation and report. Permits have been issued to the consignces of 51 vessels to discharge cargoes, on vouchers from

the Health Officer of the Port.

59 permits have been granted scavengers to empty, clean, and disinfect privy-sinks. The Disinfecting Corps have visited 56 premises where contagious diseases were found, and have disinfected and fumigated 53 houses, 53 privy-sinks, together with clothing, bedding, etc.

During the week ending Saturday, November 24, 1877, there were issued from this Bureau 424 burial permits for city deaths, 32 for bodies in transitu, and 35 for the interment of still-born infants. There were recorded 424 deaths, 178 marriages, 500 births, 35 still-births, 32 applications for transit permits, and 44 returns from coroners. There were 35 searches of the registers of births, mar-riages, and deaths, and 5 transcripts of birth record, 3 of marriage, and 27 of death were issued from this Bureau.

W. DE F. DAY, M. D., Sanitary Superintendent and Register: SIR-424 deaths were reported to have occurred in this city during the week ending Saturday, November 24, 1877, which is a decrease of 42 as compared with the number reported the preceding week, and 11 more than were reported during the corresponding week of 1876. The actual mortality for the week ending November 17, was 444, which is 48.0 below the average for the corresponding week of the past 5 years, and represents an annual death-rate of 21.31 per 1,000 persons living, the population estimated at 1,083,304. Compared with the deaths reported during the corresponding week of 1876, measles showed an increase of 3, membranous croup, 2; diphtheria, 6, and typhoid fever, 1. The following is a comparison of the 8 most fatal causes of death during the week ending November 25, 1876, with November 24, 1877, viz. :

The past week showed a decrease compared with the preceding week of one death from whooping cough, I from erysipelas, 3 from diarrhead diseases, I from alcoholism, I9 from phthisis pulmonalis, 6 from bronchitis, 7 from diseases of the heart, I from marasmus and scrofula, 3 from hydrocephalus and tubercular meningitis, 2 from cyanosis and atelectasis, and 5 from suicide; measles increased 3; scarlatina, 2; diphtheria, I; membranous croup, I; typhoid fever, I; cerebro-spinal fever, I; malarial fevers, 3; puerperal diseases, I; inanition and want of breast milk, 5; rheumatism and gout, 2; cancer, 2; pneumonia, 4; diseases of the nervus system, I; entertitis, gastritis and peritonitis, 3; Bright's disease and nephritis, 2; and premature and preternatural births, 2.

Of the total number of deaths reported for the week, 66 were in institutions, 224 in tenement-houses, 121 in houses containing 3 families or less, 9 in hotels and boarding-houses, I in rivers, streets, boats, etc.; 8 were on the basement floor, 106 on the first, 111 on the second, 92 on the third, 30 on the fourth, 5 on the fifth, and 2 on the sixth; 422 were stated to be residents of New York City, and 2 non-residents; 50 were stated to be single, 113 married, 39 widowed, and the condition of 222 was not stated, these were children who had not attained a marriageable age.



Draper, Director of the New York Meteorological Observatory, Central Park.




