

BOARD OF ARMORY COMMISSIONERS.

MAYOR'S OFFICE, CITY HALL, NEW YORK, March 14, 1889.

A meeting of the Armory Board was held this day, at I P. M., at the office of his Honor the

Mayor.

Present—The Mayor, the President Commissioner of Taxes and Assessments, the Commissioner of the Public Works Department and Colonel Emmons Clark.

The minutes of the last meeting were read and approved.

A communication was received from I. Joseph, No. 40 Wall street, offering, as an armory site, a plot, 75 by 184 feet, 375 feet east of Ninth avenue, between Sixteenth and Seventeenth streets. Price, \$60,000.

Ordered on file.

The request of Architect J. P. Leo for a payment on account of services, was then considered. Commissioner Coleman reported that he was entitled to a payment and recommended the

amount as \$5,500.

Colonel Clark presented the following resolution:
Resolved, That a voucher for \$5,500, in favor of John P. Leo, architect for the Twenty-second
Regiment Armory, be forwarded to the Comptroller for payment, and that the Commissioners of
the Sinking Fund be requested to concur in the same.

This resolution was unanimously passed.

A report was read from the Clerk of the Works as to the progress of the work on the Eighth and Twenty-second Regiments armories.

A communication was read from the Corporation Counsel in reply to the Secretary's letter relating to bill of printing contracts, specifications and proposal for the Twelfth Regiment Armory:

SIR—I have received your letter, dated February 11, 1889, in which you ask my opinion how the bill of Martin B. Brown, amounting to \$153.03, for printing proposals, contracts and specifications shall be paid.

The printing charged for in the bill you state was ordered by your Board directly from Mr. Brown and not through the CITY RECORD and was so ordered prior to the opinion of the Counsel to the Corporation given to your Board under date April 26, 1887.

The printing of the forms of contract, specifications and proposals in question seems to have been ordered by your Board with reference to the erection of a particular armory building, viz., the armory at Ninth avenue, Sixty-first and Sixty-second streets. It does not fall within the category of stationery and printing for ordinary office purposes. It may therefore, I think, be fairly considered an expense incidental to the erection of the armory building and that accordingly, as intimated in my predecessor's opinion already referred to, the Commissioners of the Sinking Fund may appropriate at the recommendation of your Board an amount sufficient to cover this expense out of the proceeds of bonds heretofore sold remaining in their hands.

Colonel Emmons Clark presented the following resolution:

Resolved, That a voucher be drawn for \$153.03 in favor of Martin B. Brown, and forwarded to the Comptroller for payment from the "Twelfth Regiment Armory Fund," for printing specifications and proposals for that armory, and that the Commissioners of the Sinking Fund be requested to concur in the same.

This resolution was unanimously passed.

The report of the Committee on Sites was read and ordered on file.

The Committee appointed by the Armory Board in 1888, to recommend suitable sites for armories for those regiments of the National Guard of this city not already properly provided for,

That due consideration has been given to the subject of suitable sites for armories for the Ninth and Sixty-ninth Regiments, the only regiments not yet properly provided for by the Armory Board, when the Commissioners of the Sinking Fund have approved the sites selected for the Seventy-first Regiment on the block bounded by Fourth and Lexington avenues and Thirty-third and Thirty-fourth streets. The public policy of locating either of said regiments above Forty-second street has also been specially considered. Four regiments are already located above Forty-second street: the Twelfth Regiment at Ninth avenue and Sixty-second street, the Twenty-second Regiment at Sixty-eighth street and Boulevard, the Seventh Regiment at Sixty-seventh street and Fourth avenue, and the Eighth Regiment at Ninety-fifth street and Fourth avenue. It is the opinion of your Committee that too many regiments are already located above Fifty-ninth street, and that they are too far distant from the business and populous portions of the city to be speedily useful, when needed, on account of the long distance they would be obliged to march in case their services were required in the lower or central parts of the city. It will be a long period, in all probability, before the services of any regiment will be needed above Ninety-fifth street, and the Eighth Regiment, now permanently located at Ninety-fifth street, will be able to respond quickly to any call from the civil authorities for military services above that street. But in the part below Forty-second street, now fully built up, and occupied by public buildings and by financial, commercial, mercantile and manufacturing establishments as well as by a large population, there is always a possibility of the services of the National Guard being required in case the civil authorities and the municipal police are unable to protect the lives and property of the people and maintain public order. For these reasons and in the public interest your Committee report and recommend that the Ninth Regiment and Sixty-ninth Regiment should be located below Forty-second street, and in the opinion of the Committee the welfare and numerical strength of said regiments will be promoted thereby.

This Committee is prepared to report suitable sites for the Ninth and Sixty-ninth Regiments, should the Armory Board concur in the opinion that the public welfare demands that said regiments should be located below Forty-second street.

The matter was laid over.

Commissioner Coleman offered sketches of locations for the Ninth Regiment, which he had submitted to the Colonel of the regiment.

Commissioner Coleman also offered a sketch of a site for the Sixty-ninth Regiment, which embraced Hall place.

The Secretary was directed to write the Corporation Counsel as to the power of closing Hall place and using it for such a purpose.

Commissioner Coleman offered the following resolution:

Resolved, That the Comptroller be recommended, with the concurrence of the Commissioners of the Sinking Fund, to renew for one year the premises now occupied as an armory, Broadway, Forty-fourth and Forty-fifth streets, for the use of the Seventy-first Regiment and Brigade Headquarters, at a yearly rental of \$17,500.

This resolution was unanimously adopted.

The meeting then adjourned.

Resolved, That a crosswalk of two courses, with a row of paving-blocks between the courses, be laid across One Hundred and Forty-fifth street, at its intersection with the easterly and westerly sides of Eighth avenue; the materials to be used for said work to be bridge-stone of North river blue stone of the dimensions and according to the specifications now used in the Department of Public Works; under the direction of the Commissioner of Public Works; and that the accompanying ordinance therefor be adopted.

Resolved, That permission be and the same is hereby given to Barnum & Bailey to parade their show or circus in some of the principal streets of this city, on the evening of March 22, 1839, accompanied by music, weather permitting. If the weather should prove unfavorable on this date, the parade is hereby permitted to be given the first fair evening following.

Resolved, That permission be and the same is hereby given to Barnum & Bailey to drive advertising wagons through the streets of this city, from March 18 to April 20, 1889, provided such wagons shall not obstruct or hinder the free uses of the streets by the public, and upon the further condition that should the privilege hereby given in any way hinder or obstruct the uses of the streets, it shall then be in the power of the Commissioner of Public Works, and it is hereby made his duty, to prevent any further exercise of the privilege hereby granted.

Adopted by the Board of Aldermen, February 26, 1889. Approved by the Mayor, March 6, 1889.

Resolved, That permission be and the same is hereby given to P. T. Wall to place and keep an ornamental post and clock, as shown on the accompanying letter, in front of No. 30 Union Square, the work to be done and gas supplied at his own expense, under the direction of the Commissioner of Public Works; such permission to continue only during the pleasure of the Common Council.

Adopted by the Board of Aldermen, February 19, 1889. Approved by the Mayor, March 1, 1889.

Resolved, That permission be and the same is hereby given to James Everard to extend the vault in front of his premises, on the north side of One Hundred and Thirty-second street, beginning at a point about one hundred and sixty feet east of Fifth avenue, and running easterly one hundred and twenty feet, four feet beyond the curb, upon payment of the usual fee, provided the work be done in a durable and substantial manner, and that the said James Everard shall stipulate with the Commissioner of Public Works to save the city harmless from any loss or damage in consequence of the building or extension of said vault during the progress of the work, or subsequent to the completion thereof, the work to be done at his own expense, under the direction and to the satisfaction of the Commissioner of Public Works; such permission to continue only during the pleasure of the Common Council. Sec. 18. That no owner or lessee of any building, or any part thereof, shall lease or let, or hire out the same or any portion thereof, to be occupied by any person, or allow the same to be occupied, as a place in which, or for any one, to dwell or ledge, except when said buildings or such parts thereof are sufficiently lighted, ventilated, provided and accommodated, and are in all respects in that condition of cleanliness and wholesomeness, for which this Code or any law of this State provides, or in which they or either of them require any such premises to be kept. Nor shall any such person rent, let, hire out, or allow, having power to prevent the same to be used as or for a place of sleeping or residence, any portion or apartment of any building, which apartment or portion has not at least one foot of its height and space above the level of every part of the sidewalk and cubstone of any adjacent street, nor of which the floor is damp by reason of water from the ground, or which is imprepated or penetrated by any offensive gas, snell, or exhalation prejudicial to health. But this section shall not prevent the leasing, renting, or occupancy of cellars or rooms less elevated than aforesaid and as a part of any building rented or let, when they are not let or intended to be occupied or used by any person as a sleeping apartment, or as a principal or sole dwelling apartment.

REGULATIONS ESTABLISHING A SCALE OF WATER RENTS AND RULES GOVERNING THE USE OF WATER, FOR THE CITY OF NEW YORK, BY ORDER OF JOHN NEWTON, COM-MISSIONER OF PUBLIC WORKS.

U NDER CHAPTER 410, LAWS 1882, SECTIONS 350, 351, 352 and 353, and as amended by chapter 559, Laws 1887, as follows:

The rent of all tenements which shall exceed in width fifty feet shall be the subject of special contract with the Commissioner of Public Works.

The apportionment of the regular rents upon dwelling houses are on the basis that but one family is to occupy the same, and for each additional family, one dollar per year shall be charged.

Meters will be placed on all houses where waste of water is found, and theywill be charged at rates fixed by the Department for all the water passing through them. The extra and miscellaneous rates shall be as follows, to wit:

BARBERS.—For the average daily use of flour, for each barrel, three dollars per annum.

BARBER SHOPS shall be charged from five to twenty dollars per annum each in the discretion of the Commissioner of Public Works; an additional charge of five dollars per annum shall be made for each bathtub therein.

BATHING TUBS in private houses, bayond one shall be

five dollars per annum shall be made for each bath tub therein.

Bathing Tubs in private houses, beyond one, shall be charged at three dollars per annum each, and five dollars per annum each, and five dollars per annum each in public houses, boarding-houses, and bathing establishments. Combination stationary wash-tubs, having a movable division in the centre and capable of use for bathing, shall be charged the same as bathing tubs.

BUILDING PURPOSES.—For each one thousand bricks laid, or for stone-work—to be measured as brick—ten cents per thousand For plastering, forty cents per hundred yards.

Cows.—For each and every cow, one dollar per annum. Dining Saloons shall be charged an annual rate of from five to twenty dollars, in the discretion of the Commissioner of Public Works.

FISH STANDS (retail) shall be charged five dollars per annum each

For all stables not metered, the rates shall be as follows:

HORSES, PRIVATE.—For two horses there shall be charged six dollars per annum; and for each additional horse, two dollars.

HORSES, LIVERY.—For each horse up to and not exceeding thirty in number, one dollar and fifty cents each per annum; and for each additional horse, one dollar.

HORSES, OMNIBUS AND CART.—For each horse, one dollar per annum.

HORSE—FROUGHS.—For each trough, and for each half

Horses, Omnibus and Cart.—For each horse, one dollar per annum.

Horse Troughs.—For each trough, and for each half barrel or tub on sidewalk or street, twenty dollars per annum; each trough is to be fitted with a proper ball-cock to prevent waste.

Hotels and Boarding Houses shall, in addition to the regular rate for private families, be charged for each lodging room, at the discretion of the Commissioner of Public Works.

Laundrigs shall be charged from eight to twenty dollars per annum, in the discretion of the Commissioner of Public Works.

Liquor and Lager Beer Saloons shall be charged an annual rate of ten dollars each. An additional charge of five dollars per annum shall be made for each tap or wash-box.

PHOTOGRAPH GALLERIES shall be charged an annual rate of from five to twenty dollars, in the discretion of the Commissioner of Public Works.

PRINTING OFFICES, when not metered, shall be charged at such rates as may be determined by the Commissioner of Public Works.

Soda, Mineral Water and Root Beer Fountains shall be charged five dollars per annum each.

Steam Engines, where not metered, shall be charged by the horse-power, as follows: For each horse-power up to and not exceeding ten, the sum of ten dollars per annum; for each exceeding ten, and not over fifteen, the sum of seven dollars and fifty cents each and for each horse-power over fifteen, the sum of five dollars.

WATER-CLOSETS AND URINALS.—To each building on a lot one water-closet having sewer connection is allowed without charge; each additional water-closet or urinal will be charged as hereinafter stated. All closets connected in any manner with sewer shall be charged two dollars for each seat per annum, whether in a building or on any other portion of the premises. Urinals shall be charged two dollars per annum each. WATER-CLOSET RATES.—For hoppers of any form, when water is supplied direct from the Croton supply, through any form of the so-called single or double valves, hopper-cocks, stop-cocks, self-closing cocks, or any valve or cock of any description attached to the closet, each, per year, twenty dollars.

For any pan closet, or any of the forms of valve, plunger, or other water-closet not before mentioned, supplied with water as above described, per year, ten dollars.

For any form of hopper or water-closet, supplied from any of the forms of waste-preventing cisterns, that are approved by the Engineer of the Croton Aqueduct, which are so constructed that not more than three gallons of water can be drawn at each lift of the handle, or depression of the seat, if such cisterns are provided with an overflow pipe, such overflow pipe must not connect with the water-closet, but be carried like a safe-waste, as provided by the Board of Health regulations, per year, two dollars.

Cistern answering this description can be seen at this Department.

METERS.

Under the provisions of section 352, Consolidated Act 1882, water-meters, of approved pattern, shall be hereafter placed on the pipes supplying all stores, workshops, hotels, manufactories, public edifices, at wharves, ferry-houses, stables, and in all places where water is furnished for business consumption, except private dwellings.

It is provided by section 352, Laws of 1882, that "all expenses of meters, their connections and setting, water rates, and other lawful charges for the supply of Croton water, shall be a lien upon the premises where such water is supplied, as now provided by law." * *

All manufacturing and other business requiring a large supply of water will be fitted with a meter.

The rate charged for steam-vessels taking water daily or belonging to daily lines, is one-half cent, per ton (Custom House measurement) for each time they take water. Steamers taking water other than daily, one cent per ton (Custom House measurement).

Water supplied to sailing vessels and put on board, twenty-five cents per hundred gallons.

All matters not hereinbefore embraced are reserved for special contract by and with the Commissioner of Public Works

HYDRANTS, HOSE, TROUGHS, FOUNTAINS, ETC., ETC.

No owner or tenant will be allowed to supply water to another person or persons.

All persons taking water from the City must keep their own service-pipes, street tap, and all fixtures connected therewith, in good repair, protected from frost, at their own risk and expense, and shall prevent all waste of water.

of water.

The use of hose to wash coaches, omnibuses, wagons, railway cars or other vehicles or horses, cannot ne per-

railway cars or other vehicles or horses, cannot be permitted.

No horse-troughs or norse-watering fixtures will be permitted in the street or on the sidewalk, except upon a license or permit taken out for that purpose. All licenses or permits must be annually renewed on the first of May. Such fixtures must be kept in good order and the water not allowed to drip or waste by overrunning the sidewalk or street, or to become dangerous in winter by freezing in and about such troughs or fixtures.

No hydrant will be permitted on the sidewalk or in the front area, and any hydrant standing in a yard or alley, attached to any dwelling or building, must not be left running when not in actual use, and if the drip or waste from such hydrant freezes and becomes dangerous in winter, the supply will be shut off in addition to the penalty of five dollars imposed.

Taps at wash-basins, water-closets, baths and urinals must not be left running, under the penalty of five dollars for each offense, which will be strictly enforced.

Fountains or jets in hotels, porter-houses, eating-salons, confectioreries or other buildings are strictly prohibited.

The use of hose for washing sidewalks, stoops, areas, house-fronts, vards, court-vards, gardens, and about

saioons, contectoreries or other buildings are strictly prohibited.

The use of hose for washing sidewalks, stoops, areas, house-fronts, yards, court-yards, gardens, and about stables, is prohibited. Where premises are provided with wells, special permits will be issued for the use of hose, in order that the police or inspectors of this department may understand that the permission is not for the use of Croton water.

Opening fire-hydrants to fill hand sprinklers or other vessels will not be allowed.

The penalty for a violation of any of the preceding rules and regulations will be five dollars for each offense, and if not paid when imposed will become a lien on the premises in like manner as all other charges for unpaid water rates.

PUBLIC NOTICE AS TO WATER RATES.

PUBLIC NOTICE IS HEREBY GIVEN THAT in compliance with the provisions of chapter 559, Laws of 1887, amending sections 350 and 921 of the New York City Consolidation Act of 1882, passed June 9, 1887, the following changes are made in charging and collecting water rents:

1st. All extra charges for water incurred from and alter
June 9, 1887, shall be treated, collected and returned in
arrears in the same manner as regular rents have heretofore been treated.

2d. In every building where a water meter or meters
are now, or shall hereafter be in use, the charge for water
by meter measurement shall be the only charge against
such building, or such part thereof as is supplied through
meter.

3d. The returns of arrears of water rents, including the year 1887, shall be made as heretofore on the confirmation of the tax levy by the Board of Aldermen, and shall include all charges and penalties of every nature.

4th. A penalty of five dollars (\$5) is hereby established, and will be imposed in each and every case where the rules and regulations of the Department prohibiting the use of water through hose, or in any other wasteful maner, are violated, and such penalties will be entered on the books of the Bureau against the respective buildings or property, and, if not collected, be returned in arrears in like manner as other charges for water.

5th. Charges for so-called extra water rents of every nature, imposed or incurred prior to June 9, 1881, will be canceled of record on the books of the Department.

NOTICE TO CROTON WATER CONSUMERS.

NUMEROUS APPLICATIONS HAVE BEEN made to this Department by citizens claiming reductions or rebates on bills for water supplied through meters, on the alleged ground of leakage caused by defective plumbing and worn-out service pipes, or by willful waste of water by tenants allowing the faucets to be turned on in full force in water-closets, sinks, etc., without the knowledge or consent of the owners of the premises.

out the knowledge or consent of the owners of the premises.

The main object of the use of water-meters is to enable this Department to detect and check the useless and unwarrantable waste of an element so valuable and essential to the health and comfort of all the citizens, and this object can only be accomplished by enforcing payment for the water wasted.

Under the law all charges for water supplied througn meters are a lien against the respective premises, and the law therefore holds the owner of the premises responsible for the amount of water used or wasted.

Notice is therefore typen to all householders that, in all turther applications for reduction of water rents, no allowance will be made on account of waste of water occurring through leaks, from defective service pipes or plumbing, or wasteful use of water by tenants or occupants of buildings, though such leakage or waste may have occurred without the knowledge or consent of the owners of the buildings.

House-owners are further notified that whenever their premises become vacant, and are likely to remain vacant, they must notify this Department in writing, and that unless this requirement is complied with no deductions in extra water rents will he allowed for any portion of one year.
