

The Office of Brooklyn Borough President Antonio Reynoso submits this annual report on the application, selection, and appointment process of community board members as required by the New York City Charter §82(17).



The New York City Charter gives the Borough President the responsibility of selecting community board members who are representative of Brooklyn’s 18 community districts. Community boards were created to give New York City burgesses a formal space to influence the policy making and decisions that shape their neighborhoods.

THE VISION

In appointing members, Borough President Antonio Reynoso looks beyond demographic data measured in the Census and outlined in the Charter to also prioritize diversity in employment sectors, housing types, and transportation modes. Borough President Reynoso believes that Brooklyn will be at its best when every voice is included. The Borough President remains committed to reaching constituents who have been traditionally under-represented on community boards such as youth and NYCHA residents. The Borough President is also working to increase representation of populations who are not formally counted in the Census such as Brooklyn residents who identify as non-binary, and smaller populations of immigrants from Sub-Saharan Africa, the Middle East and North Africa, South Asia and the Caribbean. Ideally, Brooklyn Community Boards will function as microcosms of the experiences, life stages, and diverse cultures across the borough.



SWEARING-IN AND ORIENTATION 2024

Borough President Reynoso views the Charter-mandated responsibility for community boards not just as an obligation, but a mission to build an equitable borough. The Borough President is steadfast in the belief that Brooklyn will be even better when every interest and every group participates in policy making. The 2024 outreach campaign proclaimed, “Your Voice Matters”, making it clear that community boards are a forum for all regardless of opinions, origins, education attainment, or profession. The goal is to seek residents from a variety of experience to enhance community boards and create a Brooklyn for all.



2024 APPOINTMENTS

Brooklyn's 18 community boards are each comprised of 50 members who live, work or have significant interest in their respective districts. Outreach efforts resulted in a pool of 1,042 applicants. From this applicant pool, 238 are now first-time appointees, and 281 previous members were reappointed. While there was a 2% decrease in the number of applications, the volume was more dispersed with only two boards receiving less than 40 applications. At the end of the appointment cycle there were six vacancies.

THE APPLICATION AND APPOINTMENT PROCESS

The Brooklyn Community Boards application became available on the Borough President's website on November 15, 2023, signaling the start of the 2024 open period. Applications were accepted via the online portal, mail, or hand delivery to Borough Hall until the extended deadline of February 22, 2024. The application consisted of standard identifying information, involvement with community organizations, and interest statements. For the first time, proof of eligibility was required for those whose affiliation was based on significant interest.

Using a standard rubric, new applicants were invited to interview with the Borough President's community board liaisons to discuss their community involvement, the role of community boards, and the skills, interests, and experiences applicants can bring to broaden district representation.

Reapplicants who attended less than half of their general board meetings were also interviewed, as regular attendance is mandatory. The interview sought to determine the member's commitment, barriers to attendance and capacity to continue serving.

Community board liaisons interviewed and rated the applicants based on submitted applications, interview scores and demographic characteristics. Liaisons consulted the Department of City Planning's Community District Profiles, and existing member profiles to prioritize district diversity in the appointment process. Maps were created to show existing member addresses to promote geographic inclusivity. The Borough President reviewed applicant information presented by staff, reapplicant attendance records, and Council Member recommendations before selecting the new cohort. The cohort was advised of their appointment on April 25, 2024.



THE IMPACT OF REDISTRICTING

Census 2020 recorded a shift in New York City population resulting in changes to electoral district lines and the loss of one council seat in Brooklyn. The Department of City Planning provided the Borough President with a formula to calculate new seat allocations for the council districts. Some board compositions were markedly changed with council districts losing upwards of 40% of their previous allocations.

Early in the process, council members were provided with a draft roster highlighting the seat allocation changes and the number of current vacancies as well as a spreadsheet illustrating the board's demographic makeup. In some instances, the Borough President absorbed members who were redistricted, in other cases the affected members' appointments were revoked. Council members were also given restricted access to the application database to assist with the recommendation process.

PUBLIC OUTREACH

In November, staff distributed flyers to almost 300 organizations that participated in the Borough President's Thanksgiving food distribution. The general outreach was supplemented by the Borough President's Community Affairs team distributing flyers to non-profit organizations and pedestrians in neighborhoods with historically low application numbers.

From January 20 – February 20, every LinkNYC kiosk in Brooklyn broadcasted notice of the applications throughout the borough. A robust email campaign reached 158 Brooklyn groups that included business improvement districts, and cultural and service organizations. Repeat emails were also sent to 174 NYCHA tenant associations. The office was able to

rely on our growing relationships with 13 colleges, which used their communication networks to disseminate the information to over 15,000 recipients.

Borough Hall also partnered with Brooklyn Public Library to conduct outreach during the branches' busiest periods at 12 local libraries. The Brooklyn Public Library also heavily promoted the campaign over several weeks on social media and carried community board pamphlets at library branches in communities across the borough. Staff conducted virtual workshops with community groups along with presentations to precinct councils, disability organizations, and trade unions representatives to spread the word.

Council members, state and assembly members, and community boards' district offices were asked to include notice of the application period in their newsletters to their constituencies. Borough President Reynoso used his platform on Brooklyn News 12's monthly "Ask the BP" television program to promote civic engagement and community board involvement. The Borough President engaged with Brooklynites through Facebook and Instagram, and dedicated a special edition of an e-newsletter to community boards. A printed version of this newsletter was sent to more than 100,000 persons.

EXISTING MEMBERS OUTREACH

Beginning in October, Borough Hall liaisons actively reminded members at monthly board meetings of the open application period, and those with expiring terms needed to submit a new application to be considered for reappointment. Existing members also received two (2) personalized letters informing them of the need to reapply. Approximately one (1) week prior to the application deadline, district managers were asked to contact the members who had not applied.


DEMOGRAPHIC REVIEW

AGE


AGE [ALL MEMBERS BY BOARD 2024]



Our boards continue to skew older than the districts and the Borough. In 2024, 85 (or 36%) of new appointees are under 40, comprising 10% of all members. This is compared to 12% in 2023.


AGE [COMPARISON 2023-2024]

In 2024, 305 (34%) of all members are 60 or older, with CBs 13, 10 and 15, having half or more members aged 60 or older. CB 6 with 26 (52%) of members under 40 has the youngest cohort of members, followed by CB 7 (42%) and CB 9 (40%). Persons under 40 comprise 244 (27%) of the entire Brooklyn community boards membership.




GENDER

GENDER [ALL MEMBERS BY BOARD 2024]



There are 97 (41.5%) first time appointees who identify as male, comprising 44.5% of the cohort and 42% of all members. Thirty more females (13%) are new appointees, resulting in a 1% increase over 2023 Membership.

GENDER [COMPARISON 2023-2024]




The 2020 Census records Brooklyn's population at 52% women and 48% men.

Some boards have a disproportionate male/female balance that cannot be accounted for by deducting persons who self-select as gender non-conforming. In relation to Census data, CB 16 has 21% more female members than males, while CB12 and CB15 have a 20% or greater imbalance favoring males. Community Board 18 has an almost even balance of male and female representation. The 2024 cohort shows a 4% increase in the number of new appointees who identify as female, comprising 53% (274) of the new class and 50% of the overall board membership: an increase of 1% from 2023.

EDUCATIONAL ATTAINMENT

EDUCATION [ALL MEMBERS BY BOARD 2024]

Community board members have significantly higher levels of education than that of the average Brooklyn resident. ACS data indicates 43% of residents 25 and older have Bachelors' degrees, however 63% of all board members have a Bachelors' degree or higher, including 68% of new appointees with tertiary level education. Less than 1% of members are trade certified.

EMPLOYMENT

EMPLOYMENT [ALL MEMBERS BY BOARD 2024]


Applicants were able to choose multiple categories, and many did so, showcasing the multifaceted nature of residents' employment. Business owners and freelancers comprise 30% of all board members. Government employees are 20% of all board members, with New York City employees accounting for 15% of the group. Private sector employees and retirees are 16%. First-time appointees represent the non-profit sector at 22%, business owners and self-employed/freelancers account for 20% each. Census data identified 14% of Brooklyn residents as municipal or government employees; self-employed at 11%; private sector employees are 62%.



HOUSING


HOUSING [ALL MEMBERS BY BOARD 2024]

Rates of ownership are reflected in the housing typology of each district. For example, Census data shows that CB 18 has the highest home ownership rates in Brooklyn and 80% of all board members own a house, co-op or condo. CBs 9 and 4 have the most renters at 56% and 50%. Sixty-two new appointees (12%) live in rent-regulated housing as does 125 or (14%) of all board members. NYCHA residents are under-represented on all boards at 2% of overall membership.



HOUSING COMPARISON 2023-2024


Brooklyn residents dwell in housing types as diverse as the borough; from homeowners in 1-3 family houses, condo and co-op units, to market rate and subsidized rental homes. Homeowners are 42% of new appointees, 51% of all members. Census records show Brooklyn homeownership at 30%.



RACE AND ETHNICITY


RACE AND ETHNICITY [ALL MEMBERS BY BOARD 2024]

Brooklyn is well known as a place where many races, languages, and cultures meet. Currently, the Census data combines unique populations as a single category. For example, Middle Eastern-North Africans (MENA) are categorized as European/White, and Sub-Saharan Africans are counted as African-American/Black. However, Borough President Reynoso asserts that smaller populations present in significant numbers need to be singularly identified and included on the community boards.



RACE AND ETHNICITY COMPARISON 2023-2024


The largest sub-population are persons of Caribbean/West Indian and Caribbean Hispanic ancestry who account for 17% of Brooklyn's population and are represented by 14% of community board members. Middle Eastern-North Africans and South Asian demographic categories are also equitably represented.



TRANSPORTATION

TRANSPORTATION [ALL MEMBERS BY BOARD 2024]

New York City continues to invest in its extensive multi-modal transportation network, which allows its residents to drive, walk, bike, use public transportation or any modal combination to commute for work or leisure. Our community board members represent every user type. The analysis of all board members shows that almost every member uses more than one transportation option.





A vast majority of members rely on public transportation for most of their commuting needs. First-time appointees (33%) travel frequently by bus, and 55% commute regularly on the subway system. Among all members, Community Board 2 has the highest usage of public transportation (80%); followed by CB 9 (74%), the next closest is CB 7 (61%). An average 8% of all members always avoid public transportation. Districts with the highest public transportation usage also lead the pedestrian category CB 2 (60%) and CB 9 (52%). CBs 6, 10 and 15 are also boards with a high percentage of frequent walkers (50%). Brooklyn-wide, 41% of members walk as a primary transportation modality.

TRANSPORTATION


TRANSPORTATION [ALL MEMBERS BY BOARD 2024]

Comparatively 37% of the first-time members frequently travel by personal vehicle versus 27% of all members. For-hire services are utilized by 17% of the new appointees versus 8% of all members. Access-a-Ride service or mobility scooter is used by 3% of all members. ACS data indicates 46% of Brooklyn residents use public transportation and 22% travel by private vehicle to and from work.




OTHER MEMBER CHARACTERISTICS

MEMBER CHARACTERISTICS [ALL MEMBERS BY BOARD 2024]



ACS data estimates 35% of Brooklyn’s residents were born outside of the United States, reflecting the 44% who speak another language at home. Of the newly appointed board members, 16% identified as immigrants and 6% as non-native English speakers. The 2024 Community District Profiles (DCP) show that 13% of all community board members are immigrants and 5% are non-native English speakers. Four percent of all members (38) selected LGBTQ+ as an additional identification factor.




OTHER MEMBER CHARACTERISTICS

Parents of minor children account for 18% of all members, providing their boards with some insight into the needs of younger residents. This is almost on par with the census data showing 22% of Brooklynites are parents of children under 18. Persons with disabilities are 8% of community board members who self-identify a physical, visual, aural, emotional, and/or other condition.

CONCLUSION

Borough President Reynoso views the Charter-mandated responsibility for community boards not just as an obligation, but a mission to build an equitable borough. The Borough President is steadfast in his belief that Brooklyn will be even better when every interest and every group participates in policy making. The 2024 outreach campaign proclaimed, “Your Voice Matters,” making it clear that community boards are a forum for all regardless of age, opinions, origins, education attainment, or profession.

This year’s success can be measured in the increase of applications in neighborhoods with historically low application numbers, however, there is still much work to enhance the composition of Brooklyn Community Board. Borough President Reynoso is actively striving to enhance the composition of the boards by increasing representation of residents under 40, especially those aged 16-18, and bolstering the diversity of work experiences.
