GENERAL PROVISIONS

Chapter 2 **Construction of Language and Definitions**

DEFINITIONS

Words in the text or tables of this Resolution which are #italicized# shall be interpreted in accordance with the provisions set forth in this Section.

Floor area

"Floor area" is the sum of the gross areas of the several floors of a #building# or #buildings#, measured from the exterior faces of exterior walls or from the center lines of walls separating two #buildings#. In particular, #floor area# includes:

- 443. #basement# space, except as specifically excluded in this definition;
 - elevator shafts or stairwells at each floor; , except as specifically excluded in this definition;

However, the #floor area# of a #building# shall not include:

(11) floor space within stairwells

- at each floor of #buildings# containing #residences# #developed# or #enlarged# after April 16, 2008, that are greater than 125 feet in height, provided that:
- (1) such stairwells are located on a #story# containing
- (2) such stairwells are used as a required means of egress from such #residences#:
 - (iii) (3) such stairwells have a minimum width of 44 inches;
 - (iv) (4) such floor space excluded from #floor area# shall be limited to a maximum of eight inches of stair and landing width measured along the length of the stairwell enclosure at each floor; and
 - where such stairwells serve non-#residential uses# on (v) (5)any floor, or are located within multi-level #dwelling units#, the entire floor space within such stairwells on such floors shall count as #floor area#;
- at each floor of #buildings# #developed# or #enlarged# after (date of amendment), that are 420 feet or greater in height, provided
 - such stairwells serve a space that is any occupancy group other than Group R-2, as classified in the New York City Building Code, that is located at or above a height of 420 feet; and
 - 2. such floor space excluded from #floor area# shall be limited to:
 - the 25 percent of stair and landing width required by the New York City Building Code which is provided in addition to the stair and landing widths required by such Code for means of
 - the one stairwell required by the New York City Building Code which is provided in addition to the stairwells required by such Code for means of egress. For the purposes of this paragraph (11) (ii)(2)(bb), such additional stairwell shall include the stair and <u>landings as well as any walls enclosing such stair and landings;</u>
 - exterior wall thickness, up to eight inches: (12)

Notice of Promulgation of Final Rule

NOTICE IS HEREBY GIVEN PURSUANT TO THE AUTHORITY VESTED in the Environmental Control Board (ECB) in accordance with Sections 1043 and 1049-a of the New York City Charter and Sections 19-144 and 19-150 of the New York City Administrative Code. The ECB has amended its Department of Transportation (DOT) Penalty Schedule. This schedule is found in Section 3-124 of Subchapter G of Chapter 3 of Title 48 of the Rules of the City of New York. It contains penalties for notices of violation issued by the New York City Department of Transportation (DOT). The rule was published in The City Record on November 25, 2014 and a public hearing was held on December 29, 2014.

Statement of Basis and Purpose of Final Rule

The Environmental Control Board ("ECB") has amended its Department of Transportation (DOT) Penalty Schedule, codified in Section 3-124 of Title 48 of the Rules of the City of New York. In an effort to support Mayor de Blasio's Small Business First initiative and set penalties that are reasonable in relation to the violations cited, at DOT's request ECB has:

- lowered the penalty for failure to obtain a confirmation number for a street opening permit on a protected street, and
- added a separate penalty for failure to obtain a confirmation number two hours prior to the commencement of a backfill on a protected street.

This amendment and the additional charge will clarify the difference between a respondent's failure to notify the department prior to commencing a backfill on a protected street versus a respondent's failure to obtain a confirmation number for any street opening permit on a protected street. They will also ensure that the penalty is proportionate to the violating condition cited, and will promote consistency within DOT's fine structure by setting similar penalties for similar offenses.

The ECB held a public hearing on December 29, 2014 regarding amendments to its Department of Transportation (DOT) Penalty Schedule found in Section 3-124 of Subchapter G of Chapter 3 of Title 48 of the Rules of the City of New York. Two representatives of DOT attended the public hearing. No members of the public attended the public hearing. ECB received one written comment on the proposed rule regarding amendments to its DOT Penalty Schedule.

Fine Decrease for 34 RCNY \S 2-11(f)(2)(ii). Failure to obtain a confirmation number for a street opening permit on a protected street.

In June 2013, 34 RCNY § 2-11(f)(2) of the Highway Rules was

amended to require all permittees who have obtained a street opening permit on a protected street to also obtain a confirmation number. The purpose of this amendment was to clarify that a confirmation number is required for all such permits on protected streets regardless of whether a permittee engages in a backfill. As an unintended consequence of the rule change, permittees who fail to obtain a confirmation number but whose work does not involve a backfill or impact the roadway currently receive the same penalty as permittees who fail to obtain a confirmation number before performing a backfill in the roadway. Therefore, ECB has reduced the penalty for failing to obtain a confirmation number for a street opening permit on a protected street, where the permittee is not engaging in backfill, from \$750 to \$250 with a default penalty of \$750.

New Code Request for 34 RCNY \S 2-11(f)(4)(i). Failure to obtain a confirmation number two hours prior to the commencement of a backfill on a protected street.

When a permittee conducts a backfill without a confirmation number, it impacts DOT's ability to conduct appropriate oversight of the construction activity taking place. Therefore, this charge imposes a penalty if a permittee fails to obtain such confirmation number at least two hours prior to the scheduled start time for the backfill, except as otherwise authorized by the Commissioner. The new charge, "Failing to obtain a confirmation number on a protected street two hours prior to the commencement of a backfill," carries a penalty of \$750 with a default penalty of \$2,250.

NOTICE IS HEREBY GIVEN PURSUANT TO THE AUTHORITY VESTED in the Environmental Control Board (ECB) in accordance with Sections 1049-a and 1043 of the New York City Charter and Chapter 14 of Title 17 of the Administrative Code. The ECB has amended its Department of Buildings (DOB) Penalty Schedule. The

DOB Penalty Schedule is found in Section 3-103 of Subchapter G of Chapter 3 of Title 48 of the Rules of the City of New York. It contains penalties for notices of violation issued by the New York City DOB. The rule was published in The City Record on November 25, 2014 and a public hearing was held on December 29, 2014.

Statement of Basis and Purpose of Final Rule

The New York City Environmental Control Board has modified the ECB Buildings Penalty Schedule to enforce Local Law 141 of 2013 (LL 141), also known as the 2014 NYC Construction Code update.

The ECB held a public hearing on December 29, 2014 regarding amendments to its Department of Buildings Penalty Schedule found in Section 3-103 of Subchapter G of Chapter 3 of Title 48 of the Rules of the City of New York. Two representatives from the NYC Department of Transportation ("DOT") attended the December 29, 2014 Public Hearing that also addressed an ECB proposed rule concerning amendments to ECB's DOT Penalty Schedule. Neither written comments nor oral testimony were presented at the December 29, 2014 public hearing concerning the Proposed Rule regarding amendments to ECB's DOB Penalty Schedule.

LL 141, effective December 31, 2014, amends the Administrative Code of the City of New York, the New York City Plumbing Code, the New York City Building Code, the New York City Mechanical Code and the New York City Fuel Gas Code and brings these codes up to date with the 2009 editions of the International Building, Mechanical, Fuel Gas and Plumbing Codes.

LL 141 amended some requirements, added new requirements and renumbered existing sections of these codes. The penalty schedule is amended to reflect these changes. The rule amends the penalty schedule by:

- updating sections of the Administrative Code,
- updating descriptions to the table of classifications,
- deleting some existing violations that no longer apply or could be combined with existing descriptions, and
- · adding new violations and their classifications.

Penalty amounts for all existing infractions remain unchanged. All penalties fall within the guidelines for all classes of violations, as stated in Section 28-202.1. The statutory maximum for each class of violation is:

Class 3 -\$500,

Class 2 - \$10,000, and

Class 1 - \$25,000.

New violations that are not immediately hazardous (Class 1) are indicated as curable in the penalty schedule.

NOTICE IS HEREBY GIVEN PURSUANT TO THE AUTHORITY VESTED in the Environmental Control Board (ECB) in accordance with Sections 1043 and 1049-a of the New York City Charter and Sections 19-190 and 19-191 of the New York City Administrative Code, that the ECB has amended its Department of Transportation (DOT) Penalty Schedule. This schedule is found in Section 3-124 of Subchapter G of Chapter 3 of Title 48 of the Rules of the City of New York. It contains penalties for violations of provisions of Titles 10 and 19 of the New York City Administrative Code and Title 34 of the Rules of the City of New York that are heard and decided by ECB. The rule was published in The City Record on December 5, 2014 and a public hearing was held on January 6, 2015.

Statement of Basis and Purpose of Final Rule

On February 18, 2014, Mayor de Blasio launched the Vision Zero action plan – an ambitious plan to reduce traffic fatalities in New York City. Vision Zero accepts no traffic fatality as inevitable. Vision Zero allows government agencies, industry groups, key transportation stakeholders and the public to understand traffic crashes as the result of a series of actions that can be changed or prevented through enforcement, education and design. As part of Mayor de Blasio's Vision Zero Action Plan, several pieces of legislation have been enacted that are intended to reduce fatalities resulting from motor vehicle accidents. Among this legislation are two new laws, Local Law No. 29 and Local Law No. 50 of 2014, which establish civil penalties for certain traffic-related offenses, and which provide for adjudication by the Environmental Control Board. This rule amends ECB's DOT Penalty Schedule to implement these new laws.

The ECB held a public hearing on January 6, 2015 regarding amendments to its Department of Transportation Penalty Schedule found in Section 3-124 of Subchapter G of Chapter 3 of Title 48 of the Rules of the City of New York. A representative from the NYC Police Department attended the January 6, 2015 public hearing. Neither written comments nor oral testimony were presented at the January 6, 2015 public hearing.

Section One: Right of Way

Local Law No. 29 of 2014 added a new Section 19-190 to the Administrative Code, entitled "Right of way." Subdivision (a) provides that if a motor vehicle driver fails to yield to a pedestrian or bicyclist who has the right of way, the driver shall be subject to a civil penalty of not more than \$100, in addition to or as an alternative to the

penalties that can be imposed for committing a traffic infraction as provided in the law. Subdivision (b) of Section 19-190 provides that if a driver violates subdivision (a) and the vehicle causes contact with the pedestrian or bicyclist, and thereby causes physical injury, the driver shall be subject to a civil penalty of not more than \$250, in addition to or as an alternative to the penalties that can be imposed for committing a misdemeanor as provided in the law.

Section Two: Civil Penalties for Leaving the Scene of an Incident without Reporting

Local Law No. 50 of 2014 added a new Section 19-191 to the Administrative Code, entitled "Civil penalties for leaving the scene of an incident without reporting." The civil penalties contemplated by the law relate to a violation of Vehicle and Traffic Law Section 600, which obligates motor vehicle operators, who know or have cause to know that property damage or personal injury has been caused due to an incident involving their vehicle, to stop and share their identifying information with the person sustaining the damage or injury and/or with a police officer, the nearest police station, or a judicial officer, as applicable.

Administrative Code Section 19-191 sets forth four levels of civil penalties associated with a motor vehicle operator's failure to comply with Vehicle and Traffic Law Section 600, as follows:

- If an incident involves property damage, the operator is liable for a civil penalty of not more than \$500;
- If an incident involves physical injury, the operator is liable for a civil penalty of not less than \$1,000 and not more than \$2,000;
- Notwithstanding the limits on civil penalties where an incident involves physical injury, if an incident involves serious physical injury, the operator is liable for a civil penalty of not less than \$2,000 and not more than \$10,000; and
- Notwithstanding the limits on civil penalties where an incident involves physical injury, if an incident involves death, the operator is liable for a civil penalty of not less than \$5,000 and not more than \$10,000.

Penalties

The default penalties for these sections are the maximum penalty amounts pursuant to the respective sections.

The rule adds six new entries to the Department of Transportation Penalty Schedule in Section 3-124 of Subchapter G of Chapter 3 of Title 48 of the Rules of the City of New York (RCNY), setting forth

civil penalties for the enforcement of Sections 19-190 and 19-191 of the Administrative Code. In recognition of the seriousness of the offenses articulated by these two new laws, no cure periods are provided and the civil penalties are set at the maximum authorized by Local Law Nos. 29 and 50, respectively.

ECB's authority for these rules is found in Sections 1043 and 1049-a of the New York City Charter and Sections 19-190 and 19-191 of the New York City Administrative Code.

The Taxi and Limousine Commission (TLC) is proposing a rule change so that owners of Unrestricted Medallions who choose to purchase an accessible vehicle, or are required to do so under TLC rules, can obtain a one-time waiver allowing them to purchase an approved accessible vehicle that is not the Accessible Official Taxicab Vehicle (AOTV). The City's contract with the Official Taxicab Vehicles (OTV) vendor provides for 496 exemptions from the AOTV requirement for Unrestricted Medallions.

When and where is the Hearing? The Commission will hold a public hearing on the proposed rule. The public hearing will take place at 10:00 A.M. on March 19, 2015. The hearing will be in the hearing room at 33 Beaver Street – 19th Floor, New York, NY 10004.

Where can I find the Commission's rules? The Commission's rules are in title 35 of the Rules of the City of New York.

What rules govern the rulemaking process? The Commission must meet the requirements of Section 1043 of the City Charter when creating or changing rules. This notice is made according to the requirements of Section 1043(b) of the City Charter.

Statement of Basis and Purpose of Proposed Rules

The Official Taxicab Vehicle activation date is April 20, 2015, as of which Unrestricted Medallion owners may only hack up an OTV, an AOTV or a hybrid vehicle that meets TLC specifications. The City's contract with the OTV vendor provides a waiver for up to 496 Unrestricted Medallion owners to buy an approved accessible vehicle other than the AOTV if they wish to or need to purchase an accessible taxi vehicle. The proposed rule provides a process for Unrestricted Medallion owners to apply to the Chairperson for such waivers. Exemption applications will be handled on a first come, first served basis. Only Unrestricted Medallion owners whose vehicles are nearing the vehicle retirement date and who are in good standing (license is current, not suspended, and no fines owed) with the Commission may apply. The waiver is valid for a one time use only.

These rules are authorized by Section 2303 of the Charter and Sections 19-503 of the Administrative Code of the City of New York.

- (b) On or after the OTV Activation Date, an Unrestricted Medallion can be Hacked-up ONLY with
 - (1) the Official Taxicab Vehicle designated by the Commission under this section; or
 - (2) After the OTV Activation Date, a medallion issued prior to January 1, 2012 that was not restricted when issued can be used with an OTV or an AOTV. If at any time after the OTV Activation Date such medallion is restricted by law or rule of the Commission to use with an Accessible Vehicle, the owner of such medallion must purchase an AOTV or lease such medallion for use with an AOTV. Provided, however, that with the Chairperson's approval and in accordance with paragraph (3) herein, up to 496 Unrestricted Medallion owners in good standing may at any time purchase for Hackup any accessible vehicle which meets the accessible vehicle specifications set forth in Rule 67-05.2, or lease their medallions for use with such a vehicle.
 - (3) Any Unrestricted Medallion owner in good standing who wants to purchase for Hack-up an accessible vehicle that is not an AOTV but that meets the accessible vehicle specifications set forth in Rule 67-05.2 may apply for a one-time waiver of the requirement set forth in paragraph (2) of this subdivision. Such application must be made on a form and in accordance with instructions that will be made available on the TLC's Web site. The application must be received by the TLC no less than 120 days prior to the medallion owner's vehicle retirement date, and no more than

150 days prior to such retirement date. The waiver is non-transferable, and expires if not presented at hack-up.

Name, Description, and Location of Proposal:

341 Canal Street

This Revised Negative Declaration supersedes the Negative Declaration issued on October 29, 2007, and reflects the new owner's request for a modification to the original, approved special permit. The modified application (ULURP No. M070161(A) ZSM) was submitted on January 7, 2015, prior to the expiration of the approved special permit, together with an application for renewal of the approved special permit (ULURP No. N120207CMM).

In 2007, the prior applicant, Judo Associates, sought a special permit pursuant to Zoning Resolution section 74-712 to modify use regulations in a mixed-use building to be constructed at 341 Canal Street (Block 229, Lot 1) in the SoHo-Cast Iron Historic District in Manhattan Community District 2. For the purposes of a conservative analysis, it was assumed that the special permit would facilitate a proposal by the applicant to construct a seven-story, 66,170-gross square foot (gsf), mixed-use containing 32 dwelling units and 23,108 gsf of commercial uses on the ground floor. An Environmental Assessment Statement (EAS) was issued on October 24, 2007 and a Negative Declaration was issued on October 29, 2007. The special permit was approved by the New York City Planning Commission (CPC) on February 13, 2008. Since 2008, the approved special permit has lapsed; the proposed building in connection with the prior approval has not yet been constructed and the property at 341 Canal Street is currently utilized as parking. The property has also changed ownership, and the applicant for the modification is 11 Greene Street, LLC (the former owner and applicant was Judo Associates).

The applicant, 11 Greene Street, LLC, is proposing a modification to the original, approved special permit. The modified application includes: recessing the windows of the building at 341 Canal Street along its Greene Street façade by approximately 1'-10," aligning the proposed building with an existing building to the north, and lowering the building's cornice line by approximately 1'-0," as requested by the Landmarks Preservation Commission (LPC); and relocating floor area lost in adjustments made to the building per LPC to fill the area of a previously approved interior airshaft. The overall size of the proposed building (total zoning floor area) is expected to remain unchanged. The proposal also involves a change to the previous analysis year from 2008 to 2016.

It was found that the modified special permit does not alter the conclusions of the Environmental Assessment Statement dated October 24, 2007, prepared in connection with the proposed project, and is thus not expected result in significant adverse impacts.

Statement of No Significant Effect:

The Environmental Assessment and Review Division of the Department of City Planning, on behalf of the City Planning Commission, has completed its technical review of the Environmental Assessment Statement, dated October 24, 2007, and a Memorandum to the Project File dated January 30, 2015, prepared in connection with the ULURP Application (ULURP Nos. C070161ZSM, and M070161(A) ZSM, N120207CMM). The City Planning Commission has determined that the proposed action will have no significant effect on the quality of the environment.

Supporting Statement:

The above determination is based on an environmental assessment which finds that:

1. The former applicant, Judo Associates, previously requested a special permit pursuant to Zoning Resolution section 74-712 to modify use regulations of a mixed-use building to be constructed at 241 Canal Street (Pleak 220 Let 1) in the S. H. Const. at 341 Canal Street (Block 229, Lot 1) in the SoHo-Cast Iron Historic District in Manhattan Community District 2. Provisions were incorporated into the 2007 special permit in order to ensure that no significant adverse impacts related to noise and hazardous materials would occur. To avoid the potential for significant adverse noise impacts, the original project design was expected to incorporate double-glazed windows and central air conditioning, which would provide 35 dB(A) of window-wall attenuation, in order to maintain an interior noise environment of 45 dBA. Consistent with the original application, the site plan included in the modified proposal's ULURP application indicates 35 dB(A) of window-wall attenuation. The original, approved action also included a restrictive declaration (as referenced in R-124 in Table 2, Appendix C of the New York City Zoning Resolution) to ensure that significant adverse impacts related to hazardous materials would not occur. The restrictive declaration remains in effect and binds the applicant, 11 Greene Street, LLC, to prepare a hazardous materials sampling protocol including a health and safety plan. With these provisions in place, no significant adverse impacts related to hazardous materials and noise would be expected to result from the proposed actions.

¹ This Revised Negative Declaration addresses the applicant's request for a minor modification to a special permit and renewal of such permit.

Topics for Public Hearing on Licensing FHV Dispatch Apps

For the last several years, for-hire vehicle (FHV) bases have used web-based systems/smartphone apps to connect passengers to FHVs. This practice has grown significantly in recent years. Today approximately 13% of FHV bases use a dispatch app to connect tens of thousands of passengers each day to available TLC-licensed FHV drivers.

Section 19-511 of the Administrative Code grants the TLC the authority to license communications systems used to dispatch or to convey information to drivers. On January 29, 2015 the Taxi and Limousine Commission passed a set of rules to license and regulate the apps that allow passengers to connect to yellow taxis and green Boro Taxis using their smartphones (known as "E-Hailing"). TLC is now developing a set of proposed rules to license and regulate FHV dispatch apps that will mirror the recently-passed rules governing yellow and Boro Taxi E-hail apps on key consumer protection and safety items. Additionally, the rules will address the unique circumstances of dispatching by app in the FHV segment of the industry by holding app companies accountable for complying with core TLC requirements on accountability and dispatching behavior. Through these rules TLC seeks to promote innovation, consumer protection, accountability, and safety for the public. The key items TLC is considering with respect to proposed rules governing FHV dispatch apps are:

- License Structure Today some FHV dispatch apps work with several bases via agreements and do not hold a TLC FHV base license. Others hold FHV base licenses and work only through their licensed bases. Proposed FHV App licensing rules will formalize this practice and only allow FHV drivers to accept appbased dispatches through a TLC licensed FHV App or through a TLC licensed base under the same terms of use as a TLC licensed FHV dispatching app.
- 2. Access to Drivers Rules surrounding what group of drivers a TLC licensed FHV App can dispatch and what group of drivers a TLC licensed base can dispatch.
- Refusals The circumstances in which a cancellation of an accepted FHV app dispatch trip would be considered a service refusal
- Accessibility –Requirements surrounding apps' making wheelchair accessible options available.
- Minimizing Driver Distraction Rules surrounding the number of permitted devices, device lock-down features, voice activation and other elements that impact a driver's ability to pay attention to driving.
- Privacy and Security The requirements surrounding the collection, storage, and use of passenger data.
- 7. **Trip Records** The rules surrounding the creation, preservation, and transmission of accurate trip records for trips that were booked using a dispatch app.
- 8. **Price Transparency** Rules surrounding passenger notification of what a ride will cost prior to booking, including how passengers are notified of dynamic or "surge" pricing, and how FHV dispatch apps that work with liveries will provide a binding fare quote.
- 9. **App and Base Accountability** Rules surrounding the information FHV dispatching apps must give passengers regarding the vehicle dispatched, its home base, and its dispatching base and rules governing consortiums of TLC licensed bases that dispatch through the same app.





