## NYC OFFICE OF EMERGENCY MANAGEMENT (OEM) HOSTSPODEX A MULTIAGENCY FIELD EXERCISE

The New York City Office of Emergency Management (OEM) today hosted PODEX, a major multi-agency field exercise focusing on the request for, receipt of and distribution of [Strategic National Stockpile assets] in response to a terrorist use of a biological weapon. Sponsored by the U.S. Department of Homeland Security's Office for Domestic Preparedness (ODP), PODEX was staged at four New York City Department of Education (DOE) facilities in the borough of Queens.

PODEX is part of the City's continuing efforts to test and refine its preparedness plans and emergency response protocols

Coordinated by OEM, the two day drill began yesterday with the City's health monitoring equipment testing positive for anthrax. Day one of PODEX involved the request of medical and non-medical supplies from the federal government, as well as their receipt at points of dispensing (POD) around the city. It also included the training of supervisory POD staff from the New York City Department of Health and Mental Hygiene (DOHMH). Day two of the exercise consisted of the setup of mock PODs for distribution of medications to affected individuals, as well as the related security, public information and transportation issues that would arise in such a circumstance.

"We are continually working to keep New York City the most prepared city in the country," said OEM Commissioner Joseph F. Bruno. "Exercises like PODEX allow us to evaluate both our decision making process and our operational plans."

"The Health Department uses state-of-the-art technology to perform laboratory testing and to monitor thousands of health events including emergency department visits and ambulance runs every day for any signs of a public health threat, natural or man-made," said Commissioner Frieden. "We've had more than our fair share of health emergencies in New York City. Every drill exercise is an opportunity to find ways to perform our job even better."

Some of the many challenges exercise participants faced were to simultaneously staff and manage multiple POD locations, handle unsolicited volunteers, serve special needs and non-English speaking populations, provide accurate information to the public and oversee operations from the City's Emergency Operations Center.

Designed to test the City's ability to provide medication to individuals affected by a biological attack, PODEX examined interagency coordination in accordance with the Citywide Incident Management System (CIMS), overall emergency response, the integration of federal, state and regional assets and the City's ability to protect the public.
