Spotlight on Safety

DEP's Emergency Planning Policy

DEP'S revised Emergency Planning Policy has been distributed Agency-wide and officially goes into effect February 21, 2017. The policy requires every regularly-staffed facility to have a written plan or program, even if there are fewer than 10 employees. All employees must be trained on the requirements of their facility's emergency plan.

The key changes to the revised Emergency Planning policy include the following additions:

- · active shooter emergency
- · shelter-in-place procedure

 a new template that can be used for facilities with 10 or fewer employees

The policy is part of DEP's efforts to ensure that DEP workers know what to do, where to go, and how to keep safe when an emergency occurs. Preparation for an emergency also includes having employees participate in evacuation drills, which help workers to become familiar with the hazards involved and learn how to properly and safely evacuate during an emergency.

Holiday Toy Drives



any thanks to everyone who donated to the holiday toy drives this year. Downstate, 590 toys were donated as part of the 8th annual Smiles of Love Gift Drive. Citywide, the Department of Youth and Community Development collected a record total of 3,002 gifts, a portion of which were distributed Saturday morning by Mayor Bill de Blasio at John S. Roberts Junior High in East Harlem. The remaining gifts were presented to kids at four other simultaneously held events, with the rest slated to be given out to other young people in need at Three Kings Day events in January. Upstate, in addition to all the wonderful toys and gifts collected, we also received \$225 worth of gift cards and \$325 in cash donations. Some of the cash was used to purchase more toys, while some of the money was given to Christmas Wishes Ulster County to help purchase items for families in need. Stormwater Project at Bronx HS

DEP is proudly assisting students at DeWitt Clinton High School in the Bronx as they create a stormwater swale using crushed toilets as bedding material. The green project, located in the teacher's parking lot near the school's Clinton Garden, is being done in conjunction with DEP's Education Office under the direction of Kim Estes-Fradis and Benjamin Huff from BEPA, who arranged for the toilet pieces. The crushed toilets are part of the more than 40,000 bathroom fixtures in hundreds of public school buildings throughout the city that are being updated as part of DEP's water conservation efforts. Earlier this year, DEP used porcelain harvested from nearly



6,500 inefficient recycled toilets as the basis for oyster beds installed in Jamaica Bay to help improve water quality and protect wetlands.

Rondout Bridges Replaced



The \$7 millon project to replace two small bridges at the upper end of Rondout Reservoir in Sullivan County has been successfully completed. The project included the replacement of the Sugarloaf Bridge and Lows Corners Bridge, which were constructed more than 60 years ago, at the same time as the reservoir. Work to replace both bridges began in May. DEP owns, operates and maintains 57 bridges and 99 miles of roads throughout its upstate water supply system. The 50-foot-long Sugarloaf Bridge carries Sundown Road over the Sugarloaf Brook. During the summer and fall, DEP installed a temporary bridge at the site to allow for the complete removal and replacement of the bridge, including its footings and deck. The 150-footlong Lows Corners Bridge carries Route 55A over Rondout Creek at the head of Rondout Reservoir. Workers replaced the superstructure of the bridge, and repairs were made to its piers. The concrete wing walls that guide water beneath the bridge were also replaced.

Volunteers Needed For Homeless Tally

On Monday, January 23, 2017, the Department of Homeless Services (DHS) will conduct its annual Homeless Outreach Population Estimate (HOPE) count, as part of an ongoing effort to engage NYC's street homeless individuals. Fellow New Yorkers are being asked to help canvass parks, subways, and other public spaces to estimate the number of people who are street homeless. Volunteers assist from approximately 10pm–4am. Just one night of your time will aid in collecting vital information for outreach teams to help homeless people move from the streets to a more stable, safe environment.
