

Report to the City Council pursuant to LL50 of 2011

Reporting Period: Fiscal Year 2021

For the FY 2021 reporting period, MOCS worked to improve upon the data collection process for the Local Law 50 report. In addition to gathering information on food related purchases from the City's Financial Management System, we reached out to all City agencies to independently confirm what, if any, food-related procurements agencies completed. This helped ensure that no potentially relevant procurements would be missed.

Survey Changes We sought to increase the number of survey responses we received from vendors by leveraging vendor contact information in the PASSPort system. Using those verified vendor details, we then issued the Local Law 50 survey asking vendors to provide the details of their food-related procurements with the City, including whether they procured their foods from New York State sources or elsewhere, what types of foods were procured, and whether they were procured in season or out of season. In addition, we stepped up our follow-up efforts with vendors to try and solicit as many survey responses as possible. Unfortunately, due to the ongoing COVID-19 pandemic, the survey itself was historically difficult for vendors to complete, especially nonprofit providers who are the majority of indirect food purchasers. The breadth of questions and data collection is vast, and providers do not typically track this data on an ongoing basis. We are looking forward to the FY 2022 report for possible changes to make this easier in the future. The above changes will be carried forward to future Local Law 50 Reports as we continue to identify and implement new efficiencies for the tracking of information relating to New York State food procured by City agencies and vendors.
