AQUEDUCT COMMISSION.

Minutes of Stated Meeting of the Aqueduct Commissioners, held at their office, No. 78 Tribune Building, Wednesday, January 14, 1885, at 3 o'clock P. M.

Commissioners present—The Mayor, the Comptroller, Commissioner of Public Works, Com-missioners James C. Spencer, William Dowd, and C. C. Baldwin; also, Chief Engineer Church, Executive Engineer Fteley, and Consulting Engineer Davis; also, Chief Engineer Birdsall and Consulting Engineer Adams of the Department of Public Works. The minutes of the Stated Meeting of January 7 were read and approved. The Committee of Finance and Audit reported the examination and audit of bills included in Vouchers Nos, 472 to 478, and, upon motion of Commissioner Dowd, the said vouchers were approved and ordered certified to the Comptroller for payment. The Committee also reported upon the application of George Lucas for an increase of com-pensation, and recommended that his salary as Stenographer, Type-writer and Engrossing Clerk of the Commissioners, be increased to the sum of sixteen hundred dollars per annum ; which recom-mendation was, on motion of Commissioner Dowd, approved by the Commissioners, the said increase to commence at this date.


