

At a meeting of the Board of Docks of the City of New Vork, held at the office of the Board, "A," Battery place, Thursday, November 9, 1893, at 11 o'clock A. M. Present—President Cram. Pier

Commissioner Phelan.

"Commissioner Phelan. ""White. The minutes of the meeting held on the 2d inst. were read and approved. On motion, the matter of the purchase of the property between One Hundred and First and One Hundred and Second streets, Harlem river, referred to Commissioners White and Phelan June 22, 1893, was referred to Commissioner Phelan. J. W. Miller, president of the Providence and Stonington Steamship Company, appeared and requested that his company be permitted to remain at Pier, old 29, North river, until December 1, 1802. Granted.

requested that his company be permuted to remain a series of the Board of Education, request-1893. Granted. The communication from Miles M. O'Brien, Commissioner of the Board of Education, request-ing permission to allow the school-ship "Saint Mary's" to remain at the Pier foot of East Twenty-eighth street until ready to sail, was referred to the Treasurer. The following communications were referred to the Engineer-in-Chief to examine and report : From the New York, Lake Erie and Western Railroad Company—Submitting plans and speci-fications for a proposed extension to the ferry-rack at Chambers street, North river. From the Department of Street Cleaning—Requesting dredging at the dumps foot of Seven-teenth street, East river, and Nineteenth and One Hundred and Twenty-ninth streets, North river. From Dock Master Fleming—Reporting dredging required on the north side of the Pier foot of West Fuffieth street.

West Fiftieth street.

The following permits were granted, the work to be done under the supervision of the Engineerin-Chief:

White Star Line—To extend railroad tracks on Pier, new 38, North river. New York, Lake Erie and Western Railroad Company — To replace spring piles on the north side of the Pier foot of West Twenty-second street, provided the consent of the lessee is obtained. R. McLaughlin—To build a temporary pile platform at Will's avenue and Bronx Kills, in accordance with diagram submitted ; said platform to remain only during the pleasure of the Board. The following communications were received, read, and, On motion, ordered to be placed on file : From the Counsel to the Corporation—Transmitting duplicate copies of the lease of Pier, new 55, North river, to the Atlas Steamship Company (Limited), with his approval as to form indorsed thereon. The officers of the Board authorized to execute said lease. 2d. Advising the Board, that it has no power to purchase water-front property where no new plan has been adopted.
