The Framework consists of six elements - Rigorous Instruction, Collaborative Teachers, Supportive Environment, Effective School Leadership, Strong Family-Community Ties, and Trust-that drive Student Achievement. The School Quality Guide also shares ratings and data on Student Achievement based on a variety of quantitative measures of student growth and performance.
