

Local Law 119 of 2019 (Int. No. 1533-A) A Local Law to amend the New York City Building Code, in relation to the definition of site safety training full compliance date and site safety training second compliance date.

Local Law 118 of 2019 (Int. No. 1280-A) A Local Law to amend the Administrative Code of the City of New York, in relation to the tenant protection plan and penalties for false statements relating to tenant occupancy on certain construction documents.


Local Law 117 of 2019 (Int. No. 1279-A) A Local Law to amend the Administrative Code of the City of New York, in relation to requiring the Department of Buildings and the Department of Housing Preservation and Development to audit a certain percentage of certifications of correction.

Local Law 116 of 2019 (Int. No. 1278-A) A Local Law to amend the Administrative Code of the City of New York and the New York City Building Code, in relation to requiring heightened review of tenant protection plans and increased enforcement of building code standards.

Local Law 115 of 2019 (Int. No. 1277-A) A Local Law to amend the Administrative Code of the City of New York, in relation to preliminary inspections.

Local Law 114 of 2019 (Int. No. 1275-A) A Local Law to amend the Administrative Code of the City of New York, in relation to denying permits for occupied buildings.

Local Law 111 of 2019 (Int. No. 1257-A) A Local Law to amend the Administrative Code of the City of New York, in relation to inspections of construction sites for which the Department of Buildings has issued a permit.



Local Law 196 Site Safety Training FAQ

Major Disciplinary Cases

- \$43,750 in total penalties issued to Tracking Number Holder Lime-Light
 Construction for a failure to safeguard a work site at 26 1st Avenue,
 Manhattan, which resulted in a worker falling from a supported scaffold. The
 Tracking Number Holder was cited for a number of violating conditions at the
 work site including defective scaffold installation, incomplete decking, missing
 guardrails and pins, and lack of required worker training cards for scaffold
 work.
- \$10,000 in penalties issued to Safety Registrant DLC Development for operating a crane in an unsafe manner at 37-27 12th Street, Queens. The crane was being used without proper DOB approvals, was found to be operating too close to overhead power lines, and had improperly set up supporting outriggers on a cracked sidewalk.
- \$25,000 in penalties issued to Safety Registrant Mega Contracting GP, LLC, for failure to safeguard a construction site at 540 West 53rd Street, Manhattan, which led to a worker falling 16 feet to the ground. It was

determined that the worker fell between a gap between the building and a sidewalk shed, which should have been closed off.

 \$10,000 in penalties issued to General Contractor Vice Contracting LLC, for failure to safeguard a construction site located at 5120 6th Avenue, Brooklyn. DOB inspectors found that the rear of the site had been excavated and the building's rear fire escape ladder could no longer be used as a safe means of egress.
