Alderman Monheimer called for the reading of an opinion from the Counsel to the Corporation relating to that subject, now on the President's table. The opinion is as follows:

LAW DEPARTMENT-OFFICE OF THE Counsel to the Corporation, New York, December 3, 1874.

To the Honorable the Board of Aldermen

GENTLEMEN—My opinion is requested, whether the death of the late Mayor, and the imposition of the duties of his office upon the late President of the Board of Aldermen, create a vacancy in the seat in your Body, lately held by the Hon. Samuel B. H. Vance

The act of April 30, 1873, known as the Amended Charter of that year, provides that "Whenever there shall be a vacancy in the office of Mayor," "the President of the Board of of Mayor," "the President of the Board of Aldermen shall act as Mayor, and possess all the rights and powers of Mayor." (Laws of 1873, chapter 335, section 21.) It will be observed, that under the language of the law, the President of the Board is not only to "act as Mayor," but is to absolutely "possess all the rights and powers of Mayor." These words are as strong as any that could have been used. They clearly make the President of the Board of Aldermen the actual Mayor of the City when a vacancy has been crethe President of the Board of Aldermen the actual Mayor of the City when a vacancy has been created in the office. Mr. Vance is therefore, at this moment, under the Laws of the State of New York, as truly the Mayor of the City as was Mr. Havemeyer during the last twenty-three months of his life, and as will be Mr. Wickham if alive on the first day of the ensuing year. The law operates to absolutely divest him of the office of Alderman, and to invest him with the office of Mayor, during the time which Mr. Havemeyer would have served if his life had been prolonged to the first day of January. He holds but one office, and that the Mayoralty of the city. By operation of existing statutes he is for the time being, as perfectly transferred from the Board of Aldermen to the Chamber of the Mayoralty as though he had resigned the former position and been elected to the latter.

Upon the death of President Harrison, in April, 1841, a question similar to this was considered by the eminent members of the cabinet which his successor, Mr. Tyler, appointed upon the accession of the latter. The inquiry arose whether the official designation of Mr. Tyler should be President or Acting President. The Constitution of the United States provides that—"In case of the removal of the President from office, or of his death, resignation, or inability to discharge the moval of the President from office, or of instead, resignation, or inability to discharge the powers and duties of the said office, the same shall devolve on the Vice-President." (Sub-division 6, section 1, of article 2.) This clause does not, in express terms, declare that the Vice-President shall be the President. It simply says that the "powers and duties of the office shall devolve." "powers and duties of the office shall devolve."
So here, the article of the charter which we are considering does not expressly declare that the President of the Board of Aldermen shall be Mayor. It simply says that he "shall possess all the rights and powers of Mayor." This language is at least equally strong and comprehensive with that employed in the Constitution. Mr. Webster suggested that Mr. Tyler was not simply acting President, but President. This view was acquiesced in and acted upon by his colleagues in the Cabinet and by both Houses of Congress, nor was it ever questioned in any branch of the judiciary.

A separate act of the Legislature of this State, passed thirteen days after the adoption of the Charter, provided that any vacancy occurring in

Charter, provided that any vacancy occurring in the Board of Aldermen by reason of death, resignation, or any other cause, should be filled by election by the Board in which such vacancy should arise by a vote of a majority of all the members elected to said Board. (Laws of 1873,

members elected to said Board. (Laws of 1973, chapter 857, section I.)

In my judgment, there can be no question that Mr. Vance is the Mayor of the City, and no longer a member of your Board; that his seat therein has become vacant; and that the Board clearly possesses the power and duty of filling such vacancy by a vote of a majority of all the members elected. His return to the Board on the second property of the second property o the first day of January will, of course, terminate the vacancy caused by his leaving his seat, and he, and not the newly-elected Alderman, will sit with you until the new Board of Aldermen shall take your place, early in that month.

HEALTH DEPARTMENT.

HEALTH DEPARTMENT OF THE CITY OF NEW YORK, BUREAU OF VITAL STATISTICS, December 1, 1874.

To the Secretary of the Board of Health :

To the Secretary of the Board of Heath?

SIR—In the fourth week of November there were 521 deaths reported in this city. Precisely the same number were reported during the previous week, and after receiving all returns 548 were verified for the week. The classes and various causes of death and the number by each cause presented slight differences in these two weeks, except that there was an increase of mortality from bronchitis and pneumonia, and diseases tality from bronchitis and pneumonia, and diseases of the brain and nervous system, and from causes of the brain and nervous system, and from causes certified as Bright's disease; while there was a con-siderable decrease of infant mortality; the latter decrease (in children under 5) was equal to the total decrease in all ages.

The number and causes of sudden deaths of persons in advanced life, even among the most favored classes, during the cold prelude of winter for ten days past, show how readily the silver cord for ten days past, snow how readily the sliver cord of life is loosed in persons past 70 years of age. There were 83 deaths in this class of persons during the last two weeks of November. The city, in mourning for the sudden death of its Mayor, testifies the importance of inevitable causes which at last strike down the most vigorous and well-preserved lives. preserved lives.

The death rate in the third week of November was equal to 27.40 in the 1,000 inhabitants yearly. The rate in twenty-one cities of Great Britain the first week in November was equal to 25 per 1,000. It was equal to 22 per 1,000 in London, Bristol, and Edinburgh; 36 in Glasgow, 35 in Liverpool.

While scarlatina, small-pox, and enteric fever While scarlatina, small-pox, and enteric fever are scourging numerous cities in England, diphtheria is now prevailing in about half the cities with which this Bureau holds correspondence in the United States, and it is more fatal in numerous interior towns and cities than it is in this city, where its increase prome to be stayed. No other rous interior towns and cities than it is in this city, where its increase seems to be stayed. No other infectious malady more imperatively demands the best resources of medical and sanitary knowledge to limit its prevalence and save life. Sanitary precautions have supreme importance in this dis-

The Sanitary Committee respectfully submit the following propositions concerning diphtheria which, embody deductions from the investigations of the latest and most competent medical authorities:

Diphtheria is caused by the inoculation of the air-passages with the diphtheritic poison, which, from this point infects the whole system; the local in-flammation is attended with the formation of membrane (exudation); the fever and general symptoms are the result of this local infection.

HOW IT SPREADS.

Diphtheria is therefore a contagious disease (not perhaps as marked as scarlet fever) induced by contact with objects and persons infected. It may be diffused by the exhalation of the sick and the be diffused by the exhalation of the sick and the air surrounding them, or directly by the exudation, as in the act of kissing, coughing, spitting, sneezing, or by the infected articles used, as towels, napkins, handkerchiefs, etc.; the poison clings with great tenacity to certain places, rooms, and houses, where it may occasion cases after the elapse of courts. of months.

SYMPTOMS.

In ordinary attacks the poison begins to act the In ordinary attacks the poison begins to act the moment it lodges upon the tissues, but, like a vaccination, causes but slight sensible effects in from two to five days; then is marked prostration, dryness of throat, and pricking pain in swallowing; the throat becomes red, and patches of white exudation appear; and the glands of the neck swell. In mild cases these symptoms subside on the third or fourth day from their appearances; if more severe, these spmptoms may be prolonged; if unfavorable, the fever increases, the local inflammation spreads, and exhaustion rapidly follows.

PREDISPOSING CONDITIONS.

The Person.-Diphtheria attacks by preference children between the ages of one and ten years, the greatest mortality being in the second, third, and fourth year; children of feeble constitution, and those weakened by previous sickness; and those suffering from catarrh, croup, and other forms of throat affections.

Social Relations .- All classes are liable to diphsocial Relations.—An classes are made to appropriate where it is prevailing, but those suffer most severely who live on low, wet grounds; in houses with imperfect drains or surrounded by offensive matters, as privies, decaying animal and vegetable refuse; in damp rooms, as cellars; in overcrowded and unventilated apartments.

Seasons.—Diphtheria is not affected by either heat or cold, drought or rain.

PRECAUTIONS.

(a). The Dwelling or Apartment.—Cleanliness in and around the dwelling, and pure air in living and sleeping rooms, are of the utmost importance wherever any contagious disease is prevailing, as cleanliness tends both to prevent and mitigate it. Every kind and source of fifth around and in the house should be thoroughly removed; cellars and foul a reas should be cleaned and disinfected; drains should be put in perfect repair; dirty walls and ceilings should be lime-washed, and every occupied room should be thoroughly ventilated.

Apartments which have been occupied by persons sick with diphtheria should be cleansed with disinfectants, ceilings lime-washed, and woodwork painted, the carpets, bed-clothing, upholstered furniture, etc. exposed many days to fresh air and the sunlight (all articles which may be boiled or subjected to high degrees of heat should be thus disinfected); such rooms should be exposed to currents of fresh air for at least one week before reoccupation. reoccupation.

WELL CHILDREN.

(b). When Diphtheria is Prevailing — No child should be allowed to kiss strange children nor those suffering from sore throat; (the disgusting custom of compelling children to kiss every visitor is a well-contrived method of propagating other grave diseases than diphtheria); nor should it sleep with, nor be confined to rooms occupied by, or use articles, as toys, taken in the cupied by, or use articles, as toys, taken in the mouth, handkerchiefs, etc., belonging to children having sore throat, croup, or catarrh. If the weather is cold, the child should be warmly clad with flannels.

(c). When Diphtheria is in the House or in the Family—The well children should be scrupulously kept apart from the sick in dry, well-aired rooms; and every possible source of infection through the air, by personal contact with the sick, and by articles used about them or in their rooms, should be rigidly guarded. Every attack of sore throat, cough, and catarrh should be at once attended to; the feeble should have invigorating food and treatment. food and treatment.

(d). Sick Children—The sick should be rigidly isolated in well-aired (the air being entirely changed at least hourly), unlighted rooms, the outflow of air being, as far as possible, through the external windows by depressing the upper and elevating the lower sash, or a chimney heated by a fire in an open fire-place; all discharges from the mouth and nose should be received into vessels containing disinfectants, as solutions of carbolic acid on sulphate of zinc; or upon cloth, which are immediately burned; or if not burned, thoroughly boiled, or placed under a disinfecting fluid. oughly boiled, or placed under a disinfecting fluid.
