Labor Report.

Of the male patients, a daily average of 164 have been engaged as follows: in kitchens, 23; in bake-shop, 6; in boiler-room, 5; in blacksmith-shop, I; on dock, 2; in laundries, I2; driving horses and in stable, 8; in offices, 2; in store-rooms, 3; in drug-store, I; in Physicians' kitchen, 2; as helper for Tinsmith, I; plumbing, I; in Carpenter-shop, I; in dining-room, 8; working on sea-wall, I0; making soap, 2; ward work, 22; painting, I; plastering, I; tailoring, I; making mattresses, I. Miscellaneous work—unloading and trimming coal, removing freight from dock, shoveling snow, delivering bread and stores, screening sand, turning manure, loading coal for boiler-room, removing ashes, and keeping the grounds around the pavilions clean, 50. Of the female patients, a daily average of 619 have been engaged in the following manner: housework, sewing and knitting, 402; in the laundry, 57; peeling vegetables, 12; in the general dining-room, 9; at out-door scrubbing, 18; making mattresses and teasing hair, 110; in the sewing-room, 5; as help for Medical Staff and Officers, 6. 2,076 pieces were laundered for the Ward's Island Asylum, Male Department, and 199,782 pieces for this Asylum. 43,731 articles of clothing and bedding were repaired and 7,255 articles made for this Asylum; 235 articles were made for the Ward's Island Asylum, Male Department.
