SIR—As required by the provisions of section 49 of the New York City Consolidation Act of 1882, the Commissioners of Taxes and Assessments make the following

REPORT

of the operations and action of this Department for the three months ending March 31, 1890 :

The Books of Annual Record of Assessed Valuations of Real and Personal Estate for the year 1890 were completed and opened for inspection and correction on the second Monday of January last, as required by section 817 of the New York City Consolidation Act of 1882.

Previous to that time the opening of such books was advertised in several of the daily newspapers and in the CITY RECORD, and since that time the fact that such books were opened for inspection and correction has been continuously advertised in the CITY RECORD, as required by law.

The following statement shows the assessed valuations of real estate by wards for the year 1890, as appears by the Books of Annual Record of Assessed Valuations of Real Estate, compared with the assessed valuations of real estate for 1889 :

These valuations are subject to revision and reduction upon applications that have been filed or that may be filed in the Department on or before the 30th inst.

During the time the Books of Annual Record of Assessed Valuations have been open for inspection and correction there have been received 6,247 applications for correction of personal assessments of individuals, 365 applications for correction of assessments of shareholders of banks, 1,296 statements of corporations, and 257 applications for reduction of assessed valuations of real estate.

Minutes of Special Meeting of the Aqueduct Commissioners, held at their Office, No. 209 Stewart Building, on Monday, April 28, 1890, at 3 o'clock P. M.

M., at the office of said Commissioners, for the purpose of considering the adoption of plans, maps, etc., providing for the construction of Reservoir "D," on the west branch of the Croton river, Westchester County, New York.

A copy of the above call and notice was mailed to the residence or place of business of each of the Aqueduct Commissioners twenty-four hours before the time named for said meeting in said call and notice.

Present—The Comptroller, and Commissioners Duane, Tucker and Scott.

On motion of Commissioner Scott, the reading of the minutes of April 23, 1890, was dispensed with at this meeting.

The Construction or Executive Committee presented the following :

The Committee on Construction present herewith plans described as Sheets 1, 2 and 3, giving plan and cross-section of the proposed dam and reservoir to be constructed on the west branch of the Croton river, near Carmel, on the New York and Northern Railway, in Putnam County, New York, this day received from the Commissioner of Public Works, and recommend the adoption of the following preamble and resolutions :

CLAIMS FOR EXEMPTION FROM JURY duty will be heard by me daily at my office, from 9 A. M. until 4 P. M.

Those entitled to exemption are: Clergymen, lawyers, physicians, surgeons, surgeon-dentists, professors or teachers in a college, academy or public school, licensed pharmacists or druggists, actually engaged in their respective professions and not following any other calling; militiamen, policemen, and firemen; election officers, jury non-residents, and city employees, and United States employees; officers of vessels making regular trips; licensed pilots, actually following that calling; superintendents, conductors and engineers of a railroad company other than a street railroad company; telegraph operators actually doing duty as such; Grand, Sheriff's, and Civil Court jurors; stationary engineers; and persons physically incapable of performing jury duty by reason of severe sickness, deafness, or other physical disorder.

Those who have not answered as to their liability, or proved permanent exemption, will receive a "jury enrollment notice," requiring them to appear before me this year. Whether liable or not, such notices must be answered (in person, if possible), and at this office only, under severe penalties. It exempt, the party must bring proof of exemption; if liable, he must also answer in person, giving full and correct name, residence, etc., etc. No attention paid to letters.

Persons "enrolled" as liable must serve when called or pay their fines. No mere excuse will be allowed or interference permitted. The fines, if unpaid, will be entered as judgments upon the property of the delinquents.

TO OWNERS OF LANDS ORIGINALLY ACQUIRED BY WATER GRANTS.

ATTENTION IS CALLED TO THE RECENT act of the Legislature (chapter 449, Laws of 1889), which provides that whenever any streets or avenues in the city, described in any grant of land under water, from the Mayor, Aldermen and Commonalty, containing covenants requiring the grantees and their successors to pave, repave, keep in repair or maintain such streets, shall be in need of repairs, pavement or repavement, the Common Council may, by ordinance, require the same to be paved, repaved or repaired, and the expense thereof to be assessed on the property benefited; and whenever the owner of a lot so assessed shall have paid the assessment levied for such paving, repaving or repairing, such payment shall release and discharge such owner from any and every covenant and obligation as to paving, repaving and repairing, contained in the water grant under which the premises are held, and no further assessment shall be imposed on such lot for paving, repaving or repairing such street or avenue, unless it shall be petitioned for by a majority of the owners of the property (who shall also be the owners of a majority of the property in frontage) on the line of the proposed improvement.

The act further provides that the owner of any such lot may notify the Commissioner of Public Works, in writing, specifying the ward number and street number of the lot, that he desires, for himself, his heirs and assigns, to be released from the obligation of such covenants, and elects and agrees that said lot shall be thereafter liable to be assessed as above provided, and thereupon the owner of such lot, his heirs and assigns shall thenceforth be relieved from any obligation to pave, repair, uphold or maintain said street, and the lot in respect of which such notice was given shall be liable to assessment accordingly.

The Commissioner of Public Works desires to give the following explanation of the operation of this act: When notice, as above described, is given to the Commissioner of Public Works, the owner of the lot or lots therein described, and his heirs and assigns, are forever released from all obligation under the grant in respect to paving, repaving or repairing the street in front of or adjacent to said lot or lots, except one assessment for such paving, repaving or repairs, as the Common Council may, by ordinance, direct to be made thereafter.

No street or avenue within the limits of such grants can be paved, repaved or repaired until said work is authorized by ordinance of the Common Council, and when the owners of such lots desire their streets to be paved, repaved or repaired, they should state their desire and make their application to the Board of Aldermen and not to the Commissioner of Public Works, who has no authority in the matter until directed by ordinance of the Common Council to proceed with the pavement, repavement or repairs.

PUBLIC NOTICE IS HEREBY GIVEN THAT in compliance with the provisions of chapter 559, Laws of 1887, amending sections 350 and 921 of the New York City Consolidation Act of 1882, passed June 9, 1887, the following changes are made in charging and collecting water rents:

1st. All extra charges for water incurred from and after June 9, 1887, shall be treated, collected and returned in arrears in the same manner as regular rents have heretofore been treated.

2d. In every building where a water meter or meters are now, or shall hereafter be in use, the charge for water by meter measurement shall be the only charge against such building, or such part thereof as is supplied through meter.

3d. The returns of arrears of water rents, including the year 1887, shall be made as heretofore on the confirmation of the tax levy by the Board of Aldermen, and shall include all charges and penalties of every nature.

4th. A penalty of five dollars (\$5) is hereby established, and will be imposed in each and every case where the rules and regulations of the Department prohibiting the use of water through hose, or in any other wasteful manner, are violated, and such penalties will be entered on the books of the Bureau against the respective buildings or property, and, if not collected, be returned in arrears in like manner as other charges for water.

5th. Charges for so-called extra water rents of every nature, imposed or incurred prior to June 9, 1887, will be canceled of record on the books of the Department.
