Resolved, That, by virtue and under the powers of chapter 247 of the Laws of 1883, this Board, acting and discharging the duties of Supervisors under section 83 of chapter 410 of the Laws of 1882, does hereby designate the President of the Board of Health as the proper authority to certify all bills and claims for interring the body of any honorably discharged soldier, sailor or marine who served in the aimy or navy of the United States during the late rebellion, who may hereafter die without leaving means sufficient to defray funeral expenses, at an expense not exceeding thirty-five dollars in any case, or for the erection of a headstone of a design and material as approved by the Board of Supervisors by resolution, Cotober 22, 1883, at a cost not exceeding fifteen dollars in any case, and which expenses are by chapter 247 of the Laws of 1883 made a county charge to be paid by the County Treasurer.

GENTLEMEN—While doing the work of preparing and coating with cement the New Croton Aqueduct, in Sections 13 and 14, you verbally authorized me to do at the same time similar work in adjacent part of Section 12.

In view of the work of the same character remaining to be done in the rest of Section 12, including the siphon under Harlem river, I would respectfully ask you to authorize the Chief Engineer to complete the preparation of this section. The amount necessary therefor will not exceed \$2,500, and may remain much below that sum.

This is to ask you to appropriate the amount of \$2,500 for that purpose, including in it the \$300 already spent as stated above.

The long time during which the inverted siphon under the Harlem river has been inaccessible, with chances of silting being caused by adjoining work and by the flow of the water from the upper sections, is the cause of the uncertainty in regard to the probable cost of this work, which is, as you are aware, of an expensive character.

York:

It becomes my duty as Commissioner of Public Works
and custodian of the many and immense interests involved in the City's water supply, to briefly present to
the people of the City the present condition of the
supply, and the extreme necessity for care and economy
in the use of the water.

For a number of years past and up to the present
time, the old Aqueduct and the Bronx river conduit
have delivered in the City all the water which they are
capable of carrying, the supply thus remaining stationary when the City has been constantly growing in population, buildings, manufactures and commerce, creating
new and additional demands upon the water service. The
consequence is that at certain seasons of the year, notably in extreme cold weather, when the habit of wasting
water from faucets to prevent freezing in the pipes prevails, and in warm and dry weather, when various
methods of waste are in vogue, the daily consumption
exceeds the supply which can by any possibility be
received through the old Aqueduct and the Bronx river
conduit, the excess of consumption being drawn from the
city reservoirs, diminishing the depth of water and the
pressure in the distributing mains. There is no possibility of increasing the water supply received in the
City until the new Aqueduct is brought into operation,
and in the meantime the only reliance for a fair and
equal distribution of water throughout the city is care
and economy in its use on the part of the people.
Already the depth of water in the reservoirs is being
diminished at the rate of one inch per day, and if this
should continue for any length of time, the pressure in
the distributing mains would be so reduced that it
would be impossible to deliver water in thousands of
houses located on high ground, and in some other
locations even in the basements or cellars.

ACQUIRED BY WATER GRANTS.

ATTENTION IS CALLED TO THE RECENT act of the Legislature (chapter 449, Laws of 1889), which provides that whenever any streets or avenues in the city, described in any grant of land under water, from the Mayor, Aldermen and Commonalty, containing covenants requiring the grantees and their successors to pave, repave, keep in repair or maintain such streets, shall be in need of repairs, pavement or repavement, the Common Council may, by ordinance, require the same to be paved, repaved or repaired, and the expense thereof to be assessed on the property benefited; and whenever the owner of a lot so assessed shall have paid the assessment levied for such paving, repaving or repairing, such payment shall release and discharge such owner from any and every covenant and obligation as to paving, repaving and repairing, contained in the water grant under which the premises are held, and no further assessment shall be imposed on such lot for paving, repaving or repairing such street or avenue, unless it shall be petitioned for by a majority of the owners of the property (who shall also be the owners of a majority of the property (who shall also be the owners of a majority of the property (who shall also be the owners of the property in frontage) on the line of the proposed improvement.

The act further provides that the owner of any such lot may notify the Commissioner of Public Works, in writing, specifying the ward number and street number of the lot, that he desires, for himself, his heirs and assigns, to be released from the obligation of such covenants, and elects and agrees that said lot shall be thereafter liable to be assessed as above provided, and thereupon the owner of such lot, his heirs and assigns, shall theneforth be relieved from any obligation to pave, repair, uphold or maintain said street, and the lot in respect of which such notice was given shall be liable to assessment accordingly.

A penalty of five dollars (\$5\$) is hereby established, and will be imposed in each and every case where the rules and regulations of the Department prohibiting the use of water through hose, or in any other wasteful manner, are violated, and such penalties will be entered on the books of the Bureau against the respective buildings or property, and, if not collected, be returned in arrears in like manner as other charges for water.

5th. Charges for so-called extra water rents of every nature, imposed or incurred prior to June 9, 1881, will be canceled of record on the books of the Department.
