I understand that the candidate or treasurer will be required to change this password the first time the campaign commences the Internet disclosure statement submission process, and may further change the password at any time after that. I agree not to disclose those passwords to any other person or authorize any other person to use those passwords or otherwise submit a disclosure statement to the CFB over the Internet.

I verify that I have read and understand the following:

Intentionally or knowingly making a false statement, including but not limited to in the form of an electronic submission, or intentionally or knowingly violating any provision of the New York City Campaign Finance Act, is a Class A misdemeanor pursuant to Section 3-711(3) of the New York City Administrative Code.

Knowingly making a false written statement, including but not limited to in the form of an electronic submission, is a Class A misdemeanor pursuant to New York State Penal Law Section 210.45.

Knowingly offering false written information, including but not limited to in the form of an electronic submission, with the belief that it will become a part of the records of a public office, and with the intent to defraud, is a Class E felony pursuant to New York State Penal Law Section 175.35.

If a disclosure statement is submitted to the CFB over the Internet by anyone other than the candidate or the treasurer, or in any other unauthorized manner, in addition to any civil penalties or criminal sanctions that may be appropriate, I, along with the candidate/treasurer may be held jointly and severally liable for the return of any public funds already received, and my campaign may not be eligible to receive any additional public funds.
