# DEPARTMENT OF DOCKS AND FERRIES.

At a regular meeting of the Board of Docks held Friday, July 1, 1898, at 11 o'clock A. M. Present—The full Board.

The minutes of the two meetings held June 24, 1898, were approved. On motion, the minutes of the meeting held April 29, 1898, were amended by inserting therein the following resolution :

"Resolved, That permission be and hereby is granted the New York, New Haven and Hart-ford Railroad Company to use and occupy, during the pleasure of the Board, the following

described wharf property : "The easterly half of Pier, old 51; westerly half of Pier, old 52, and the bulkhead between Piers, old 51 and 52, East river, together with platform in front of same, with privilege of using shed on said platform.

"It being understood that the above permit is subject to the terms, covenants and conditions of the indenture dated May 1, 1888, between the Mayor, Aldermen and Commonalty of The City of New York, acting by and through the Board of Docks of said city, and said New York, New Haven and Hartford Railroad Company." Hon. LOUIS F. HAFFEN, President, Borough of The Bronx, Crotona Park, New York :

DEAR SIR—In reference to changing the pavement of the Brook Avenue Beam Tunnel and adjacent streets from granite block to asphalt pavement, we hereby consent to substitute asphalt pavement for the granite-block pavement specified in said contract for the same price per square yard, viz., one dollar and seventy cents (\$1.70).
