AGENCY RECYCLING PLAN

Local Law 36 of 2010 requires each city agency to develop and submit an agency waste prevention, reuse, and recycling plan. To be in compliance with the Local Law, OATH will be implementing the following agency wide recycling plan:

- 1. Centralized Locations for Recycling Paper:
 - There will be labeled recycling containers wherever mixed paper and cardboard recyclables are commonly discarded, especially at high paper generation areas such as mailrooms, copiers, or near common areas such as entrance ways and meeting rooms.

2. Desk-Side Recycling:

- Given that the majority of the typical office waste stream is paper, there will two receptacles at each desk: one designated for paper, and one for garbage. Workers will bring recyclable bottles and cans to recycling bins located centrally.
- 3. Recycling Beverage Cartons, Bottles, Cans, Metal, and Foil:
 - There will be labeled recycling containers to collect beverage cartons, plastic bottles, glass bottles, cans, metal, and foil wherever these designated recyclables are commonly generated, especially at food vending areas, cafeterias, pantries, and staff lunch areas; and in or near common areas such as entranceways and meeting rooms.

Also as part of Local Law 36, OATH is required to designate a lead recycling coordinator and an assistant recycling coordinator for each facility that OATH occupies. They will be responsible for insuring implementation and compliance.

Attached is a list of the agency's lead recycling coordinators and assistant recycling coordinators as of March 18, 2015. The lead recycling coordinator has been working with all the assistants to implement the agency plan at all locations.
