

**New York City Department for the Aging**  
**Social Adult Day Care Ombuds City Council Report**

**January 11, 2022**

In compliance with Local Law 9 of 2015, the following is the annual report of the legislated Social Adult Day Care (SADC) Ombuds Office for Calendar Year 2021.

- (i) The total number of social adult day cares and the name and address of each social adult day care:

Total Number of SADCs Registered: 347<sup>1</sup>  
 Sub-Total Number of SADCs that are Active: 322  
 Sub-Total Number of SADCs that are No Longer Active: 13  
 Sub-Total Number of SADCs that are Pending to become Active: 12

<sup>1</sup>This number reflects the total registered SADC programs as of December 31, 2021. On June 1, 2021, NYC Emergency Executive Order 206 authorized the resumption of outdoor activities at older adult congregate centers and on June 14, 2021, indoor activities were allowed. SADC programs throughout NYC were gradually opening their doors to provide in-person services while adhering to guidance issued by the NYS Department of Health and the NYC Department of Health and Mental Hygiene.

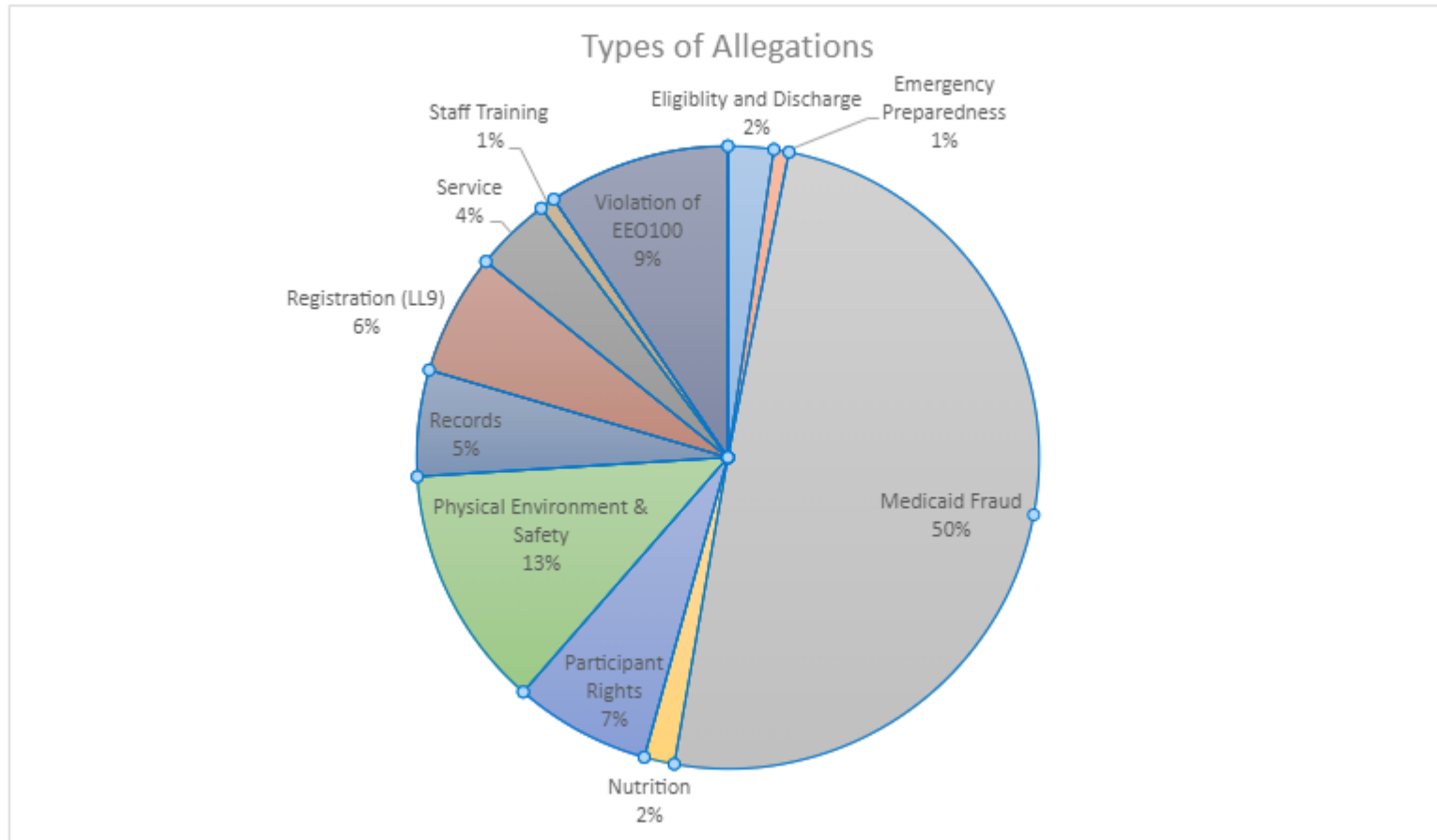
- (ii) The total number of complaints received by the SADC Ombuds Office:

There were 90 complaints received against 52 SADC sites. It is important to note that the majority of complaints contained more than one allegation. There were three additional allegations reported to the SADC Ombuds Office, but there was not enough information with which to conduct an investigation, or to determine whether a referral should be made. These three were not included in the complaint count.

(iii) A general description of the reason for each such complaint:

There were 127 distinct allegations within the 90 complaints received as shown below.



<b>Types of Allegation</b>	
<b>Eligibility and discharge:</b>	Participants who reportedly do not qualify for SADC services are admitted into the program; participants attending SADC are discharged from program without due process.
<b>Emergency preparedness:</b>	SADC does not have current written procedures for handling emergencies such as missing or incomplete NY Forward re-opening safety plan.
<b>Medicaid Fraud:</b>	Cash or goods are used as incentives to recruit older adults; possible falsification of eligibility; participants who are not eligible as defined by SADS Standards are recruited into the program; false billing or attendance records.
<b>Nutrition:</b>	Quality of food and/or conditions of food service area does not comply with New York State Office for the Aging (NYSOFA) SADS Standards.
<b>Participant Rights:</b>	SADC staff failed to enforce or protect the rights of participants in accordance with the NYSOFA SADS Standards.
<b>Physical environment and safety:</b>	Issues regarding site condition including facilities being dirty, bathrooms malfunctioning, and Certificate of Occupancy concerns.
<b>Records:</b>	SADC staff failed to ensure confidentiality of client records.

<b>Not Registered:</b>	SADC failed to register with the SADC Ombuds Office
<b>Service plan:</b>	Scheduled or planned services are not provided to participants or do not reflect the CORS services required under NYSOFA SADS Standards.
<b>Staffing - Training:</b>	Staff are not adequately trained to provide services or work with SADC participants; SADC director failed to create policies, procedures, or enforce NYSOFA SADS Standards.
<b>Violation of NYC Emergency Executive Order 100:</b>	SADC programs are providing in-person services during the state of emergency.

(iv) The total number of investigations conducted by the SADC Ombuds Office, a general description of the basis for each investigation, any findings that an SADC has violated subdivision a of section 21-204 of the New York City Administrative Code (Admin. Code) , and the outcome of each investigation:

The SADC Ombuds Office conducted six investigations this calendar year. Below are general descriptions of the bases for the investigations, our findings, and outcomes.

- An allegation that an SADC was providing in-person services while NYC Emergency Executive Order 100 (prohibiting in-person services in older adult congregate settings) was active. The findings and outcome were unsubstantiated.
- An allegation that the SADC was doing business as (DBA) another name in the community. The DBA was not reflected in the SADC registration. The findings and outcome were substantiated. The SADC submitted an appeal contesting the findings; however, the SADC then complied with the recommendations. The appeal was closed.

- Allegations that two SADC programs were operating without following the NYS Forward Safety Plan guidance. The office closed one investigation; the findings and outcome were inconclusive. The office is currently investigating the second case.
- An allegation that an SADC was in violation of the nutrition and staff training SADC Standards. The office is currently investigating this complaint.
- An allegation that an SADC was in violation of participant’s rights. The office is currently investigating this complaint.

Additionally, complaints were also referred to other City and/or State agencies based on their respective jurisdiction regarding the nature of the allegation. See chart below.

(v) The total number of notices of violation issued pursuant to subdivision a of section 21-204 of the Admin. Code, as noted in (iv) above, and subdivision c of section 21-204 of the Admin. Code, which outlines the civil penalties to be imposed, disaggregated by the specific violation for which such notice was issued:

The SADC programs that were found in violation of the NYS Office for the Aging SADC Standards were informed of the investigative findings. The SADCs resolved the violations through corrective action plans (CAP) approved by the SADC Ombuds Office; therefore, zero notices of violations were issued for Calendar Year 2021.

(vi) The total number of SADC programs that failed to register pursuant to subdivision b of section 21-204 b of the Admin. Code as of this date:

There were eight SADC programs that failed to register with the SADC Ombuds Office. The office notified the eight social adult day care programs of the registration requirements.

- Two of the eight SADCs complied with the requirement and registered immediately following a technical assistance session with the office.
- One SADC reported that the facility closed and is no longer operating.
- Another SADC reported that the program's scope of work changed and is not operating as an SADC.
- The remaining four SADCs have not responded to the office's outreach attempts. The office will conduct site visits to these SADCs in Calendar Year 2022.

(vii) Any recommendations regarding the operation of SADCs:

Trainings:

- The SADC Ombuds Office conducted a webinar on Local Law 9 of 2015 and the associated Rules for SADC directors/owners and Managed Long-Term Care Plans (MLTCs) on November 15, 2021 and December 28, 2021, respectively.
- The Office will continue to provide technical assistance webinars to SADCs and MLTCs to ensure that the SADCs remain in compliance with local, state, and federal rules and regulations.

Collaborations with City and State government agencies:

- Continue to strengthen the Office's network of NYC and NYS governments agencies to assist in enforcing all applicable city and state regulations relating to the NYSOFA SADC standards.
- Continue to work with the NYC Office of Administrative Trials and Hearings (OATH) and NYC Department of Finance (DOF) in establishing the system of enforcement and adjudication of violations and judgments.
- Continue to work with the NYS oversight agencies (NYS Office of Medicaid Inspector General, NYSOFA and NYS Department of Health) by referring complaints that fall within their jurisdiction such as allegations of medicaid fraud.

Key Activities:

- Referred an SADC complaint to NYC Department of Buildings (DOB) regarding an allegation of non-compliance with the Certificate of Occupancy. In coordination with DOB, a joint inspection was conducted, which resulted in DOB issuing a notice of violation to the SADC.
- Supported SADC providers during the COVID-19 pandemic by communicating relevant NYC Emergency Executive Orders to SADCs via email. For example, the Office disseminated Emergency Executive Order No. 206 to SADC providers and MLTC plans, authorizing the resumption of in-person services to older adults in June 2021.
- Conducted outreach activities to SADC programs to confirm their reopening and ensure that the SADC Ombuds Complaint signage and Participants Rights are posted in a public area. The SADC Ombuds Office will continue to conduct outreach activities to the remaining SADC programs.
