APPROVED PAPERS.

Ordinances, Resolutions, etc., approved by the Mayor during the week ending July 13, 1878.

Resolved, That the four vacant lots on the south side of Twenty-fourth street, eighty-two feet east of First avenue, be fenced in, under the direction of the Commissioner of Public Works; and that the accompanying ordinance therefor be adopted.

Resolved, That the Commissioner of Public Works repair the fence crossing Forty-first street and Prospect place, between First and Second avenues.

AN ORDINANCE to regulate the sprinkling of the streets, avenues, and public places in the City of New York.

The Mayor, Aldermen, and Commonalty of the City of New York do ordain as follows:

Section 1. The Mayor, in his discretion, is hereby authorized to grant licenses to such persons as shall be recommended to him by the Board of Aldermen, or a majority of the members thereof, who shall comply with the conditions of this ordinance, for permission to use Croton water from such of the public hydrants as may be designated by the Commissioner of Public Works, and shall be located on the routes, respectively, of the persons so licensed, or failing to make such designation, from the hydrants now or heretofore used for such purpose, for sprinkling the streets of this city.

Sec. 2. Every such person who shall thus obtain a license shall pay to the Water Registrar such sum or sums as may be fixed by the Commissioner of Public Works, as rates for the use of the Croton water used by each in sprinkling the streets, which shall be accounted for and deposited, as provided in section 23, article III., of chapter VI., of the Ordinances of 1866.

Sec. 3. The sprinklers used by every such person shall conform in every respect to a pattern to be kept in the office of the Mayor, which shall be in form and shape as follows, that is to say: A tin cylinder, six feet in length, curved so as to give a versed sine of seven inches, of a diameter not to exceed two and one-half inches at the inlet, tapering thence at each end to a diameter of not more than two inches; the four centre sheets or feet of which shall each be pierced with three rows of holes, and the end feet or sheets, each with four rows; said holes to be in parallel rows, and at least one-half an inch apart, and to be of a size not to exceed number sixteen wire. The first or bottom row of holes shall be at right angles to the inlet, and the sprinkler, when in use, shall be so hung as to throw the water directly on the street; the ends of the cylinder shall be without holes.

Sec. 4. Every cart used in sprinkling streets under the provisions of this ordinance, shall have painted on each side of the cask, or other receptacle for the water, and exposed to public view, in black letters of not less than two inches in length, and on a white ground, the name and residence of the person under whose license the work is performed.

Sec. 5. Any person licensed to sprinkle the streets, as provided in this ordinance, who shall violate any of its provisions, shall, in the discretion of the Mayor, have his license revoked; and any person, except by order of the Street Cleaning Bureau, in the work of cleaning the streets, who, without being so licensed, shall sprinkle, or attempt to sprinkle, any water from any cart or other vehicle upon any of the streets, avenues, or public places in the City of New York, shall be deemed guilty of a misdemeanor, and on conviction thereof, shall be punished pursuant to the provisions of sections 20 and 21 of an act relative to the powers of the Common Council of the City of New York, passed by the Legislature of the State of New York, January 23, 1833, and to the provisions of section 5, article IV. of an act in relation to the Police Department of the City of New York, passed April 13, 1853; and it is hereby made the duty of the Commissioners of Police strictly to enforce the provisions of this ordinance.

Sec. 6. Section 59 of chapter VI. of the Ordinances of 1866 is hereby amended, and shall read as follows: "Section 59. No person or persons except such as may be licensed by the Commissioner of Public Works to sell water to shipping, and by the Mayor, as provided in this ordinance, to sprinkle the streets, shall take water from any hydrant erected, or hereafter to be erected, in the City of New York, and attached to or connected with the Croton water-pipes, for the purpose of selling said water, or offering it for sale, under the penalty of twenty-five dollars."

Sec. 7. The ordinance entitled "An ordinance to amend sections 51 and 64 of chapter VI. of the Revised Ordinances of 1866," approved June 7, 1875; also, sections 51, 52, 53, 54, and 55 of said chapter VI. of the Ordinances of 1866, and all other ordinances or parts of ordinances inconsistent or conflicting with the provisions of this ordinance are hereby repealed.

Sec. 8. This ordinance shall take effect immediately.

Resolved, That the Secretary of the Board respectfully call the attention of the District Attorney to the fact that the manufacture of fertilizers on Newtown creek with sludge acid has been continued, especially by Clark and Clark & Reed, and often at night; that the reports of Inspectors Goldschmidt and Brennan show that within the last two weeks the manufacture at Clark's factory has been the same, and the nuisance therefrom similar to that proved in the month of May, and that unless Clarke and Clark & Reed, on Newtown creek, stop using sludge acid the east side nuisance will be likely to prevail during the summer. This Board is satisfied that at Clark's factory the nuisance is continued, and has not been abated.

Resolved, That the Consulting Architect be requested to examine some of the plans of tenement houses recently filed in Department of Buildings, and report to this Board at its next meeting whether they comply in all particulars with the Tenant House Act.

Resolved, That the Department of Public Works be respectfully requested, for sanitary reasons, to flush the gutters with Croton water, so far as possible, during the summer months, with particular reference to keeping the street culvert basins filled with water.

Resolved, That the Sanitary Superintendent be and is hereby authorized and directed to repair the rescuing apparatus at an expense not to exceed \$50.

Resolved, That Orders 2641, 2642, and 2643, on premises south side of One Hundred and Twenty-seventh street, east of Madison avenue, be and is hereby suspended indefinitely.

Resolved, That Order 2200, on premises 68 Oliver street, be and is hereby suspended during the pleasure of the Board, provided the owner stipulates to keep the premises disinfected and in an inoffensive condition.

Resolved, That Order 4873 on premises 56 and 58 East Fifty-sixth street be and is hereby extended until October 1, 1878.

Resolved, That Order 5466 and 5467 on premises 52 Frankfort street and No. 1 Vandewater street be and are hereby rescinded.

Resolved, That leave of absence of two weeks from the 15th instant be and is hereby granted to M. J. Bowers.

Resolved, That Dr. Geo. Hart be and is hereby appointed an Assistant Sanitary Inspector for temporary service in the inspection of tenement houses with particular reference to the care and attendance of sick children therein; that such service continue for five weeks, and that the amount to be paid for such service for that period be \$100.

Resolved, That the services of Samuel A. Goldschmidt, Ph. D., be and are hereby continued or one month.

Whereas, The Sanitary Superintendent has certified to this Board that the nine buildings situated on the east side of Third avenue south of One Hundred and Ninth street, New York city, have become dangerous to life by reason of want of repair,

Ordered, That all persons in said buildings situated on the east side of Third avenue south of One Hundred and Seventh street, New York city, be required to vacate said buildings on or before July 19, 1878, for the reason that said buildings are dangerous to life by reason of want of repair; and further that this order be affixed conspicuously on the front of said buildings, and be served as the law requires under the direction of the Sanitary Superintendent, and further that said buildings be not again used as human habitations without a written permit from this Board.

Sanitary Bureau.

The following is a record of the work performed in the Sanitary Bureau for the week ending July 6, 1878:

The total number of inspections made by the Sanitary and Assistant Sanitary Inspectors was 1,488, as follows, viz.: 3 public buildings, 647 tenement houses, 154 private dwellings, 44 other dwellings, 12 manufactories and workshops, 9 stores and warehouses, 44 stables, 37 slaughter-houses, 1 bone and rag house, 2 uninhabitable dwellings, 4 public sewers, 16 fat-rendering establishments, 1 lime kiln, 7 manure dumps, 1 garbage dump, 1 oil works, 1 pond, 5 soap factories, 1 tripe establishment, 35 sunken and vacant lots, 50 yards, courts, and areas, 36 cellars and basements, 85 waste pipes and drains, 160 privies and water closets, 33 streets, gutters, and sidewalks, 3 dangerous stairways, 6 cesspools, 2 piggeries, 4 smoky chimneys, 1 fertilizing works, 2 glycerine works, 1 stock yard, 19 other nuisances, together with 62 visits of the Sanitary Inspectors to cases of contagious disease.

The number of reports thereon received from the Inspectors was 614.

During the past week 245 complaints were received from citizens, and referred to the Sanitary and Assistant Sanitary Inspectors for investigation and report.

Permits were issued to the consignees of 97 vessels to discharge cargoes, on vouchers from the Health Officer of the port.

81 permits were granted to scavengers to empty, clean, and disinfect privy-sinks.

HEALTH DEPARTMENT, No. 301 MOTT STREET, NEW YORK, July 8, 1878.

AT A MEETING OF THE BOARD OF HEALTH of the Health Department of the City of New York, held at its office on the 25th day of June, 1878, the following resolution was adopted:

Resolved, That Section 155 of the Sanitary Code be and is hereby amended so as to read as follows:

Section 155. That no captain, agent, or person having charge of, or attached to any ferry-boat, sailing, or other vessel, nor any person in charge of any car, stage, or other vehicle, or public or private conveyance, shall convey or allow to be conveyed thereon, or by any means aforesaid, nor shall any person convey or allow to be carried or conveyed, in any manner, from or in the City of New York, the dead body of any human being, or any part thereof, without a permit therefor from this Department. And the proper coupon for that purpose attached to any such permit, when issued shall be preserved and returned to this Department, as its regulations may require, by the proper officer or person on such boat or vessel, and by the proper person in charge of any train of cars or vehicle on which such body may be carried from said city; provided, however, that the same effect shall be given, under this section, to a burial or transit permit issued from this Department, when the death of the person named in the permit shall have occurred in the City of Brooklyn; and provided that the same effect shall be given under this section to a burial or transit permit issued by the Board of Health of the Vital Statistics of Richmond county, as to a burial permit from this Department, when the death of the person named in the permit shall have occurred in Richmond county; and provided that the same effect shall be given under this section to a burial or transit permit issued from this Department, when the death of the person named in the permit shall have occurred in Long Island City; and provided that the same effect shall be given, under this section, to a burial or transit permit issued by the Board of Health, or health officer of the City of Yonkers, as to a burial or transit permit issued from this Department, when the death of the person named in the permit shall have occurred in said City of Yonkers.

And provided that the same effect shall be given under this section to a burial or transit permit issued under the laws of the State of New Jersey, and especially pursuant to provisions of an act of said State, entitled "An act concerning the registry and returns of marriages, births and deaths," passed April 5, 1878, as to a burial or transit permit issued from this Department, subject, nevertheless, in every case to all the care, precautions and diligence prescribed by the rules and regulations of this Department.
