### DEPARTMENT OF DOCKS.

At a meeting of the Board of Docks, held October 9, 1879.

Present—Commissioners Dimock and Vanderpoel.

On motion, Commissioner Dimock took the chair.

The minutes of the meetings held September 26 and October 2, 1879, were read and approved.

The following communications were received, read, and,

On motion, laid on the table, to await action as stated, to wit:

From Hudson Tunnel R. R. Co.—For use of Department boring machine.

From S. A. Frost—In reference to repairs made by him to the surface of Pier 19, East river. Referred to Engineer-in-Chief to examine and report if the repairs are being made in conformity with the directions of the Board, under date of September 26, last.

From Joseph V. Brown—To have repairs made to pier at Fifth street, East river. Engineer-in-Chief directed to examine and report repairs necessary, and an estimate of the cost thereof.

The following communications were received, read, and,

On motion, placed on file, action being taken where necessary as stated, to wit:

From Irving C. Smith—To erect a small boat-house on piles now standing at the foot of One Hundred and Nineteenth street, Harlem river. Application denied, as this Department has no authority to grant permission for the erection of the building referred to.

From Central R. R. Co. of New Jersey—Accepting terms of resolution adopted October 2, 1879, to pay rent for land under water covered by extension to be made to the outer end of Pier 14, North river.

From E. W. Youmans—For permission to place a hoisting engine on Pier, old 42, North river. Applicant informed that this Department has no objection to his placing and retaining, under the supervision of the Engineer-in-Chief of this Department, a small engine and boiler on Pier, old 42, North river, for the purpose of hoisting coal, provided that the same be placed on wheels so as to be easily moved; but the Department reserves the right to cause its removal at any time it may so elect.

From Beebe, Wilcox & Hobbs—In reference to wharfage due from steamer "Castlewood" at Pier, old 44, North river.

From E. G. Tinker, Captain of the Port—In reference to the berth set aside by this Department for the Old Dominion Steamship Co., at Pier, new 1, North river.

From Stephen A. Jenks & Co.—For permission to drive fender piles at platform between Piers 18 and 19, East river. Action of the Commissioners on the 8th instant, in granting the permission asked for, approved.

From Department of Public Works—Requesting that the fenders be removed from around the public baths, now closed for the season. Engineer-in-Chief directed to remove the floats, fenders, etc., in accordance with said request.

From G. B. Lawton—In reference to wharf accommodations between West Eleventh and Fourteenth streets, North river.

From Martin Karl—For permission to place a coal-bin on pier at Fifty-first street, North river. Application denied.

From Engineer-in-Chief, the following reports:

1. Stating that the bulkhead in the rear of Pier 51, East river, is in bad condition and should be rebuilt from low water. Engineer-in-Chief directed to rebuild the premises as recommended by him, at a cost of about \$250.

2. As to work performed during week ending October 4, 1879.

3. Stating that the rebuilding of bulkhead between Piers 41 and 42, East river, has been completed by the owners, and recommending that the space adjacent thereto be paved. Secretary directed to address a communication to the Commissioner of Public Works, requesting that the pavement be laid at the aforesaid bulkhead as soon as may be convenient.

A report was received from the Engineer-in-Chief, as to the delivery and return of the pile cutting machine loaned to Ross & Sanford; and being read,

On motion, it was

Resolved, That the Treasurer be and is hereby authorized and directed to prepare a statement of claim in the sum of \$10, and present the same to Ross & Sanford for payment, being for use of pile cutting machine one day, pursuant to resolution of the Board of September 25, 1879, at the rate of \$10 per day.

A communication was received from the Engineer-in-Chief, as to the amount of dredging done by C. H. Loomis and the Union Dredging Co., while using the Department dredging scows, and, being read,

On motion, the following resolutions were adopted:

Resolved, That the Treasurer be and is hereby authorized and directed to prepare a statement of claim in the sum of \$735.04, and present the same to Chandler H. Loomis for payment, being for use of scows of the Department in removing, to date of October 1, 1879, 36,752 cubic yards of material dredged under contract with him, dated June 18, 1879, at two cents per cubic yard.

Resolved, That the Treasurer be and is hereby authorized and directed to prepare a statement of claim in the sum of \$2,382.06, and present the same to the Union Dredging Company for payment, being for use of scows of the Department in removing, from April 1 to October 1, 1879, 119,103 cubic yards of material dredged by said company, under orders of the Treasurer of this Department, at two cents per cubic yard.

An application was received from Clark & Seaman, for permission to erect platform between Piers 8 and 9, North river; and being read,

On motion, it was

Resolved, That permission be and is hereby granted to Clark & Seaman, lessees, to drive piles between Piers 8 and 9, North river, easterly of the new bulkhead line, and to erect thereon a platform extending to that now existing in front of the bulkhead thereat; the owners and lessees of the said bulkhead and piers having consented in writing to the improvement being made; provided that the plans for the said improvement shall first be submitted to and approved by the Engineer-in-Chief of this Department, and all the work be done under his supervision; and that the said lessees file in this office, within ten days after date hereof, a written agreement to pay to this Department, as rent for the land under water covered by said platform, the sum of \$1,250 per annum, payable quarterly, in advance, from and after November 1, 1879; and provided, further, that the acceptance of this permission shall be held to be an agreement on the part of the said lessees to remove all the said improvement at their own cost and expense, whenever so directed to do by this Department or its successor, or by the party or parties claiming to own the said bulkhead, and that neither the erection of said platform, nor its removal, nor anything herein contained, shall operate to the prejudice of any existing rights of said party or parties, or of the Corporation of the City of New York.

An application was received from Wm. Cruikshank, for permission to make an extension to Pier 9, North river; and, being read,

On motion, it was

Resolved, That permission be and is hereby granted to William Cruikshank, agent for the owners of Pier 9, North river, to drive piles for the purpose of making a temporary extension to said pier, of its entire width, for a distance of 100 feet westerly from its present outer end, the owners and lessees of Piers 8 and 10, North river, having assented, in writing, to the improvement being made, provided that the plans for the said improvement shall first be submitted to and approved by the Engineer-in-Chief of this Department, and all the work be done under his supervision, and that the said agent file in this office within ten days after date hereof, a written

agreement to pay as rent for the land under water to be covered by said extension, the sum of \$700 per annum, payable quarterly, in advance, from and after November 1, 1879, and, provided further, that the acceptance of this permission shall be held to be an agreement on the part of the said agent and his principals to remove all the said extension at their own cost and expense within thirty days after date of written notice so to do from this Department or its successor, and in case such removal is not made within that time, that the said Department may proceed with the work of removal at the cost and expense of said agent and principals, and that neither the erection nor removal of said extension, nor anything herein contained, shall operate to the prejudice of any existing rights of said owners or of the Corporation of the City of New York.

The Auditing Committee presented an audit of twenty-one bills or claims, amounting in the aggregate to the sum of \$27,324.66; and, being read, was

On motion, accepted and adopted, and the Secretary directed to forward the said bills, together with proper requisitions for the amount, to the Finance Department for payment.

On motion, the communication from Board of Commissioners of Pilots, in reference to mattresses thrown into the slip between Piers 20 and 21, North river, from the Anchor Line of steamships, was taken from the table and placed on file, and the following resolution adopted:

Resolved, That in accordance with Regulation 11 of the manual of this Department, a penalty in the sum of \$50 be and is hereby imposed upon Henderson Brothers, agents of the Anchor Line of steamships, for two violations of said regulation, to wit: for having thrown into the slip between Piers 20 and 21, North river, on September 23d, from steamer "Devonia," about fifty mattresses, and on September 29th, from steamer "Bolivia," about forty mattresses, as reported by the Commissioners of Pilots, and that the Treasurer be and is hereby authorized and directed to prepare a statement of claim, in the sum of fifty dollars, and present the same to Henderson Brothers for payment.

The Engineer-in-Chief, stating that the deck of the pier at Seventh street, East river, torn up during the progress of improvements made between Seventh and Eighth streets, by the East River Ferry Company.

On motion, the Secretary was directed to notify said company that the surface of the pier is to some extent unfit for commercial use, and requesting them to inform this Board if it is their intention to put the pier in proper order, or to leave it in its present unserviceable condition.

A communication was received from J. P. Minster, offering to surrender his lease of the pier at One Hundred and Seventeenth street, Harlem river, purchased by him at public sale held March 13, 1879, in consequence of there being an insufficient depth of water thereat; and, being read,

On motion, the aforesaid offer of said J. P. Minster to surrender lease was accepted, to take effect from 27th ultimo, and the Engineer-in-Chief directed to make requisition for the necessary dredge, scows, and labor to excavate and remove from said premises about 3,000 cubic yards of mud, at a cost not exceeding \$950, and to superintend the work.

The weekly report of Superintendent Butler being read,

On motion, the Engineer-in-Chief was directed to examine and report on the condition of the bulkhead between Seventeenth and Eighteenth streets, East river, and to make the necessary repairs to the outer end of pier at Twenty-third street, East river, and to place a mooring pile on the southeast corner of said pier, in order to moor the Schoolship "St. Mary's," and the Secretary directed to notify Superintendent Butler to call upon the Commissioners in reference to the fence which has been erected by the Harlem Navigation Co. at the pier at One Hundred and Twentieth street, Harlem river.

A communication was received from Alexander & Green, attorneys for John G. Dale, agent, in reference to wharfage accrued at Pier, old 44, North river; and, being read,

On motion, the Secretary was directed to inform said counsel for the Inman Steamship Co. that pursuant to their communication of September 8, ultimo, and of the communication of John G. Dale, agent of said company, of September 9, ultimo, that this Department should claim all the wharfage accrued at the said Pier, old 44, North river, subsequent to August 27, 1879, the said steamship company having become liable for the collecting and payment to the city thereof in said communications.

On motion, Patrick Stafford was appointed a laborer.

On motion, the Board adjourned.

The minutes of the meeting held October 9, 1879, were read and approved.

The following communications were received, read, and,

On motion, laid on the table to await action as stated, to wit:

From Department of Public Works—For permission to place two hydrants at the bulkhead at the Department yard, at East Seventeenth street, in order to supply steam tugs, etc., with Croton water. Engineer-in-Chief directed to examine and report if any objection exists to granting the permission asked for.

From Board of Commissioners of Pilots—Stating that owing to the bad condition of wharf premises at Sixty-second street, East river, much of the sand constantly loaded there falls into the river. Engineer-in-Chief directed to examine and report as to the condition of the premises referred to.

From Police Department—As to the bad condition of the bulkhead at Seventeenth street, East river. Engineer-in-Chief directed to examine and report what repairs are required to be made to the premises, and an estimate of the cost of doing the work.

From Engineer-in-Chief, the following reports:

1st. As to repairs required to Pier at Fifth street, East river. Joseph V. Brown, lessee, requested to call upon the Commissioners in reference to the same.

2d. As to the condition of the bulkhead between Seventeenth and Eighteenth streets, East river.

3d. As to the condition of Pier, old 54, North river.

The following communications were received, read, and,

On motion, placed on file, action being taken where necessary as stated, to wit:

From William H. Webb—In reference to the condition of bulkhead between Thirty-sixth and Thirty-seventh streets, North river, owned by him.

From Police Department—Stating that there are several holes in the surface of Pier 13, East river, and that the premises are dangerous for travel. Secretary directed to notify the owners of said pier to make the necessary repairs thereto without delay.

From Josiah Macy's Sons—For permission to drive piles and repair the bulkhead between Piers 45 and 46, East river. Application granted, the work to be done under the supervision of the Engineer-in-Chief of this Department, within the existing lines of the present structure.

From Health Department—For permission to cut through the string-piece and dock in front of the Reception Hospital, foot of Sixteenth street, East river, for the purpose of constructing a gangway, to facilitate the transfer of patients. Application granted, the work to be done under the supervision of the Engineer-in-Chief of this Department.

From Wm. Cruikshank—Agreeing to terms of resolution adopted October 9th, fixing rent for land under water at Pier 9, North river.

From Martin Karl—For permission to place a coal bin upon pier at Fifty-first street, North river, leased by him. Application denied.

From Engineer-in-Chief, the following reports:

1. Stating that a large amount of dirt upon pier at Fifty-seventh street, North river, should be removed, and that the approach to said pier is in a dangerous condition, and suggesting that earth filling be deposited up to the level of the old dock, to give the sheathing a solid support. Secretary directed to notify Frederick Schecker, lessee, to remove the dirt referred to, and Engineer-in-Chief directed to fill in said approach in accordance with recommendation contained in his report.

2. As to repairs made to Pier 19, East river, communication from S. A. Frost, in reference thereto, taken from the table and placed on file, and the Engineer-in-Chief directed to take up the old plank recently placed upon said pier, and to sheath a space of 65 feet in length by the entire width of the pier with new plank.

3. As to the work performed during week ending October 11, 1879.

4. Stating that the deck of the pier at Twenty-fifth street, North river, is in bad condition, and that an area of 30 x 100 feet should be patched with 4-inch plank. C. T. Van Santvoord, lessee, directed to make the repairs to said pier, under the supervision of the Engineer-in-Chief of this Department.

H. Miller, Jr., lessee, of Pier, old 54, North river, appeared and was heard as to the necessity of repairs being made thereto by this Department.

On motion, the Board adjourned.
