What are we proposing? We are proposing amendments to the Campaign Finance Board's ("Board") rules regarding disclosure, transition and inauguration entities, and the voter guide.

These amendments are being made to streamline the candidate experience and to ensure that the rules comport with amendments to local laws.

This rulemaking was not included in the Board's regulatory agenda for this year.

When and where is the Hearing? The Board will hold a public hearing on the proposed rules online. The public hearing will take place at 2:00 p.m. on January 17, 2023.

#### Statement of Basis and Purpose of Proposed Rules

The Campaign Finance Board (the "CFB" or "Board") is a nonpartisan, independent City agency that empowers New Yorkers to make a greater impact in elections. The CFB administers the City's campaign finance system, overseeing and enforcing the regulations related to campaign finance and holding candidates accountable for using public funds responsibly. The CFB publishes detailed public information about money raised and spent in City elections by candidates and independent spenders, and engages and educates voters through community outreach, the voter guide, and the debate program.

The CFB is proposing amendments to several of its rules regarding disclosure, transition and inauguration entities, and the voter guide. The changes are largely administrative and are intended to streamline the candidate experience and to ensure that the rules comport with amendments to local laws. The following is a summary of the changes. "Shall" and "must" denote mandatory requirements and may be used

interchangeably in the rules of this agency, unless otherwise specified or unless the context clearly indicates otherwise.

#### **Summary of Proposed Rules**

#### **Disclosure**

Section 4-05(b)(ii)(B) is amended to provide that, at the Board's discretion, disclosure statements may be required to be filed on October 15 in the year prior to the year of a primary or general election. This change is to provide campaigns with an additional opportunity to demonstrate eligibility for the first public funds payment in December of that year.

Section 4-05(c)(ii)(C) is amended to clarify that contributions not itemized in disclosure statements are not matchable, even if they would otherwise be subject to the disclosure exemption applicable to contributions totaling \$99 or less from a single source. This amendment is to conform with section 3-703(6)(b)(ii) of the New York City Administrative Code (the "Code").

Section 4-06 is amended to require daily disclosure of contributions aggregating \$1,000 or more and expenditures aggregating \$20,000 or more during the 14 days preceding the election. Previously, the threshold was contributions in excess of \$1,000 and expenditures in excess of \$20,000. This change is made in recognition of the reduced contribution limits pursuant to section 3-703(1)(f) of the Code as amended by Local Law 128 of 2019.

Section 4-07 is amended to clarify that, even after a final statement has been filed, any subsequent financial activity must be reported to the Board in the next semi-annual disclosure statement. Candidates who file a final statement are relieved of the obligation to file semi-annual statements if they have not raised or spent funds during the reporting period, but any subsequent activity (for example, fundraising to pay penalties or costs associated with the post-election audit) must be disclosed to the public and to the Board.

Sections 14-03 and 15-06 are amended to modify the disclosure deadlines applicable to independent spenders in primary, general, and special elections. Independent spenders will now be required to file disclosure statements on a weekly basis during the election year (for primary and general elections) or beginning when the vacancy is declared (for special elections). Disclosure statements are not required if the independent spender had no reportable activity during the reporting period.

#### Transition and Inauguration Entities ("TIEs")

The definition of "transition expenses" in section 1-02 is amended to clarify that re-elected incumbents are permitted to use a TIE to make expenditures in furtherance of their selection as Speaker of the City Council, and to remove the reference to the deadline for incurring transition expenses, which is addressed in section 13-03(b)(iii).

Sections 13-03(b)(iii) and 15-07(a) are amended to clarify the time frame for making transition and inauguration expenditures in general and special elections, respectively. The amendments reflect the Board's existing policy that, notwithstanding the deadlines for incurring transition and inauguration expenses, a TIE may make expenditures after those deadlines for the purpose of paying liabilities incurred prior to those deadlines, fundraising to pay such liabilities, or routine and nominal expenditures associated with and necessary for satisfying such liabilities, terminating the entity, and responding to a CFB audit.

Section 13-03(c)(ii) is amended to clarify that, if a TIE pays its leftover funds to the New York City Election Campaign Finance Fund (the "Fund") in lieu of refunding such funds to its donors, it is characterized as a payment rather than a refund. This is an administrative clarification to reflect the fact that TIEs do not receive public funds.

### **Voter Education and Engagement**

Section 7-06 is amended to provide, pursuant to section 3-705(4) of the Code as amended by Local Law 48 of 2022, that the Board will withhold five percent of a candidate's public funds payments until the final pre-election disclosure statement, and that the five percent withholding will not be paid to any candidate who fails to participate in the video voter guide by providing to the CFB any submissions required for a video statement to be created and published. The requirements for candidate video statements are detailed in Chapter 16 of these rules. Previously, section 3-705(4) of the Code provided for the Board to withhold "up to" 5% of payments, but, as amended by Local Law 48 of 2022, the provision now directs the Board to withhold exactly 5%.

The definitions of "candidate print statement," "candidate video statement," and "election" in section 16-01 are amended to reflect the fact that the CFB issues voter guides for all contested covered elections.

Section 16-02(b)(ii)(A) is amended to provide that candidate video statements must contain the same categories of biographical information regarding the candidate as print statements, and may also include a concise audio description of the candidate. This change is made to conform with sections 1053(a)(3) and 1053(e)(2) of the New

York City Charter (the "Charter"), as amended by Local Law 48 of 2022

Section 16-02(b)(ii)(F) is amended to provide that an American Sign Language translation, and captions in English and other languages required by law, will be provided for each candidate video statement. This change is made to conform with section 1053(e)(3) of the Charter, as amended by Local Law 48 of 2022.

Section 16-02(b)(ii)(G) is amended to provide that whether a candidate video statement satisfies the requirements of these rules is determined by the Board at its sole discretion. This change is made to conform with section 16-02(b)(i)(E) regarding candidate print statements.

A new section 16-02(b)(ii)(I) is added to provide that candidate video statements included in the voter guide will be made accessible to individuals with vision disabilities. This section is added to conform with section 1053(e)(4) of the Charter, as added by Local Law 48 of 2022

Section 16-03(b) is amended to provide that the online voter guide will be published in all languages required by law. This change is made to conform with section 1053(d) of the Charter, as amended by Local Law 48 of 2022.

#### Miscellaneous

Minor technical amendments are made to sections 2-03(a), 4-05(c)(ii) (C), 5-05(j) 6-02(a)(ii)(D), 6-06(e), 7-04(a), 7-07(b), 15-02(d)(viii), and 15-03(e)(i).

#### Text of Proposed Rules

New material is underlined. [Deleted material is in brackets.]

# §1. The definition of "transition expenses" in section 1-02 of chapter 1 of title 52 of the rules of the city of New York is amended to read as follows:

"Transition expenses" means expenses relating to an elected candidate's transition into office for goods and services received, used, or rendered before the elected candidate's date of inauguration. Transition expenses shall be limited to those incurred solely for the purpose of preparing to take office, such as those listed in section 13-03(b)(i)[, and may not be incurred after January 31 in the year after the year of the election, or, in the case of a special election, 30 days after inauguration]. Incumbent elected candidates shall not incur transition expenses, except for expenditures made for the purpose of furthering the elected candidate's selection as Speaker of the City Council

# §2. Subdivision (a) of section 2-03 of chapter 2 of title 52 of the rules of the city of New York is amended to read as follows:

(a) The candidate must notify the Board of any material change in the information required to be listed on the candidate's Filer Registration or Certification, including any new information or any change to any required information, concerning any political committee, bank account, merchant or payment processor account, candidate or treasurer employment, address, telephone number, or email address, in such manner as may be provided by the Board, if such change occurs prior to the covered election or within a period of five years from the filing of a final statement showing satisfaction of all liabilities and disposition of all assets arising from the covered election, including payment of any penalties or repayment of public funds owed to the Board. Such notification must be submitted no later than the next deadline for filing a disclosure statement, or, in the case of changes that occur after the deadline for the [last] final disclosure statement required to be filed, no later than 30 days after the date of the change.

# §3. Subparagraph (B) of paragraph (ii) of subdivision (b) of section 4-05 of chapter 4 of title 52 of the rules of the city of New York is amended to read as follows:

(B) Pre-election disclosure statements are due: (i) 32 and 11 days before the election; [and] (ii) at the Board's discretion, on October 15 in the year before the year of the election; and (iii) at the Board's discretion, on March 15 and the fourth Friday in August in the year of the election.

# §4. Subparagraph (C) of paragraph (ii) of subdivision (c) of section 4-05 of chapter 4 of title 52 of the rules of the city of New York is amended to read as follows:

(C) Contributions totaling \$99 or less from a single source. Contributions totaling \$99 or less from a single source need not be separately itemized in a disclosure statement, unless such contributor is an employee of the candidate or of the spouse, or domestic partner of such candidate or of [a business] an entity in which such candidate, spouse, or domestic partner has an ownership interest of 10% or more or in which such candidate, spouse or domestic partner holds a management position, such as the position of officer, director, or trustee; provided, however, that contributions that are not itemized shall not be matchable.

# $\S 5.$ Section 4-06 of chapter 4 of title 52 of the rules of the city of New York is amended to read as follows:

§4-06. Daily disclosures during the two weeks preceding the election. If a candidate, during the 14 days preceding an election, accepts aggregate contributions and/or loans from a single source [in excess] of \$1,000 or more or makes aggregate expenditures to a single [vendor] payee [in excess] of \$20,000 or more, the candidate must report, in a disclosure to the Board, all contributions and loans accepted from such source or expenditures made to such [vendor] payee during that 14-day period. The first such disclosure must be received by the Board within 24 hours after the contribution or loan that causes the total to [exceed] reach \$1,000 is accepted or the expenditure that causes the total to [exceed] reach \$20,000 is made. Each subsequent disclosure must be received by the Board within 24 hours after any additional contribution or loan is accepted or expenditure is made. Information reported in these disclosures must also be included in the candidate's next post-election disclosure statement.

# §6. Subdivision (a) of section 4-07 of chapter 4 of title 52 of the rules of the city of New York is amended to read as follows:

(a) A candidate must file all disclosure statements required under section 4-05(b) until such time as the candidate files a final statement demonstrating the disposition of all committee assets and satisfaction of all committee liabilities, including the payment of any penalties or repayment of public funds owed to the Board; provided, however, that any financial activity occurring after the final statement has been filed must be reported in the next semi-annual disclosure statement.

# $\S 7$ . Subdivision (j) of section 5-05 of chapter 5 of title 52 of the rules of the city of New York is amended to read as follows:

(j) Contributions with unreported occupation, employer, and business address. Contributions for which the candidate has not reported the contributor's occupation, employer, and business address, where such contributions: (i) total more than \$99; or (ii) total \$99 or less, and the contributor is an employee of the candidate, of the spouse or domestic partner of such candidate, or of [a business] an entity in which such candidate, spouse, or domestic partner has an ownership interest of 10% or more or in which such candidate, spouse, or domestic partner holds a management position, such as the position of officer, director, or trustee.

# §8. Subparagraph (D) of paragraph (ii) of subdivision (a) of section 6-02 of chapter 6 of title 52 of the rules of the city of New York is amended to read as follows:

(D) payments to the candidate or a spouse, domestic partner, child, grandchild, parent, grandparent, [brother, or sister] or sibling of the candidate or spouse or domestic partner of such child, grandchild, parent, grandparent, [brother, or sister] or sibling, or to [a business] an entity in which the candidate or any such person has a 10% or greater ownership interest;

# §9. Subdivision (e) of section 6-06 of chapter 6 of title 52 of the rules of the city of New York is amended to read as follows:

**(e)** Where identification would be [impractical] <u>impracticable</u>. This requirement may be modified by the Board concerning items upon which identification would be [impractical] <u>impracticable</u>.

# §10. Subdivision (a) of section 7-04 of chapter 7 of title 52 of the rules of the city of New York is amended to read as follows:

(a) A candidate shall not be eligible to receive more than one quarter of the applicable maximum pursuant to  $\S$  3-705(2)(b) of the Code unless the Board determines that one of the conditions set forth in  $\S$  3-705(7) (a)(2) or (3) of the Code is satisfied, or the candidate submits a certified signed statement attesting to the need for additional public funds and demonstrating that at least one of the conditions set forth in  $\S$ 3-705(7)(a)(1) of the Code is satisfied. The statement must be filed with the Board no later than the due date [for] of the applicable disclosure statements as follows, except that, if the basis for filing the statement arises after the due date, and no basis existed prior to such due date, then the statement shall be due by the deadline for the disclosure statement immediately preceding the next date on which a public funds payment is scheduled to be made:

- (i) Candidates in the primary election must file the statement of need no later than the due date [for]  $\underline{of}$  the 32-day preprimary election disclosure statement.
- (ii) Candidates in the general election must file the statement of need no later than the due date [for] of the 32-day pregeneral election disclosure statement.

# §11. Section 7-06 of chapter 7 of title 52 of the rules of the city of New York is amended to read as follows:

#### § 7-06 Withholdings[.]

 $(\underline{a})$  The Board [may]  $\underline{shall}$  withhold [up to] 5% of the amount of public funds payable to a candidate until the final pre-election payment for any election in which the candidate is eligible to receive public funds.

Such withheld funds shall not be payable to any candidate who is not otherwise eligible to receive a payment, or who fails to provide, to the satisfaction of the board, such submissions as may be requested by the board for the purpose of publishing a video statement in the voter guide pursuant to chapter 16 of these rules.

(b) In addition, the Board may withhold from pre-election public funds payments: (a) a percentage equal to the projected rate of invalid matching claims; (b) an amount equal to any contributions made, received, solicited, or otherwise obtained in violation of any law, pending disgorgement of such contributions to the Fund or refund to the contributor; and (c) up to an additional 5% if the Board determines that there is reason to believe that the candidate has failed to comply with the Act, including by failing to adequately respond to a Board request for information or documentation. Withholdings shall be subject to post-election audit.

# §12. Subdivision (b) of section 7-07 of chapter 7 of title 52 of the rules of the city of New York is amended to read as follows:

- (b) Disbursements that would otherwise result in a deduction pursuant to paragraph (ii) of subdivision (a) of this section shall not result in any such deduction if:
  - (i) such disbursements are made out of a segregated bank account:
  - (ii) at no time does the segregated bank account contain any funds other than contributions received by the candidate and deposited directly into the account pursuant to this section, and bank interest paid thereon;
  - (iii) funds deposited into the segregated bank account are not used for any purpose other than disbursements governed by paragraph (ii) of subdivision (a) above or payment of bank fees associated with the segregated bank account;
  - (iv) contributors whose contributions are deposited into the segregated bank account have confirmed in writing, pursuant to section 4-01(b)(ii)(B), that they understand that these contributions will only be used for such disbursements and will not be matched with public funds;
  - (v) copies of such written confirmations are submitted to the Board by the due date [for] of the disclosure statement in which such contributions are required to be reported pursuant to these rules;
  - (vi) copies of checks for each disbursement out of the segregated bank account are submitted to the Board by the due date [for] of the disclosure statement in which such disbursements are required to be reported pursuant to these rules:
  - (vii) a copy of each bank statement for the segregated bank account is submitted to the Board by the due date [for] of the next disclosure statement; and
  - (viii) for each individual contribution deposited into the segregated bank account, and each disbursement out of the segregated bank account, the candidate has complied with all other applicable provisions of the Act and these rules, including but not limited to the record keeping and reporting provisions.

# §13. Paragraph (iii) of subdivision (b) of section 13-03 of chapter 13 of title 52 of the rules of the city of New York is amended to read as follows:

- (iii) Transition [liabilities] <u>expenditures</u> may not be incurred [nor expenditures made] after the elected candidate assumes office, and inauguration [liabilities] <u>expenditures</u> may not be incurred [nor expenditures made] after January 31 in the year after the year of the election, except for:
  - (A) [expenditures made to satisfy liabilities incurred on or before January 31,
  - (B)] expenditures related to fundraising to satisfy <u>transition</u> liabilities incurred on or before <u>the elected candidate</u> <u>assumes office or inauguration liabilities incurred on or before</u> January 31, and
  - [(C)] (B) routine and nominal expenditures associated with and necessary for satisfying such liabilities, terminating the entity, and responding to the post-election audit.

# §14. Paragraph (ii) of subdivision (c) of section 13-03 of chapter 13 of title 52 of the rules of the city of New York is amended to read as follows:

(ii) If a TIE has funds remaining after all liabilities have been paid, it shall refund such funds to one or more of its donors, or if that is impracticable, issue a payment to the Fund.

§15. Section 14-03 of chapter 14 of title 52 of the rules of the city of New York is amended to read as follows:

## §14-03. Disclosure dates[.]

- (a) Filing dates[. The Board shall publish a schedule of disclosure statement filing dates and reporting periods for primary and general elections, and for ballot proposals, based on the following:]
  - (i) Disclosure statements are due [on January 15, March 15, July 15, and the fourth Friday in August of the election year.] every Monday of the election year until and including the fourth Monday after the general election.
  - (ii) [Additional disclosure statements are due:
    - (A) For a primary election: 32 and 11 days before and 10 days after the election.(B) For a general election: 32 and 11 days before
    - (B) For a general election: 32 and 11 days before and 27 days after the election.
  - (iii)] During the 14 days before a primary or general election, an independent spender must submit a disclosure statement to the Board within 24 hours of distributing any reportable communication, making any reportable expenditure, or receiving any reportable contribution.
  - [(iv) The Board's published schedule of disclosure statement filing dates shall reflect that if a disclosure statement is due to be submitted on a Saturday, Sunday, or legal holiday, submission shall be considered timely if made on the next business day.]
  - [(v)] (iii) An independent spender that has not distributed any reportable communications, made any reportable expenditures, or received any reportable contributions within a reporting period is not required to file a disclosure statement for that period.

#### (b) Reporting periods[.]

## (i) First disclosure statement[.]

- (A) The reporting period for the first disclosure statement containing communications or expenditures related to candidates in a primary or general election begins on the first day of the election cycle.
- (B) The reporting period for the first disclosure statement for communications or expenditures related to ballot proposals begins on the first day of January in the year in which the proposal appears on the ballot.
- (ii) Each subsequent disclosure statement. The reporting period for each subsequent disclosure statement begins on the [third day before the deadline for the submission of the previous disclosure statement] <a href="mailto:preceding-monday">preceding-monday</a>.
- (iii) Conclusion of reporting period. The reporting period for all disclosure statements concludes on and [include] includes the [fourth day before the deadline for the submission of that disclosure statement] day before the filing due date.
- [(iv) Weekends and holidays. The Board's published schedule of reporting period dates shall reflect that if a disclosure statement is due to be submitted on a Saturday, Sunday, or legal holiday, the reporting period will conclude on and include the fourth day before the next business day.]

# §16. Paragraph (viii) of subdivision (d) of section 15-02 of chapter 15 of title 52 of the rules of the city of New York is amended to read as follows:

(viii) Special election due dates for compliance with  $\S$  12-110 of the Code. The candidate's compliance with the requirements in  $\S$  12-110 of the Code shall be considered timely demonstrated to the Board if the Board receives confirmation of the candidate's compliance on or prior to the due date [for] of the first disclosure statement required to be filed with the Board pursuant to section 15-02(d)(ii).

# § 17. Paragraph (i) of subdivision (e) of section 15-03 of chapter 15 of title 52 of the rules of the city of New York is amended to read as follows:

(i) Public funds received for a special election to fill a vacancy may be used only for expenditures made by a candidate to further the candidate's nomination or election to fill such vacancy, and may not be used for any expenditure that is not qualified as defined in § 3-704 of the Code and section 6-02(a). An expenditure made prior to the date on which a vacancy was declared shall be presumed not to be in furtherance of the [campaign's] <a href="candidate">candidate</a>'s nomination or election, unless the candidate provides evidence demonstrating that the vacancy was reasonably anticipated when the expenditure was made.

# §18. Section 15-06 of chapter 15 of title 52 of the rules of the city of New York is amended to read as follows:

#### §15-06. Independent expenditure disclosure[.]

- (a) [The reporting period for the first independent expenditure disclosure statement in a special election concerning candidates begins on the day the vacancy is declared.] <u>Disclosure statements are due every Monday until and including the fourth Monday after the special election.</u>
- (b) [Disclosure statements are due 32 and 11 days before and 27 days after the election. If the first disclosure statement for a special election is otherwise due within a period of five days of a required disclosure statement, a single combined statement may be filed on the date on which the latter of the two separate statements is required to be filed.] **Reporting period** 
  - (i) Candidate elections. For candidates anticipated to be voted on in a special election, the reporting period for the first independent expenditure disclosure statement begins on the day the vacancy is declared. The reporting period for each subsequent disclosure statement begins on the preceding Monday.
  - (ii) Ballot proposals. For ballot proposals anticipated to be voted on in a special election, the reporting period for the first independent expenditure disclosure statement begins on the date the first reportable expenditure is incurred. The reporting period for each subsequent disclosure statement begins on the preceding Monday.
  - (iii) Conclusion of reporting period. The reporting period for all disclosure statements concludes on and includes the day before the filing due date.
- (c) <u>Daily disclosure</u>. During the 14 days before the election, an independent spender must submit a disclosure statement to the Board within 24 hours of distributing any reportable communication, making any reportable expenditure, or receiving any reportable contribution.
- (d) [For ballot proposals anticipated to be voted on at a special election, additional disclosure statements are due on January 15 and July 15 in the year of the election. The reporting period for the first disclosure statement begins on the date the first reportable expenditure is incurred.] An independent spender that has not distributed any reportable communications, made any reportable expenditures, or received any reportable contributions within a reporting period is not required to file a disclosure statement for that period.

# §19. Subdivision (a) of section 15-07 of chapter 15 of title 52 of the rules of the city of New York is amended to read as follows:

- (a) A special election TIE must not [incur liabilities or] make expenditures after 30 days following the candidate's inauguration, except for [expenditures made to satisfy liabilities incurred within 30 days of inauguration,] expenditures related to fundraising to satisfy [such] liabilities incurred within 30 days of inauguration, or expenditures related to terminating the entity or responding to the post-election audit.
- §20. The definitions of "candidate print statement," "candidate video statement," and "election" in section 16-01 of chapter 16 of title 52 of the rules of the city of New York are amended to read as follows:
- **"Candidate print statement"** means the document filed by a candidate containing biographical and other information requested by the Board, and a photograph of the candidate, for inclusion in the printed or online [primary or general election] Voter Guide.
- **"Candidate video statement"** means a video-recorded statement by the candidate for inclusion in the video and online edition of the [primary or general election] Voter Guide.
- **"Election"** means any [primary or general] election for the office of mayor, public advocate, comptroller, borough president, or Council member, or a general election in which a ballot proposal is on the ballot, and does not include any [special election held to fill a vacancy, or] election held pursuant to court order.

# §21. Subparagraph (A) of paragraph (ii) of subdivision (b) of section 16-02 of chapter 16 of title 52 of the rules of the city of New York is amended to read as follows:

- (A) Candidate video statements must contain [information regarding the candidate's platform and candidacy,] the same biographical information as candidate print statements and may contain such other information as the candidate may choose, including a concise audio description of the candidate; [except] provided, however, that the candidate may not:
- (1) refer to any opposing candidate by name;
- (2) use profanity, or statements, gestures, or materials that are patently offensive, obscene, or pornographic;
- (3) make statements that are slanderous, or defamatory, or assert facts that the candidate knows or should know to be false;

- (4) engage in any commercial programming or advertising;
- (5) display any literature, graphs, or props; or
- (6) violate any city, state, or federal law, including regulations of the New York State Public Service Commission and the Federal Communications Commission.
- §22. Subparagraph (F) of paragraph (ii) of subdivision (b) of section 16-02 of chapter 16 of title 52 of the rules of the city of New York is amended to read as follows:
- (F) Video statements shall be recorded in English. Candidates may record a portion of their video statements in a language other than English if the script submitted for Board approval contains both the English and non-English text and an English translation of all non-English text. No additional time will be allotted for statements recorded in multiple languages. The Board will take such measures as it deems reasonable and necessary to ensure that an American Sign Language translation is available for each video statement and that captions are available for each video statement in English and other languages required by law.
- §23. Subparagraph (G) of paragraph (ii) of subdivision (b) of section 16-02 of chapter 16 of title 52 of the rules of the city of New York is amended to read as follows:
- (G) Candidate video statements that violate any of the requirements outlined in this chapter, as determined by the Board at its sole discretion, will not be included in the Voter Guide.
- §24. A new subparagraph (I) of paragraph (ii) of subdivision (b) of section 16-02 of chapter 16 of title 52 of the rules of the city of New York is added, to read as follows:
- (I) The Board will take such measures as it deems reasonable and necessary to ensure that candidate video statements included in the Voter Guide are accessible to individuals with vision disabilities.
- \$25. Subdivision (b) of section 16-03 of chapter 16 of title 52 of the rules of the city of New York is amended to read as follows:
- (b) The Board will produce an online Voter Guide in English and [make the translated versions of the printed editions available online] Spanish, and in other languages required by law.

What authorizes MOME to promulgate this rule revision? Executive Order 21 of 2022 authorizes MOME to support the economic development of digital media in New York City. Sections 389 (b) and 1043 of the City Charter authorize MOME to issue this proposed rule. This rule was included in MOME's regulatory agenda.

Where can I find MOME's rules? MOME's rules are found in Title 43 of the Rules of the City of New York.

What laws govern the rulemaking process? MOME must meet the requirements of Section 1043 of the City Charter when creating or changing rules. This notice is made according to the requirements of Section 1043(b) of the City Charter.

#### STATEMENT OF BASIS AND PURPOSE OF PROPOSED RULES

The mission of the Mayor's Office of Media and Entertainment ("MOME") is to support and strengthen New York City's creative economy and make it accessible to all. MOME comprises five divisions: the Film Office, which coordinates film and television production throughout the five boroughs; NYC Media, the largest municipal throughout the live boroughs, NTC Media, the largest multicipal television and radio broadcasting entity in the country with a reach of 18 million viewers within a 50-mile radius; the Creative Industries division, which supports industry and workforce development in film, television, theater, music, publishing, advertising, and digital content; the Office of Nightlife, supporting the sustainable development of New York City's nightlife industry; and the Press Credentials Office, which issues access credentials to news media. Overall, MOME programs support the employment of nearly half a million workers in an industry that generates over \$104B in economic activity annually.

The "Made in NY" logo is a federally registered trademark. The City created the "Made in NY" branding initiative as part of the goal to support and grow the media and entertainment industries, and the support and grow the media and entertainment industries, and the initiative includes the logo and credit attribution. In 2013, MOME formally established the "Made in NY" Marketing Credit Program for film and television (the "Film and Television Marketing Credit Program") by rule. The Film and Television Marketing Credit Program offers to "Made in NY" film and television productions opportunities to promote their project in New York City, the top media market in the country. The "Made in NY" logo has also become a mark of distinction in the film and television in the state of the stat in the film and television industry, as well as among New Yorkers.

The global digital gaming industry is projected to record revenues The global digital gaming industry is projected to record revenues of \$180 billion in global sales, making the digital gaming industry larger than the global film and North American sports industries combined, with New York State ranking fifth in total in-state game industry-related economic output across the country. New York City is among the top ten cities in terms of industry presence and number of digital game developers and publishers. According to MOME's New North City Digital Game Industry 2001 Feoremic Impact Study, the York City Digital Game Industry 2021 Economic Impact Study, the digital game industry provides 7,600 jobs in New York City, \$762 million in wages, and \$2 billion in total economic output (business revenues and self-employment receipts).

Given the tremendous potential for the development of this creative industry in New York City, MOME seeks to offer incentives for the production of new digital games in New York City. To that end, this proposed rule would establish a Made in NY Marketing Credit Program for Digital Gaming Media Production. Like the Film and Television Marketing Credit Program, the proposed rule would provide digital game companies with opportunities to promote their projects in New York City, the top media market in the country.

Specifically, the proposed rule would be set forth in a new chapter and would:

- Establish the Made in NY Marketing Credit Program for Digital Gaming Media Production.
- Outline the application process.
- Provide standards for assessing applications.
- Require that recipients provide a cultural benefit in the form of a monetary contribution to a non-profit entity that is on a list established by the New York City Department of Cultural Affairs or has been identified through the New York City Council Participatory Budget process.
- Set forth reporting and record keeping requirements.

§ 19-01 Purpose and general description.

§ 19-02 Definitions.

§ 19-03 Application process.

§ 19-04 Evaluation of applications. § 19-05 Allocation of Made in NY marketing credit for digital gaming media production.

§ 19-06 In-credit requirement; logo; printing costs.

§ 19-07 Appeal process. § 19-08 Final report. § 19-09 Record retention.

#### § 19-01 Purpose and general description.

- (a) The "Made in NY" Marketing Credit Program for Digital Gaming Media Productions ("Program"), established and administered by the Mayor's Office of Media and Entertainment ("MOME"), offers opportunities to "Made in NY" digital gaming media production entities to promote their projects in major media markets that are City-owned assets or are privately owned and operated media outlets with which the City has established relationships. "Made in NY" digital gaming media production entities that apply and are approved for this Program will be provided marketing opportunities through media outlets including, but not limited to, bus shelters and subway cars.
- The purpose of this rule is to outline the application process for the Program. These procedures govern the allocation of marketing credits, standards for assessing evaluations and other provisions necessary and appropriate for administering and fulfilling the purposes of the Program.
- (c) An approved applicant must make a monetary contribution to a listed cultural institution or community organization as a condition for receiving a marketing credit.

#### § 19-02 Definitions.

As used in this rule, the following terms have the following meanings:

Application form. "Application form" means the document made available by MOME that requests information necessary to evaluate an applicant's qualifications for the Program.

Applicant. "Applicant" means a digital gaming media production entity that submits a completed application form to MOME

Certificate of marketing credit. "Certificate of marketing credit" means a certificate issued by MOME that reflects an agreement between MOME and an approved applicant that establishes the amount of media assets for which the approved applicant has qualified and the dates such media assets will run, and that sets forth the terms and conditions for receiving the allocated marketing credit. The certificate of marketing credit includes such information as name. The certificate of marketing credit includes such information as name and address of the approved applicant; name of the qualified digital gaming media production in connection with which the credit applies; the amount of media assets to be received by the approved applicant and the dates such media assets will run; requirements regarding the submission of artwork for the media assets; representations, warranties, and indemnification clauses; the in-credit requirement; reporting requirements; and a disclaimer stating that actual receipt of the marketing credit is subject to availability of media assets for the

Commissioner. "Commissioner" means the Commissioner of the New York City Mayor's Office of Media and Entertainment.

Community benefit. "Community benefit" means a monetary community benefit. Community benefit linears a monetary contribution to a listed cultural institution or community organization of (1) a minimum of \$10,000 (ten thousand dollars) for any qualified digital gaming media production with qualified digital gaming media production costs equal to \$10,000,000 (ten million dollars) or more, and the property of the qualified digital gaming media or (2) 0.1 % (one-tenth per cent) of the qualified digital gaming media production costs for any qualified digital gaming media production having qualified digital gaming media production costs less than \$10,000,000 (ten million dollars).

Digital gaming media production. "Digital gaming media production" means (1) a website, the digital media production costs of which are paid or incurred predominately in connection with (A) video simulation, animation, text, audio, graphics or similar gaming related property embodied in digital format, and (B) interactive features of digital gaming (e.g., links, message boards, communities or content manipulation); (2) video or interactive games produced primarily for distribution over the internet, wireless network or successors thereto; and (3) animation, simulation or embedded graphics digital gaming related software intended for commercial distribution regardless of medium. Some examples of a digital gaming media production include, <u>but are not limited to, the following:</u>

- video or interactive games, including extensions of video games, provided their content is new and playable for an end-user:
- (ii) simulation software;
- (iii) interactive educational or training products; and
- (iv) software applications that provide connectivity and communications between mobile devices and digital gaming media production web platforms.

Digital gaming media production costs. "Digital gaming media production costs" means

any costs for wages or salaries paid to individuals directly employed for services performed by those individuals directly and predominantly in the creation of a digital gaming media production or productions, not exceeding \$100,000 per individual; and

(ii) payments for services performed directly and predominantly in the development (including concept creation), design, production (including testing), editing (including encoding), and compositing (including the integration of digital files for interaction by end users) of digital gaming media.

"Digital gaming media production costs" do not include:

- (i) wages, salaries, or other income distribution paid to any person who serves in the role of chief executive officer, chief financial officer, president, treasurer, or similar position if the applicant has more than ten employees,
- (ii) any income or other distribution including, but not limited to, licensing or royalty fees, to any individual who holds an ownership interest in the applicant, whether or not such individual is serving in the role of chief executive officer, chief financial officer, president, treasurer, or similar position,
- (iii) costs incurred for the acquisition of intellectual property rights of a character from a third party,
- (iv) distribution costs,
- (v) costs incurred in the marketing, promotion or advertising of a digital game, and
- (vi) other costs not directly and predominantly related to the creation, development, design, production, editing, or compositing of a qualified digital gaming media production.

Digital gaming media production entity. "Digital gaming media production entity" means the person who is directly responsible for payment of the direct production expenses of a qualified digital gaming media production.

In-credit requirements. "In-credit requirements" means those acknowledgements within the qualified digital gaming media production that an applicant agrees to provide as a condition for participation in the Program.

Listed cultural institution or community organization. "Listed cultural institution or community organization" means an organization that is recognized by the Internal Revenue Service as tax-exempt pursuant to Internal Revenue Code section 501(c)(3) that is located in New York City and has been identified, either by the New York City Department of Cultural Affairs or through New York City Council Participatory Budgeting, as an organization that supports and strengthens New York City's creative community or neighborhoods.

Marketing credit. "Marketing credit" means an allocation of media assets made available through the Program, that is free of charge to an approved qualified digital gaming media production.

Media asset. "Media asset" means available advertising media including, but not limited to, bus shelters and subway cars that MOME makes available to an approved applicant for a qualified digital gaming media production.

 $\underline{MOME}.$  "MOME" means the New York City Mayor's Office of  $\underline{Media}$  and Entertainment.

 $\underline{ Person.~"Person"~means~an~individual, partnership, corporation~or~other~type~of~legal~entity.}$ 

Program. "Program" refers to the "Made in NY" Marketing Credit Program for Digital Gaming Media Production.

Qualified digital gaming media production. "Qualified digital gaming media production" means a digital gaming media production that meets the following qualifications: (1) at least 75% of its digital gaming media production costs are qualified digital gaming media production costs; (2) its digital gaming media production costs; (2) its digital gaming media production costs are at least \$100,000 per production; and (3) the production was completed no more than twenty-four months prior to the date of application to the Program and is scheduled for its first release no less than 60 days from the date of application.

A "qualified digital gaming media production" does not include a website, video, interactive game or software that is:

- (i) used predominantly for electronic commerce (retail or wholesale purposes other than the sale of video or interactive games),
- (ii) used predominantly for gambling (including activities regulated by a New York gaming agency),
- (iii) used for predominantly for political advocacy purposes, or
- (iv) depicts obscene material as defined in section 235 of the New York Penal Law.

Qualified digital gaming media production costs. "Qualified digital gaming media production costs" means digital gaming media production costs incurred directly in New York City and are attributable to the use of tangible property or the performance of services within New York City directly and predominantly in the creation, production, or modification of a digital gaming media production.

#### § 19-03 Application process.

- (a) The Program application form and directions for applying are available on MOME's website.
- (b) In accordance with MOME's application instructions, an applicant must submit a completed application form after its qualified digital gaming media production was completed and no more than 24 months after completion and at least sixty days prior to the first release date. The applicant must include information about the first date that the qualified digital gaming media production is set to be released either in stores, on digital platforms or through any and all other media.
- (c) The application form is not deemed complete until all questions have been fully addressed by the applicant and any additional supporting documents requested by MOME have been provided in a manner sufficient to allow MOME to properly evaluate the application.
- (d) Applications that are complete will be reviewed by MOME in the order they are received. If MOME receives more than one application on the same date, priority will be given to the applicant having the earliest anticipated date of first release of the qualified digital gaming media production.
- (e) MOME will approve or disapprove the application based upon criteria set forth in §19-04(a) of these rules.
- (f) No later than twenty business days from receipt of the application, MOME will inform the applicant in writing if its request has been approved or denied. If approved, the notification will include a certificate of marketing credit. MOME will not provide the allocated marketing credits unless and until the certificate is signed and returned by the applicant within five business days.

#### § 19-04 Evaluation of applications.

- (a) In order to be approved for marketing credit, each of the following requirements must be satisfied:
  - (1) the application is complete;
  - (2) MOME has determined that the applicant's project is a qualified digital gaming media production;
  - (3) the application was received by MOME no more than twenty-four months after the qualified digital gaming media production was completed and at least sixty days prior to the first release date;
  - (4) the applicant has identified a listed cultural institution or community organization as the recipient of its Community Benefit;
  - (5) the applicant agrees to comply with Program requirements, including the in-credit requirement; and
  - (6) the digital gaming media production entity has not been awarded Program marketing credits within the 365 days preceding submission of its application.
  - (b) If all of the requirements set forth in this section are not met, or if MOME concludes that the applicant has knowingly submitted false or misleading information, MOME will disapprove the application.

# §19-05 Allocation of "Made in NY" marketing credit for digital gaming media.

- (a) When an application has been approved, MOME will issue the certificate of marketing credit to the approved applicant.
- (b) MOME will allocate the credit based on a project's qualified digital gaming media production costs, tiers to be established by the Commissioner and posted on MOME's website, and MOME's availability of media assets.
- (c) If the approved applicant is unable to use the media assets for the dates specified in the certificate after the credit has been allocated or does not sign and return the certificate of marketing credit within five business days of MOME's issuance, such approved applicant will lose its "first come, first served" status and will be accommodated subject to availability without guarantee of reallocation.

### §19-06 In-credit requirement; logo; printing costs.

(a) In-credit requirement. Each recipient of a marketing credit must include the "Made in NY" logo in a qualified digital gaming media production in a location readily accessible and easily readable by the end user or in another manner acceptable to the Commissioner. The

phrase "The `Made in NY' logo is a trademark of the City of New York and is used with the City's permission" must appear along with the "Made in NY" logo unless waived by the Commissioner.

- (b) the "Made in NY" logo in all artwork provided for bus shelters, subway cars, and other media assets provided pursuant to this Program.
- An approved applicant must pay for the costs, if any, of printing materials for distribution through the media assets assigned under the Program if (1) the qualified digital gaming media production costs are \$10 million or more; or (2) more than five percent of the beneficial ownership of the qualified digital media production entity is owned directly or indirectly by a publicly traded entity; or (3) the qualified digital media production entity has more than \$35 million in annual revenue.

## §19-07 Appeal process.

- (a) If an applicant's application is disapproved by MOME, or if an approved applicant disagrees with the amount of the media assets granted by MOME, such person may appeal such determination.
- (b) In the case of an appeal from a disapproval of an application, an applicant can request an appeal by sending a letter to the Mayor's Office of Media and Entertainment, Attn: Commissioner, to the address and by the means specified in the application form, within thirty days from the date of the denial letter issued by MOME.
- (c) In the case of an appeal from a determination of the amount of media assets, an approved applicant can request an appeal by sending a letter to the Commissioner, as provided in subdivision (b), within thirty days from the date of issuance of the certificate of marketing credit.
- If an applicant fails to request an appeal within thirty days of MOME's denial decision and/or allocated amount of media assets, such decision will be deemed final
- (e) Upon receipt of a timely letter of appeal, the Commissioner will appoint an appeal officer within MOME to review the matter. The appeal officer may reverse, affirm or modify the original determination and provide a written explanation of their finding in a report to the Commissioner. The Commissioner or their designee must issue a final order in writing within sixty days of the report. A copy of the final order will be issued to the appellant within ten days after the date the Commissioner or their designee renders the final order.

## §19-08 Final report.

As part of the Community Benefit component of the Program, within thirty days after the completion of a marketing credit recipient's media campaign, such recipient must submit to MOME by U.S. mail or email proof of payment to a listed cultural institution or community organization, in the form of a cancelled check or letter of acknowledgment. A recipient that has not satisfied this component of the Program will be required to make a payment to MOME in an amount equivalent to 100% of the value of the media assets received, as determined by MOME.

#### §19-09 Record retention.

Each marketing credit recipient must maintain records, in paper or electronic form, of any qualified digital gaming media production's costs used to calculate the media assets received through this Program for a minimum of three years from the date of filing of the tax return applicable to the time period for which such recipient claims the marketing credit. MOME has the right to request such records upon reasonable notice.

NOTIFICATION IS HEREBY GIVEN to the public of the intent of the Department of Homeland Security-Federal Emergency Management Agency (DHS-FEMA), to provide Federal funding to the New York City Department of Environmental Protection (NYCDEP) as Subrecipient for financial assistance to install flood control measures, including nature-based detention and retention basins, at eight locations within the Clinton Houses public housing development in the Manhattan neighborhood of East Harlem. Funds are being requested through the Building Resilient Infrastructure and Communities (BRIC) grant program. The purpose of the BRIC grant program is to proactively invest in hazard mitigation projects, reducing the risks that communities face from disasters and natural hazards. This notification is given in accordance with Executive Order (EO) 11988 (Floodplain Management), EO 11990 (Protection of Wetlands), the Federal Coastal Zone Management Act, and 44 CFR Part 9, regulations for implementing EO 11988 and EO 11990.

The proposed project entails the installation of eight sites with green infrastructure interventions at the Clinton Houses development. These interventions will include infiltration-based stormwater system units placed under and above existing open spaces such as basketball courts, parking lots, and other locations. A conveyance system comprising of inlets, perforated pipes, spreader tanks and small bioretention nature-based channels will be utilized to route the rainfall runoff from the Clinton Houses development and surrounding streets into the eight sites. Several sites may also include "water squares," which will allow for water to be stored above ground (up to one foot) in the proposed locations. These sites will be integrated into the community as multi-functional open spaces able to store excessive rainfall runoff while incorporating green infrastructure and nature-based designs.

This action would take place within the 100-year floodplain per the current preliminary flood insurance rate map, which means that the action has the potential to affect, or be affected by, the floodplain. Alternatives considered include: 1) taking no action and 2) the proposed alternative to install the green infrastructure at the Clinton Houses development. FEMA, has determined that the proposed alternative is the most practicable to combat the increasing threat of stormwater flooding that is known to impact this community. FEMA has also determined that investment of funds to reduce flood risk is in the public interest. Potential impacts to water quality or aquatic habitat are anticipated to be negligible during construction and minimized through best management practices and conservation measures incorporated from resource agency recommendations and required regulatory permits.
