The reconstruction will include repair of glaze spalls, replacement of lead joint covers at upward facing joints, resetting displaced terra cotta units, and repointing mortar to match historic intent. The interior flooring will be restored through composite patching. Conduits at the cornice will be reset to allow adequate water drainage. The stone baluster at the dock terrace will be stabilized. A new HVAC system will be also installed.

#### Special floor area regulations

- (a) In certain #Commercial Districts# and in #Manufacturing Districts# paired with a #Residence District#, as shown on Map 2 of the Appendix to this Chapter, for any #zoning lot# containing #residential# #floor area#, the maximum #residential# #floor area ratio# shall be modified as follows:
  - (1) for #zoning lots# complying with the applicable provisions of paragraph (d)(3) of Section 23-154 (Inclusionary Housing) or, for #affordable independent residences for seniors#, the maximum #residential# #floor area ratio# set forth on Map 2 shall apply;
  - for #zoning lots# utilizing the provisions of paragraphs (d)(4) (i) or (d)(4)(iii) of Section 23-154, the maximum #residential##floor area ratio# shall apply as modified in the table below:

Maximum #residential# #floor area ratio# shown on Map 2	Modified maximum #residential# #floor area ratio#
8.5	7.52
9.0	7.52
10.0	9.0

- (3) except in C2 Districts subject to the provisions of paragraph (b) of this Section, the maximum #floor area ratio# for any combination of #uses# shall be the maximum #floor area ratio# specified in paragraphs (a)(1) or (a)(2) of this Section, whichever is applicable; and
- (4) in C4-6 Districts and in C2 Districts mapped within an R9 or R10 District, the #floor area# provisions of Sections 33-13 (Floor Area Bonus for a Public Plaza) or 33-14 (Floor Area Bonus for Arcades) shall not apply.
- (b) In C2 Districts mapped within an R7D District that is also located within 100 feet of Park Avenue, the maximum #community facility# #floor area ratio# shall be 6.5, except that the applicable provisions of paragraph (d) of Section 33-121 (In districts with bulk governed by Residence District bulk regulations) shall apply to #zoning lots# containing philanthropic or non-profit institutions with sleeping accommodations or #long-term care facilities#.
- (c) In the C4-6 District that is located on the west side of Third

  Avenue between East 121st Street and East 122nd Street, the

  maximum #commercial# #floor area ratio# shall be 7.2.
- (d) For #transit-adjacent sites# or #qualifying transit improvement sites#, in the event of a conflict between the provisions of this Chapter and the provisions of Article VI, Chapter 6 (Special Regulations Applying Around Mass Transit Stations), the provisions of Article VI, Chapter 6 shall control. For the purposes of this paragraph, defined terms additionally include those in Section 66-11 (Definitions).

#### Special Permit for Accessory Off-street Commercial Loading Spaces

Within C4-6 Districts, the City Planning Commission may, by special permit, allow a reduction or waiver in the number of required loading berths, provided that:


- (a) curbside deliveries will not create or contribute to serious traffic congestion or unduly inhibit vehicular or pedestrian movement and will not interfere with the efficient functioning of nearby #uses#; and
- (b) an efficient goods receiving system will be implemented within the #commercial# establishment to expedite the movement of goods from the curb to areas within the establishment.

The Commission may prescribe appropriate conditions and safeguards to minimize adverse effects on the character of the surrounding area.

Map 1: Special East Harlem Corridors District and Subdistrict [EXISTING MAP]






#### Map 2: Maximum Residential Floor Area Ratio



MAP 2. MAXIMUM RESIDENTIAL FAR







Map 3: Maximum Height









#### NOTICE OF ADOPTION OF FINAL RULE

NOTICE IS HEREBY GIVEN PURSUANT TO THE AUTHORITY VESTED IN THE COMMISSIONER OF THE DEPARTMENT OF ENVIRONMENTAL PROTECTION by Section 1403(c) of the New York City Charter and Sections 24-105 and 24-149.5 of the New York City Administrative Code, that the Department of Environmental Protection has amended its rules to require control devices to reduce emissions from cook stoves at food service establishments, which stoves were in existence prior to May 6, 2016. These amendments were proposed and published in the City Record on June 26, 2023, and a public hearing was held on July 27, 2023. A large number of comments were received. Many were supportive of the rule, and others expressed concerns as to the cost of compliance.

#### Statement of Basis and Purpose

Local Law Number 38 for the year 2015 amended Title 24 of the Administrative Code of the City of New York, the "Air Code," by adding a new Section 24-149.5, which provides that cook stoves used at food-service establishments must have an emission control device for odors, smoke, and particulates that meets the requirements of rules established by the Department.

DEP is promulgating these rules, as required by Section 24-149.5, to reduce particulate matter released into the environment, which

is a known cause of asthma and other respiratory complications. In accordance with Section 24-105 of the Administrative Code, an advisory committee was consulted in the development of these rules. The committee includes representatives from the restaurant and related industries, representatives of the environmental protection and environmental justice communities, and experts in the health effects of pollutants associated with cooking devices. In addition, and also pursuant to Section 24-105, the Department considered the availability and cost of emissions control devices when developing these rules.

Cook stoves that were installed after Section 24-149.5 took effect in May 2016 are subject to the rules set forth at 15 RCNY Chapter 38, which were promulgated in May 2017. This rule governs cook stoves that were installed prior to May 6, 2016. Section 24-149.5 required this rule to be promulgated before January 1, 2020. The advisory committee and DEP were unable to finalize a rule in that timeframe due to the difficulty of crafting a rule to manage technical and cost concerns that are attendant to the installation of emission control devices. For example, costs for controls for existing cook stoves can be difficult to manage as the spaces in which these cook stoves operate are often aging structures that were not designed to accommodate emission control devices. In addition, many of the locations where existing cook stoves are used are not owned by the operators of the cook stoves, and changes required to install such devices require obtaining the landlord's permission. The advisory committee took additional time to consider these practical concerns in the process of crafting the rule. The rulemaking was further delayed due to the difficulty of convening the advisory committee during the Covid-19 pandemic.

The rule provides that the operators of cook stoves that were installed prior to May 6, 2016 must hire a professional engineer or registered architect to assess the feasibility of installing emission controls on the cook stove to achieve a 75% reduction in particulate emissions (except as provided in the next paragraph). If this assessment concludes that a reduction of 75% or more cannot be achieved, or that no emissions controls can be installed, the assessment must identify any emission controls that could provide a reduction of at least 25% or an explanation for why no emission controls can be installed.

In response to public comments concerning the cost of conducting the assessment, the final rule allows installation of a control device that is already on the list of emission control devices approved by the Fire Department and DEP without requiring that an assessment be performed first.

A comment was also received regarding the field testing requirements in section 62-05. In response to this comment, the final rule makes changes to that section to clarify that 20 liters is a minimum sample size, that ten minutes is a minimum time period for drawing samples, and that fiber filters used in the testing process can be glass or PVC. The final rule also makes changes to section 38-02, which applies to new cook stoves, to conform the testing requirements in that chapter to those in Chapter 62.

Finally, the rule amends the definition of "cook stove" in 15 RCNY section 38-01, which applies to new cook stoves, to conform it to the definition in Chapter 62.

Consistent with the above, DEP promulgates the following amendments to 15 RCNY Chapter 38, as well as a new rule to be found at 15 RCNY Chapter 62.

The Rule is authorized by Section 1043 of the Charter of the City of New York and sections 24-105 and 24-149.5 of the Administrative Code.

The text of the Rule follows.

Section 1. The definition of "cook stove" in section 38-01 of title 15 of the Rules of the City of New York is amended to read as follows:

**Cook stove** means any wood fired or anthracite coal fired appliance used [primarily for cooking food for onsite consumption at a food service establishment, as such term is defined in 24 RCNY Health Code § 81.03] for the preparation of food intended for onsite consumption or retail purchase.

- §2. Item (C) of subparagraph (iii) of paragraph (1) of subdivision (c) of Section 38-02 of title 15 of the Rules of the City of New York is amended to read as follows:
- C. Samples must be taken using the Optical Particle Counter (OPC), and shall be taken for ten minutes at 2 liters per minute pump speed, twice with the unit on and twice with the unit off. If the OPC is equipped with a filter assembly, a new glass or PVC fiber filter shall be used for each test. If the OPC is equipped with RH correction function, it should be enabled when the humidity is expected to exceed 50 percent.
- §3. Items (C) and (D) of subparagraph (iv) of paragraph (1) of subdivision (c) of Section 38-02 of title 15 of the Rules of the City of New York is amended to read as follows:
- C. A minimum 20 liter sample shall be drawn into a 37mm glass or

<u>PVC</u> fiber filter. The sample should be drawn for <u>at least</u> ten minutes at 2 liters per minute pump speed, twice with the unit on and twice with the unit off. Filters should be changed for each test.

D. Except as otherwise expressly provided in this subparagraph (iv), samples shall be taken in accordance with the following Sections of NIOSH Method 0500, Issue 2, August 15, 1994: "Equipment" Section (except that a 37mm glass o<u>r PVC</u> fiber filter should be used), "Preparation of Filters" Section, "Sampling" Section (except that the total sample volume shall be 20 liters), and "Sample Preparation" Section.

§4. Title 15 of the Rules of the City of New York is amended by adding a new Chapter 62, to read as follows:

#### Chapter 62

#### **Emissions Reduction Technologies for Existing Cook Stoves** §62-01 Definitions

Access Point means that which enables a device, appliance or equipment to be reached by ready access or by a means that first requires the removal or movement of a panel, door or similar obstruction.

Air Filtration Device means a device composed of fibrous materials which removes solid particulates.

CFM means cubic feet per minute.

Cook Stove means any wood fired or anthracite coal fired appliance used for the preparation of food intended for onsite consumption or retail purchase.

Discharge Point means the point at which particulate matter is released from a stack into the open air.

Electrostatic Precipitator (ESP) means a filtration device that removes fine particles, such as dust and smoke, from a flowing gas using the force of an induced electrostatic charge minimally impeding the flow of gases through the unit. An ESP is a type of emissions control device.

Emissions Control Device means any equipment used for collecting or confining particulate matter for the purpose of preventing or reducing the emission of such particulate matter into the open air.

Existing means installed before May 6, 2016.

New means installed on or after May 6, 2016.

NFPA means National Fire Prevention Association.

Optical Particle Counter (OPC) means an instrument based on the principle of light scattering from particles. It is a real time instrument that is used to measure particles above 0.05 µm in diameter.

Particulate Matter (PM) means a complex mixture of tiny particles that consists of dry solid fragments, solid cores with liquid coatings, and small droplets of liquid. These particles vary greatly in shape, size and chemical composition, and can be made up of many different materials such as metals, soot, soil, and dust. PM 10 describes inhalable particles, with diameters that are generally 10 micrometers and smaller.

Peak Load means twenty percent additional solid fuel is added to the amount of fuel that is normally used for cooking in the cook stove.

RH Correction Function refers to relative humidity correction. When this function is enabled, the particle growth effect due to high humidity is corrected by computing the mass concentration based on the original dry environment particle population.

Smoke means small gas-borne and airborne particulate matter arising from a process of combustion in sufficient number to be visible.

Stack means any duct, control equipment exhaust or similar apparatus, which vents gases and/or PM into the open air.

Test Port Plate (TPP) means a template cover that is designed to prevent any of the air stream from escaping when the existing access plate is removed and which has an opening for the test probe to fit securely through the material (e.g. cardboard or plexi-glass).

Total Suspended Particulates (TSP) means small airborne particles such as dust, fume and smoke with diameters less than 100 µm.

Treated firewood shall have the same meaning as set forth in paragraph 13 of section 192.5 of title 6 of the New York Code Rules and Regulations.

Underwriters Laboratories (UL) means an American worldwide safety consulting and certification company.

Wet Scrubber System means any emission control device that mixes an aqueous stream or slurry with the exhaust gases from an indirect heat exchanger to control emissions of particulate matter (PM).

§ 62-02 Assessment to Determine Control Technology for

#### **Existing Cook Stoves**

(a) No person shall operate an existing cook stove that was installed prior to May 6, 2016, without hiring a professional engineer or registered architect licensed under Sections 7202 or 7302 of the Education Law to conduct and submit a feasibility analysis of installing an Emissions Control Device as set forth in this section to reduce such cook stove's total PM emissions by 75 percent or more. The feasibility analysis must detail the Emission Control Devices, if any, that can be installed be submitted to the Department within one year of the effective date of this rule. A feasibility analysis is not required if an emission control device that is on the Fire Department's and the Department's approved list of emission control devices found at: https://www.nyc.gov/assets/fdny/downloads/pdf/business/coa-pcus-and-air-cleaners.pdf and https://www.nyc.gov/assets/dep/downloads/pdf/air/approved-cook-stove-technology.pdf is installed.

(b) Except as otherwise provided in this section, if the assessment submitted pursuant to subdivision (a) of this section determines that one or more Emission Control Devices can be installed to reduce an existing cook stove's total PM emissions by 75 percent or more, the Emission Control Device, or Emission Control Devices if more than one is required, must be installed within 180 days of the date on which such assessment is submitted to the Department. Any Emission Control Device that is installed must be certified by the Department in accordance with section 62-07 of this chapter and installed in accordance with the requirements of this chapter.

(c) If the assessment submitted pursuant to subdivision (a) of this section concludes that one or more Emission Control Devices can be installed to reduce an existing cook stove's total PM emissions by at least 25 percent but less than 75 percent, such assessment must describe the Emissions Control Devices that can be installed to achieve such reduction, and such Emissions Control Devices shall be installed prior to operation of the cook stove in accordance with the requirements of this chapter. After installation of such Emission Control Devices, the operator must conduct another assessment in accordance with subdivision (a) of this section within two years of the date on which the Emission Control Devices were installed to determine if additional Emission Control Devices can be installed to reduce such existing cook stove's total PM emissions by at least 75 percent.

(d) If the assessment concludes that no Emission Control Device can be installed on an existing cook stove or that any Emission Control Devices that can be installed cannot achieve a reduction of the existing cook stove's total PM emissions by at least 25 percent, the assessment must include an explanation for this conclusion, and the applicant must submit a variance petition in accordance with the procedures set forth in Section 24-110 of the Administrative Code of the City of New York.

### § 62-03 Control Devices to Reduce Emissions from Existing Cook Stoves

The following are the approved technologies that may be used to achieve a 75 percent reduction in PM 10:

(a) Wet Scrubbers Systems and Air Filtration Devices must comply with UL 1978 (2010) and be correctly sized for the cooking appliance as specified by the manufacturer of the cook stove.

(b) Electrostatic Precipitators must comply with UL 867 (2011) or UL 710 (2012), must have a certificate of approval from the Fire Department, and must be correctly sized for the cooking appliance as specified by the manufacturer.

#### § 62-04 Compliance Requirements:

(a) Existing cook stoves that are solid fuel-fired ovens must be certified in accordance with UL 2162 (2001), "Outline of Investigation for Commercial Wood-Fired Baking Ovens-Refractory Type" and comply with the New York City Construction Codes.

(b) Fans that are used in conjunction with an Emissions Control Device must be listed and labeled in accordance with UL 762 (2010) and UL 705 (2004).

(c) Where a Type I hood, as defined in the New York City Construction Code, or other approved type of exhaust system acceptable by the Department of Buildings, is installed, the exhaust system must be designed and constructed so that the CFM rate of exhaust is equal to or greater than:

(1) The manufacturer's UL listed exhaust rate for the extra heavy duty class of appliance; and

(2) The lowest acceptable ventilation rate for the UL listed appliance exhaust requirement.

(d) A Type I hood must comply with Section 507 of the New York City Mechanical Code (2022). Listed and labeled UL solid fuel-fired ovens that are constructed of solid masonry or reinforced Portland or refractory cement concrete, that are vented by natural draft or a power chimney system in accordance with NFPA 211 (2013) and that are installed in accordance with the manufacturer's instructions and NFPA

96 (2013) are exempt from using a Type I hood.

(e) Only treated firewood, as defined in this rule, shall be used if the fuel source is for the cook stove is wood.

#### § 62-05 Testing Requirements for Emission Control Devices

Field testing must be performed on any Emissions Control Device that is not found on the preapproved list as set forth in §62-02 before it can be used to reduce emissions from an existing cook stove. This one-time testing may be performed in the field using the following procedures described in this paragraph or in the laboratory as specified in paragraph two of this section. Those devices that meet the EPA specifications will then be listed on the Department's and the Fire Department's approved list and will not require field testing.

#### (a) Field Testing:

(1) Emissions Reduction Standard. Field test data must show that the Emissions Control Device has reduced the existing cook stove's total PM emissions by 75 percent or more except as set forth in subdivision (a) of section 62-02 of this chapter.

(2) General Requirements. Field testing must be performed during peak load, using an OPC or NIOSH 500 for TSP. Peak load assumes that unburnt wood or anthracite coal is introduced at the start of the testing and that the same composition of unburnt wood or coal and embers is maintained during the testing. Sampling must be performed with the Emissions Control Device on and off.

(3) Air Filtration Devices and Electrostatic Precipitators:

(A) For AFDs or ESPs, when taking samples while the unit is on, readings must be taken from within the clean out Access Point downstream of the device, or at the Discharge Point. When taking samples while the unit is off, samples must be taken upstream of the Emissions Control Device.

(B) A field tester must remove the access plate and replace with a Test Port Plate and place the sampling probe inside a precut hole, or place the probe directly within the Discharge Point.

(C) Samples must be taken using the OPC, and must be taken for ten minutes at two liters per minute pump speed, twice with the unit on and twice with the unit off. If the OPC is equipped with a filter assembly, a new glass or PVC fiber filter must be used for each test. If the OPC is equipped with RH correction function, it should be enabled when the humidity is expected to exceed 50 percent.

#### (4) Wet Scrubbers Systems:

(A) For Wet Scrubbers Systems, samples must be taken from within the clean out Access Point or Discharge Point.

(B) A field tester must remove the access plate and replace with a Test Port Plate and place the sampling probe inside through a cutout hole, or place the sampling probe directly within the Discharge Point.

(C) A minimum 20 liter sample must be drawn into a 37mm glass or PVC fiber filter. The sample should be drawn for ten minutes at two liters per minute pump speed, twice with the unit on and twice with the unit off. Filters should be changed for each test.

(D) Samples must be taken in accordance with the following sections of NIOSH Method 0500, Issue 2, August 15, 2004: "Equipment" section (except that a 37mm glass or PVC fiber filter should be used), "Preparation of Filters" section, "Sampling" section (except that the total sample volume must be a minimum 20 liters), and "Sample Preparation" section.

(E) The filters must then be collected and the weight of the filters must be determined by an Industrial Hygienist in an EPA accredited laboratory.

(b) Laboratory Testing. Laboratory testing must be performed in a National Environmental Laboratory Accreditation (NELAC) or New York State Department of Health Environmental Laboratory Approval Program (ELAP) certified Laboratory and must follow, EPA Method 5, Appendix A-3 to 40 CFR Part 60 or Method 202, Appendix M to 40 CFR Part 51, for particulate matter. During each test, samples must be collected from the outlet of the control device. Laboratory test data must show that the Emissions Control Device has reduced the cook stove's total PM emissions by 75 percent or more, except as set forth in subdivision (b) of section 62-02 of this chapter.

#### (c) Reporting Requirements:

- (1) The results of the testing required by this section must be submitted on forms prescribed by the Department available on the Department's website and must include the following information:
  - (A) Name and address of the manufacturer of the existing cook stove, brand name, trade name, model number of the cook stove, any additional equipment installed to enhance or support the operation of the Emissions Control Device, the maximum air flow rate, and other relevant operating conditions during the test, as specified by the department.
  - (B) A description of the Emissions Control Device used on the existing cook stove model being certified.
  - (C) A statement that testing has been conducted in accordance with the requirements of this section.
- (2) Additional reporting requirements for field testing conducted in accordance with paragraph one of subdivision (c) of this section. For AFDs and ESPs, the installer of the Emissions Control Device must submit a printout to the Department with the readings of TSP, and also submit pictures of the filter with the unit on and off. For Wet Scrubber Systems, complete laboratory results must be submitted to the Department to document the reduction in PM.

### § 62-06 Emissions Control Device and Cooking Exhaust System Maintenance

- (a) Any Emissions Control Device installed or operated under this chapter must be operated, cleaned, and maintained in accordance with the manufacturer's specifications.
- (b) Every Emissions Control Device installed or operated pursuant to this chapter must be inspected, cleaned and serviced in accordance with Section 609.5.3 of the New York City Fire Code (2022) by a person holding a FDNY Certificate of Fitness as a Commercial Kitchen Exhaust & Precipitator Cleaning Technician.
- (c) The cooking exhaust system must be inspected, cleaned and serviced in accordance with Section 609.5.3 of the New York City Fire Code (2022) by a person holding a FDNY Certificate of Fitness as a Commercial Kitchen Exhaust System Cleaning Technician.

#### § 62-07 Emissions Control Device Certification

(a) The manufacturer of an Emissions Control Device may seek

- Department certification by submitting documentation that field testing has been conducted in accordance with the procedures in subdivision (a) of section 62-05 of this chapter and that such device meets the requirements of section 62-02 of this chapter. Such documentation must be submitted in accordance with the requirements of subdivision (c) of section 62-05 of this chapter.
- (b) Additionally, the manufacturer or owner of an Emissions Control Device may seek Department certification by submitting documentation from an independent testing laboratory that tests in accordance with an EPA accredited laboratory testing method that the Emissions Control Device has been tested in accordance with the procedures set forth in subdivision (b) of section 62-05 of this chapter and that such device meets the requirements of section 62-02 of this chapter. Such documentation must be submitted in accordance with the requirements of subdivision (c) of section 62-05 of this chapter.
- (c) The Department will maintain a list of approved certified Emissions Control Devices for use with particular models of cook stoves on the department's website and will update the list periodically as necessary.

#### § 62-08 Records

(a) Recordkeeping:

- (1) On or after the effective date of this rule, any person who owns or operates an existing cook stove must maintain records showing all maintenance work performed on the Emissions Control Device, including the date, time, and a brief description of maintenance work performed.
- (2) On or after the effective date of this rule, any person who owns or operates an existing cook stove must maintain records regarding the date of installation and replacement of any Emissions Control Device installed to abate emissions from the cook stove.
- (3) For purposes of this subdivision, maintenance includes, but is not limited to, preventative maintenance, breakdown repair, and cleaning performed on the Emissions Control Device.
- (b) Retention of Records. All records required by this section must be retained for at least one year and must be made available to the Department upon request.
- §5. This rule shall take effect six months after it is promulgated in accordance with the requirements of the city administrative procedure act.

#### Statement of Basis and Purpose

The Department's Division of Disease Control conducts disease surveillance and control activities for most of the diseases required to be reported pursuant to Article 11 (Reportable Diseases and Conditions) of the Health Code. The Division of Disease Control also enforces Article 13 (Clinical Laboratories) of the Health Code, which regulates the performance of laboratory tests and reporting of test results. In addition, the Department is required to comply with various provisions of Part 2 of the New York State Sanitary Code, found in Title 10 of the New York Codes, Rules and Regulations, with respect to control of communicable diseases.

To conduct more effective, timely and complete disease surveillance and control, the Department is proposing that the Board amend Article 13 of the Health Code as described below.

#### Syphilis reporting

The Department is requesting that the Board amend Health Code  $\S$  13.03(b)(2) to require laboratories to report all negative syphilis test

results and to simplify reporting requirements when laboratories perform required follow-up testing. The Health Code currently requires the reporting of all positive and indeterminate syphilis test results, but only some negative syphilis test results. Collecting all negative syphilis test results will improve diagnosis and treatment of patients and their sexual partners.

In 2021, there were 9,965 reported cases of syphilis among New York City residents. Without appropriate treatment, syphilis can damage the heart, brain and other organs and can be life-threatening. Testing and diagnosis of syphilis is complex. Accurate diagnosis often requires an assessment of multiple types of tests and a review of testing history to determine whether a patient is currently infected and, if they are, their disease stage and treatment regimen. Without knowledge of prior negative test results, a reinfection can be misinterpreted as evidence of prior infection, delaying treatment and increasing the risk of disease progression, poor health outcomes and disease transmission. Since a syphilis diagnosis triggers contact tracing (notifying sexual partners and offering testing), delays in diagnosis can also impact partners' health and further increase the risk of onward transmission.

In addition, having all negative syphilis test results would allow the Department to monitor compliance with the Health Code requirement for providers to test pregnant persons for syphilis during 28 to 32 weeks of pregnancy (see, Health Code § 11.33). This requirement was added to the Health Code in 2019 to reduce the risk of congenital syphilis, which is preventable with timely identification and treatment of syphilis in the pregnant person. Reporting of all syphilis test results would allow the Department to identify providers in need of education regarding the testing requirement, thus advancing efforts to reduce cases of congenital syphilis in New York City. Having negative test results would also help the Department monitor whether infants exposed to syphilis receive appropriate follow-up testing, consistent with Centers for Disease Control and Prevention guidelines.

The Department also proposes additional changes to simplify reporting requirements where follow-up syphilis testing is performed following an indeterminate test result. With reporting of all syphilis test results, separate reporting rules will not be needed when specimens are referred to another laboratory for additional testing. This reporting change will streamline reporting for laboratories and improve reporting accuracy.

#### Hepatitis B Reporting

The Department is requesting that the Board amend Heath Code  $\S$  13.03(b)(3)(B) to require laboratories to report all hepatitis B e antigen and all hepatitis B surface antigen test results, including negative and indeterminate results. The Health Code currently requires, pursuant to  $\S$  13.03(a), the reporting of all positive test results for any disease or condition required to be reported pursuant to Article 11, including hepatitis B. Additionally, the Health Code currently requires, pursuant to  $\S$  13.03(b)(3)(B), laboratories to report all hepatitis B DNA test results, including positive, negative and indeterminate results, and further requires laboratories to report all hepatitis B surface antigen and hepatitis B surface antibody test results for children under 5 years of age when patient age is known. Requiring the reporting of all hepatitis B surface antigen test results for all ages, as well as all hepatitis B e antigen test results, will improve individual patient outcomes and decrease hepatitis B morbidity and mortality in New York City.

More than 243,000 people are living with chronic (active) hepatitis B in New York City, with 5,346 new cases reported in 2021. Most people who acquire hepatitis B infection as adults will clear the virus on their own, but many will progress to chronic hepatitis B, which can lead to serious health issues, including cirrhosis and liver cancer. All people with chronic hepatitis B require engagement in care and regular monitoring for liver damage and other complications; a subset require treatment with antiviral medications.

Hepatitis B e antigen and hepatitis B surface antigen testing are used to diagnose hepatitis B infection and determine whether a person has chronic infection requiring treatment. Hepatitis B e antigen and hepatitis B surface antigen testing may also be used for people already diagnosed with chronic hepatitis B, including for disease monitoring, providing important information on infectiousness and treatment eligibility, and case classification by the Department.

Without negative hepatitis B e antigen and hepatitis B surface antigen test results, the Department has limited knowledge regarding follow-up testing and treatment of people who have tested positive for hepatitis B. Reporting of negative hepatitis B e antigen and hepatitis B surface antigen test results will allow the Department to better estimate the proportion of New Yorkers with hepatitis B infection who are appropriately tested and linked to care, identify gaps in access to care, develop targeted interventions to increase linkage to care and improve provider knowledge of hepatitis B testing and treatment guidelines, and increase disease monitoring.

#### Hepatitis C Reporting

The Department is also requesting that the Board amend Heath Code  $\S \ 13.03(b)(3)(C)$  to require laboratories to report all hepatitis C antibody test results, including positive, negative and indeterminate results. The Health Code currently requires laboratories, in addition to reporting all positive hepatitis C test results pursuant to  $\S \ 13.03(a)$ , to report all hepatitis C nucleic acid amplification test results. Requiring the additional reporting of all hepatitis C antibody test results will improve individual patient outcomes and decrease hepatitis C morbidity and mortality in New York City.

More than 86,000 people are living with chronic hepatitis C in New York City, with 2,832 new cases reported in 2021. Approximately 15% of people with hepatitis C will clear the virus on their own, but most will develop chronic hepatitis C, which can lead to serious health issues, including cirrhosis and liver cancer if left untreated. Identification of acute hepatitis C infection (infection within six months following exposure to the virus) allows an opportunity to recognize and break chains of hepatitis C transmission. However, of the 2,832 cases of hepatitis C reported to the Department in 2021, only 130 were identified to be acute infections through resource-intensive case investigation.

Hepatitis C antibody testing is an initial screening test to determine whether a person has a current or prior hepatitis C infection, which should be followed by a confirmatory hepatitis C RNA test. More complete detection of acute infection at the population level could be made possible by identifying people who had a negative hepatitis C antibody test with a subsequent positive hepatitis C antibody test within 12 months. Such a pattern would indicate seroconversion and recent infection, which would prompt the Department to investigate the transmission event and engage the individual in care. Reporting of negative hepatitis C antibody results will thus allow the Department to better recognize recent hepatitis C transmission and detect clusters, improve its understanding of hepatitis C disease burden in New York City, identify inequities in hepatitis C screening to inform targeted outreach and other public health interventions, and support earlier linkage to care, treatment and cure for people with recent infection, thereby reducing the risk of transmission.

#### **Statutory Authority**

The authority for these proposed amendments to the Health Code is found in sections 556, 558 and 1043 of the Charter. Section 556 of the Charter provides the Department with jurisdiction to regulate all matters affecting health in New York City. Section 558 of the Charter empowers the Board to amend the Health Code and to include all matters to which the Department's authority extends. Section 1043 grants the Department rule-making authority. Further, New York State Public Health Law § 580(3)(a) authorizes the Department "to enact or enforce additional laws, codes or regulations affecting clinical laboratories...related to the control, prevention or reporting of diseases or medical conditions or to the control or abatement of public health nuisances."

For purposes of this paragraph, syphilis tests include, but are not limited to, treponemal tests, non-treponemal tests and direct detection tests, such as darkfield microscopy, direct fluorescent antibody and polymerase chain reaction tests.

- (B) Where the result of a <u>treponemal or non-treponemal</u> syphilis test is indeterminate, the laboratory must [report the indeterminate test result to the Department] <u>perform additional testing as provided herein</u>. For purposes of this [subsection (b)(2)] <u>subparagraph</u>, an indeterminate test result is one in which the result of a test is weakly reactive, minimally reactive, equivocal, inconclusive, or otherwise indeterminate; an indeterminate result does not include instances where two separate tests have conclusive but discordant results.

- (D) If a laboratory obtains negative or non-reactive results or an indeterminate result on a specimen submitted for syphilis testing and refers a specimen for further syphilis testing to another laboratory, and such further syphilis tests yield positive or reactive results, then, in addition to the testing laboratory reporting such positive or reactive results, the referring laboratory shall report both the negative or non-reactive results or indeterminate result obtained by it and also the positive or reactive results of any such further syphilis testing within 24 hours of obtaining the results from the testing laboratory.
- (E) If a laboratory has been referred a specimen to perform only tests associated with an indeterminate result obtained at the referring laboratory, and such associated syphilis tests have yielded only indeterminate results, then, in addition to the testing laboratory reporting such indeterminate results, the referring laboratory shall report both the indeterminate result obtained by it and also the indeterminate results of such further syphilis testing within 24 hours of obtaining the results from the testing laboratory.]

- (B) With regard to hepatitis B, all hepatitis B DNA, hepatitis B e antigen and hepatitis B surface antigen test results must be reported, including positive, negative[,] and indeterminate results. In addition, all [hepatitis B surface antigen and] hepatitis B surface antibody test results, including positive, negative[,] and indeterminate results, for children ages 0 days to 1,825 days (birth up to the fifth birthday) must be reported electronically in accordance with subdivision (c) of this section when patient age is known. Blood bank laboratories and other laboratories that perform hepatitis B DNA, hepatitis B e antigen or hepatitis B surface antigen tests on donated blood are exempt from reporting negative and indeterminate hepatitis B DNA, hepatitis B e antigen or hepatitis B surface antigen test results for such donated blood.
  - (C) With regard to hepatitis C:
- (i) All hepatitis C nucleic acid amplification and hepatitis C antibody test results, including [both] positive, [and] negative and indeterminate results, must be reported electronically in accordance with subdivision (c) of this section. Blood bank laboratories and other laboratories that perform hepatitis C nucleic acid amplification and hepatitis C antibody tests on donated blood, without a positive hepatitis C antibody test, are exempt from reporting negative hepatitis C nucleic acid amplification or hepatitis C antibody test results for such donated blood.

Section 556(c)(1) of the Charter authorizes the Department to supervise and control the registration of births and deaths. Section 1043(a) of the Charter grants rulemaking powers to the Department.

Where can I find the Department's rules? The Department's rules and the Health Code are located in Title 24 of the Rules of the City of New York.

What laws govern the rulemaking process? The Department must satisfy the requirements of Section 1043 of the Charter when adding or amending rules. This notice is made according to the requirements of Section 1043(b) of the Charter.

The proposed amendments were not included in the Department's regulatory agenda for this fiscal year because it did not contemplate this amendment at the time the regulatory agenda was published.

#### Statement of Basis and Purpose of Proposed Rule

Medication-induced termination of pregnancy involves the intentional use of medicines to end a pregnancy. More than half (54%) of induced terminations of pregnancy ("ITOPs") in the United States are conducted using this method. 1 Eligible patients who opt for medication ITOPs can receive their medication from a licensed provider, or from a retail or mail-order pharmacy.

Currently, the most common medication ITOP in the United States is a two-drug regimen using mifepristone and misoprostol. This regimen is approved for use up to 10 weeks of pregnancy,2 and research has shown provision beyond 10 weeks is safe and effective. The U.S. Food and Drug Administration ("FDA") first approved mifepristone for medication abortion in 2000, and issued subsequent updates to its approved use in 2016 and 2021. Since 2016, the FDA labeling for mifepristone no longer indicates that the medication should be used only in the clinician's office. Since 2021, the FDA has allowed patients to receive the medication either in person or via mail delivery. As of January 2023, the FDA also authorized retail pharmacies to dispense mifepristone. With the removal of the requirement for in-person dispensing, telemedicine has increasingly become a more common

modality for patient access. Patients can safely and effectively receive and use mifepristone along with misoprostol at home and routine inperson follow up is not normally necessary after a medication ITOP.<sup>4</sup>

All ITOPs in New York City must be reported to the Department pursuant to Article 203 of the Health Code. However, there remains some uncertainty among health care providers about whether medication ITOPs should be reported pursuant to Article 203 because the Health Code does not include an explicit provision for a medication ITOP that occurs in the home without a health care provider in attendance then or afterwards.

The Department is therefore proposing to amend Article 203 to specifically include medication ITOPs within the existing definition of ITOP, clarify that they must be reported to the Department when the patient is within New York City at the time the abortion medication is prescribed or ordered, and specify the timing of the reporting. Updating Article 203 in this manner is necessary to ensure full and accurate reporting of medication ITOPs occurring in the city. In addition, the Department is proposing to modify section 203.07(a) of the Health Code to add the words "certification and" preceding "confidential medical report" in the first sentence, which had been inadvertently omitted when this section was recently amended.

What rules govern the rulemaking process? The rulemaking process is governed by the requirements of New York City Charter ("Charter") §1043. The proposed rule regarding carbapenem-resistant organisms reporting was not included in the FY 2024 regulatory agenda because it was not contemplated when the Department published the agenda.

#### Statement of Basis and Purpose

The Department's Division of Disease Control conducts disease surveillance and control activities for most of the diseases required to be reported pursuant to Article 11 (Reportable Diseases and Conditions) of the Health Code.

To conduct more effective, timely and complete disease surveillance and control, the Department is proposing that the Board amend Article 11 of the New York City Health Code as described below.

Reporting Carbapenem-Resistant Organism (CRO) from Animals Carbapenems are a class of antibiotics that are effective against many types of bacteria, including bacteria that may be resistant to other types of antibiotics. The Department is requesting that the Board amend Health Code \$11.25(a)(2) to add carbapenem-resistant organisms (CRO) to the list of reportable diseases in animals, making it reportable by veterinarians, animal care professionals, and veterinary diagnostic laboratories.

Antimicrobial resistance is a growing threat to humans and animals. Like people, animals can be infected with CROs, and like human

healthcare facilities, veterinary hospitals can have CRO outbreaks. While the risk of CRO-infected animals to human health is unknown, suspected CRO transmission has occurred between veterinary professionals and animal patients. ii And human and animal bacteria are routinely shared between owners and pets living in the same household, showing the potential for CRO transmission in households. iii

CROs have been detected in animals in the United States. In 2018, a cluster of animals with CRO was identified at a Philadelphia veterinary facility. The facility, in collaboration with the local health department, used multiple interventions to control CRO spread among veterinary patients. We CRO infections are already being detected in NYC pets, as seen by data shared by a high-volume NYC veterinary hospital. A 2017 retrospective analysis from this facility identified 32 CROs cultured from pets over a five-month period. Currently, there are no routine mechanisms for the Department to be notified about CRO infections among animals in real time to enable molecular characterization, infection prevention, and containment in animal care facilities.

One Health is a collaborative, multidisciplinary approach, born from the idea that human health is deeply connected to animal and environmental health. In a 2019 report on Antibiotic Resistant Threats in the United States, CDC emphasized that a One Health approach is critical for combating antibiotic resistance. CDC highlighted that to address gaps in the fight against antibiotic resistance, we need state and local tools to detect and respond to antibiotic-resistant threats; improved local antibiotic resistance data to better understand trends and inform outbreak response; and increased collaboration between public health and health care to prevent the spread of resistant organisms.

The proposed Health Code amendment uses a One Health approach The proposed reach Code anendment uses a One Treatment approach to address the needs outlined by CDC and the proposed revision is consistent with recently proposed changes for human CRO reporting in NYC. By making CROs in animals reportable, the Department will be better equipped to monitor CRO trends in animals, identify risk factors for CROs in animals, and guide interventions for CRO prevention and containment.

#### **Statutory Authority**

The authority for this proposed amendment is found in Sections 556, 558 and 1043 of the Charter. Section 556 of the Charter provides the Department with jurisdiction to protect and promote the health of all persons in the City of New York. Sections 558(b) and (c) of the Charter empower the Board to amend the Health Code and to include all matters to which the Department's authority extends. Section 1043 grants the Department rule-making authority.

**RESOLVED**, that paragraph 2 of subdivision (a) of section 11.25 of Article 11 of the New York City Health Code, as set forth in Title 24 of the Rules of the City of New York, be amended to include carbapenem-resistant organisms to the list of reportable animal diseases communicable to humans, in alphabetical order, and for such list to now read as follows:

#### §11.25 Reports and control of animal diseases communicable to humans.

(2) Animals infected with any of the diseases set forth in this paragraph shall be reported to the Department within 24 hours of confirmed diagnosis by telephone or in writing by submission of a report form via facsimile, mail or in an electronic transmission acceptable to the Department:
