#### COMMISSIONERS OF THE SINKING FUND OF THE CITY OF NEW YORK.

Proceedings of the Commissioners of the Sinking Fund at a Meeting held at the Mayor's Office, at 2 o'clock P. M. on Friday, May 18, 1894.

Present—Thomas F. Gilroy, Mayor; Frederick Smyth, Recorder; Ashbel P. Fitch, Comptroller; Joseph J. O'Donohue, Chamberlain, and Nicholas T. Brown, Chairman Committee on Finance, Board of Aldermen.

The minutes of the meeting held May 17, 1894, were read and approved.

The Secretary presented the following report with tabulated list of bids received, for award of contracts for certain furnishings and alterations, New Criminal Court Building :

FINANCE DEPARTMENT -COMPTROLLER'S OFFICE, May 18, 1894.

To the Commissioners of the Sinking Fund:

GENTLEMEN—On May 17, 1894, the bids which had been received by the Commissioners of the Sinking Fund for furnishing materials and performing work required for the furnishings and alterations in the New Criminal Court Building, as authorized by resolution of March 1, 1894, were opened in the presence of the Mayor, the Chamberlain and the Comptroller.

The advertisement called for bids as follows :

I. Furniture.

2. Metallic fixtures.

3. Steam-heating and ventilation, alterations.

4. Joiner-work, mason-work, plastering, iron-work, plumbing, gas-fitting, electric-lighting, painting, etc.

sioners of the Sinking Fund at a meeting held March 1, 1894, and approved April 16, 1894, be and hereby are awarded to the lowest bidders respectively as follows :

Walter F. Barnes, for furniture, seventeen thousand six hundred and forty-five dollars (\$17.645).

Fenton Metallic Manufacturing Company, for metallic fixtures, forty-eight thousand five hundred and five dollars and eighty cents (\$48,505.80).

Q. N. Evans Construction Company, for alterations to steam-heating and ventilation, six thousand eight hundred and sixty-five dollars (\$6,865).

P. K. Lantry, for joiner-work, mason-work, plastering, iron-work, plumbing, gas-fitting, electric-lighting, painting and other work, as specified under head of "General Items," thirty-eight thousand nine hundred and twelve dollars (\$38,912).

Resolved, That the Comptroller be and hereby is authorized to return to the unsuccessful bidders the amounts of their security deposits.

Which were unanimously adopted.

The Comptroller offered the following resolution for payment to contractors on the New Criminal Court Building :

Resolved, That the Comptroller be and hereby is authorized and directed to make payment in full to the Jackson Architectural Iron Works, the Q. N. Evans Construction Company, and Mr. James Fay, of their respective contracts, in accordance with the certificates and vouchers received from the Commissioner of Public Works, for work done and materials furnished for the construction of the New Criminal Court Building, the Commissioner of Public Works having certified to this Board, under date of May 8, 1894, that the construction of the building was not at any time delayed by lack of diligence in the performance of the said contracts.

Which was unanimously adopted.

The Comptroller offered the following resolution to authorize the issue of \$100,000 Criminal Court-house Bonds:

Resolved, That, pursuant to the provisions of section 8 of chapter 371 of the Laws of 1887, the Commissioners of the Sinking Fund hereby authorize and direct the Comptroller to issue bonds of the Mayor, Aldermen and Commonalty of the City of New York, to the amount of one hundred thousand dollars (\$100,000), to be known as "Criminal Court-house Bonds," payable from taxation and redeemable in not less than ten nor more than twenty years from the date of issue, bearing interest at a rate not exceeding three per cent. per annum, the proceeds of which shall be applied to the payment of expenses incurred, and to be incurred, in the construction of the New Criminal Court Building ; provided, also, that said bonds shall be exempted from taxation by the City and County of New York, in pursuance of the authority of section 137 of the New York City Consolidation Act of 1882, and an ordinance of the Common Council passed October 2, 1880.

Which was unanimously adopted.

The following communication was received from the Armory Board for payment of claim of John R. Thomas, Architect :

BOARD OF ARMORY COMMISSIONERS-SECRETARY'S OFFICE, ) STEWART BUILDING, NO. 280 BROADWAY, New York, May 4, 1894. To the Honorable the Commissioners of the Sinking Fund : GENTLEMEN-At a meeting of the Armory Board, held this day, the following resolution was adopted: "Resolved, That the Comptroller be authorized, with the concurrence of the Commissioners of the Sinking Fund to pay to John R. Thomas, Architect, the sum of two thousand five hundred (2,500) dollars, as per accompanying voucher, on account for professional services in the erection of the armory building on Madison avenue, between Ninety-fourth and Ninety-fifth streets." Whereupon the Comptroller offered the following : Resolved, That the Commissioners of the Sinking Fund hereby concur in a resolution adopted by the Armory Board on May 4, 1894, for the payment of two thousand five hundred dollars (\$2,500) to John R. Thomas, on account of professional services as Architect of the armory build ing, on Madison avenue, between Ninety-fourth and Ninety-fifth streets. Which was unanimously adopted. The following communication was received from the Board of Police for lease of premises No. 34 East Twenty-ninth street for Seventeenth Police Precinct : POLICE DEPARTMENT OF THE CITY OF NEW YORK, No. 300 MULBERRY STREET, New York, May 15, 1894. To the Honorable the Commissioners of the Sinking Fund : GENTLEMEN-At a meeting of the Board of Police held this day it was

Resolved, That the Commissioners of the Sinking Fund hereby approve of and authorize the renewal of the lease to the City, dated April 6, 1893, from Robert Goelet and Ogden Goelet, of the premises No. 34 East Twenty-ninth street, for the use of the Police Department as a station-house, lodging-house and prison for the Seventeenth (formerly Twenty-fifth) Police Precinct, for the term of one year from May I, 1894, at a rental of two thousand dollars (\$2,000) per annum; and the Commissioners of the Sinking Fund deeming the rent fair and reasonable, and that it would be for the interest of the City that such renewal should be made, the Comptroller is hereby authorized and directed to indorse such renewal upon the lease of said premises, dated April 6, 1893, as provided by sections 123 and 181 of the New York City Consolidation Act of 1882.


