

### Hearings.

In respect to the erection of a new slaughter house, corner Fortieth street and Eleventh avenue, adjourned to Wednesday, February 23, at I o'clock P. M. ; in respect to a modification of orders on certain tenement houses.

#### Resolutions.

That the application of Frederick Baatz for correction of clerical error in the death record of his wife, Caroline Baatz, be and is hereby granted; that the Attorney be authorized and directed to commence actions against Rev. John Quirk, Dr. A. Jacoby, Rev. George H. Houghton, and Rev. Charles C. Parsons for violations of the Sanitary Code ; that the Attorney be authorized to discontinue suits against Dr. Thomas B. Sterling and Mrs. Susannah Blackhall for violation of the Sanitary Code.

#### Sanitary Bureau.

The following is a record of the work performed by the Sanitary Bureau during the week ending February 12, 1876: The total number of inspections made by the Inspectors was 1,676, as follows : 8 public buildings, 890 tenement houses, 102 private dwellings, 56 other dwellings, 6 manufactories and workshops, 6 stores and warehouses, 54 stables, 54 slaughter-houses, 3 fat-rendering establish-ments, 2 stock yards, 2 manure dumps, 2 swamps, 24 sunken and vacant lots, 26 yards, courts, and areas, 66 cellars and basements, 159 waste-pipes and drains, 113 privies and water-closets, 2 streetgutters and sidewalks, 11 dangerous stairways, 2 cisterns and cesspools, 7 violations of the Code, 1 dangerous and smoky chimney, 7 other nuisances, together with 73 visits of the Inspectors to cases of contagious and infectious disease.

The number of reports thereon received from the Inspectors was 500. During the past week 66 complaints were received from citizens, and referred to the Inspectors for investigation and report. 37 permits were issued to consignees of vessels to discharge cargoes, on vouchers from the Health Officer of the Port. 93 permits were granted to scavengers to empty, clean, and disinfect privy-sinks.

The Disinfecting Corps have visited 46 houses where contagious diseases were found, and

have disinfected and fumigated 43 dwellings, 43 privy-sinks, together with clothing, bedding, etc. 25 persons sick with small-pox were removed to Hospital and 5 dead bodies to the Morgue by the Ambulance Corps.

1,070 cans and 131 tanks of night-soil were removed by the scavengers from the privy-vaults of the city during the week ending February 12, 1876.

The following amount of meat and fish was condemned by the officers as unfit for human food

The following amount of meat and fish was condemned by the officers as unfit for human food during the week ending February 12, 1876 : Calves (bob), 127 carcasses ; calves (case) I carcass ; sheep, 3 carcasses ; veal (bob), 224 pounds ; and fish, 2,050 pounds. During the week ending February 12, 1876, there were issued from this bureau 610 burial permits for city deaths, 18 for bodies *in transitu*, and 57 for the interment of still-born infants. There were recorded 610 deaths, 173 marriages, 502 births, 57 still-births, 18 applications for transit permits, and 51 returns from Coroners. There were 28 searches of the registers of births, marriages, and deaths, and 2 transcripts of birth record, 5 of marriage, and 21 of death were issued from this bureau. ### HEALTH DEPARTMENT OF THE CITY OF NEW YORK, BUREAU OF VITAL STATISTICS, February 15, 1876.

### To W. DE F. DAY, M. D., Sanitary Superintendent and Register :

SIR-There were 610 deaths reported in New York City during the week ending Saturday, the 12th inst., being an increase of 10 compared with the number reported the previous week, and 16 more than the number reported the corresponding week of 1875.

more than the number reported the corresponding week of 1875. The actual number of deaths during the week ending February 5 was 599, or 21 more than occurred during the corresponding period of the past year, showing an annual death-rate of 29.51 per 1,000 persons living, the population estimated at 1,055,304. The annual rate of mortality per 1,000 persons living, according to the most recent weekly returns (see Table "A"), in Boston was 33.14; Washington, 29.61; Baltimore, 23.34; Charleston, 33.99: Nashville, 30.15; Chicago, 18.14; Newark, 43.55; Philadelphia, 27.23; St. Louis, 23.58; Richmond, 17.93; Brooklyn, 25.32; London, 26.7; Dublin, 34; Glasgow, 30; Edinburgh, 23; Bombay, 26.7; Madras, 42.4; Paris, 29.6; Brussels, 26.3; Amsterdam, 26.6; Rotterdam, 29.2; Copenhagen, 27.2; Christiania, 34.6; Berlin, 24; Munich, 33.3; Vienna, 29.3; Buda-Pesth, 43.1; Rome, 36.5; Alexandria, 41.1. The increase of deaths reported during the past week compared with the previous week was—in small-pox, 10; measles, 7; scarlatina, 13; diphtheria, 2; membraneous croup, 1; whooping cough, 7; typhus fever, 1; bronchitis, 2; pneumonia, 15; diseases of brain and nervous system, 8; Bright's disease and nephritis, 4; deaths in institutions, 9; and children under 5 years of age, 34; and a decrease of 5 in typhoid fever, 6 in puerperal diseases, 4 in cancer, 14 in phthisis pulmonalis, 6 in diseases of the heart, 5 in marasmus and scrofula, and 8 in hydrocephalus and tubucular meningitis. total saturation (as reported by Daniel Draper, Director of Meteorological Observatory, at Central Park).

The actual number of deaths which occurred in this city during the month of January, the present year, was 2,384, against 2,801 for the corresponding period of last year (see Table "B"). There was a marked decrease in deaths from contagious diseases, except measles and diphtheria, which increased 34 and 42 respectively. The decrease in deaths from zymotic diseases was 79; constitutional, 35; local, 261; developmental, 16; and deaths from violence, 26. The mean temperature during the month was 35.7 degrees Fahr., or 11.1 degrees higher than that charged to the corresponding month of last year, and the mean humidity was 74—saturation, 100—against 84 of the same period of the previous year. same period of the previous year.

### BOARD OF EDUCATION.

WEDNESDAY, February 2, 1876.

The Board of Education held a stated session at the Hall of the Board, on Wednesday afternoon, February 2, at 4 o'clock P. M.

Present—Wm. Wood, Esq., President, and Commissioners Baker, Beardslee, Caylus, Dowd, Fuller, Goulding, Halsted, Kane, Kelly, Klamroth, Mathewson, Place, Traud, Walker, West, Wetmore, and Wilkins—18.

The minutes of the stated session of January 12 and 19 were approved.

The President laid before the Board the following correspondence between the President and the Comptroller, and a letter from William Herring, Esq., Counsel for the Board :

NEW YORK, January 20, 1876.

Hon. ANDREW H. GREEN, Comptroller, etc.:

SIR-I forward herewith a certified copy of a resolution adopted on the 19th inst. by the Board of Education, making a requisition on you for funds to be applied by the Board in payment of the obligations incurred by it. This action was taken in conformity with the opinion of the Counsel to the Corporation, recently submitted to this Board and to yourself, to the effect that this Board is legally the controller of the funds apportioned for the purposes of Public Instruction.

### HENRY P. WEST, Esq., Chairman Committee on By-Laws, Board of Education :

DEAR SIR-In conformity with instructions, I have called upon the Comptroller and inquired of him whether he proposed to comply with the request of the Board of Education in depositing the sum of three hundred thousand dollars with the City Chamberlain, subject to the drafts of the Board, signed by its President and Clerk.

Having failed to receive any affirmative response, I haved obtained from Hon. George C. Barrett an order directing the Comptroller to show cause, on Monday next, at a Special Term of the Supreme Court, why a mandamus should not issue commanding said Comptroller to deposit the moneys of the Board as requested. Pending the disposition of the question involved, the Comptroller has consented that payment of the obligations of the Board shall continue to be made as heretofore, without prejudice to the rights of the parties.

### To the Board of Education:

I have carefully considered a communication from the President of the Board of Education, dated 20th January, and the opinion of the Counsel to the Corporation alluded to therein. The latter refers to certain decisions relative to the respective liabilities of the city and the Board of

Education or College of the City of New York, as controlling the opinion. Without these supposed decisions it is quite apparent, from a reading of the opinion, that the Counsel to the Corporation would be unwilling to sustain the ground taken by the Board of Education as expressed in their resolution which is inclosed in your communication. On examination it appears that those decisions are not upon the direct point involved in this

resolution of the Board of Education.

From James Marlow, for appointment as Agent of Truancy. Referred to the Committee on By-laws, Elections, and Qualifications.

From John McMahon, relative to Street Cleaning in front on the Normal College. Referred to the Committee on Normal College.

The Special Order of Business, being the report of the Committee on the Course of Study and School Books, as amended, on the study of the German and French languages, was taken up, and the report of the Committee was adopted.

Commissioner Kane presented a report from the Committee on Evening Schools, recommend-ing the payment of sundry teachers for registering pupils in Evening Schools. Adopted.

Commissioner Halsted presented a report from the Committee on Teachers, relative to the dis-continuing Grammar School No. 6, Randall's Island. Recommitted.

Also, nominating Vice-Principals of Primary Department Grammar School No. 68 and Primary School No. 19. Adopted.

Also, to discontinue services of the Vice-Principal of Primary Department Grammar School No. 6, Randall's Island. Adopted.

Also, appointing male assistants in Grammar School No. 46 and Grammar School No. 54. Adopted.

Also, to transfer certain Vice-Principals in the Twelfth Ward. Adopted.

Also, relative to the communication from William Van Houten, in reference to his children, in the Twenty-second Ward Schools. Adopted.

Commissioner West presented a report from the Committee on By-Laws, Elections, and Qualifications, relative to the amended By-Laws on Musical Instruction. Adopted.

Also, relative to a communication from Michael F. Power, Nineteenth Ward. Adopted.

Commissioner Dowd presented a report from the Committee on Buildings, to authorize the advertising of proposals for an iron stairway to premises of Primary School No. 33. Adopted.

Commissioner Fuller presented a report from the Committee on Normal College, asking for an appropriation for the literary institute of the College. Referred to the Finance Committee.

Also, to appoint Mr. John Bogart to superintend the work of improving the grounds around the Normal College. Adopted.

Also, to accept the resignation of Miss Hattie A. Patterson, and appointing Miss Margaret Merrington, with the promotion of several Tutors, in the Training School. Adopted.

Also, recommending the payment of sundry bills. Adopted.

Commissioner Dowd presented a report from the Committee on Buildings, approving sundry bills for repairs, etc. Adopted.

Commissioner Beardslee presented a report from the Committee on Supplies, relative to the award of contracts for Fechner's German Copy Books. Adopted.

Commissioner Klamroth presented a report from the Committee on Colored Schools, adverse to placing Colored School No. 2 under the care of the Trustees of the Eighth Ward. Adopted.

Also, to refer to the Trustees of the Twelfth Ward an application to grant use of rooms in Grammar School No 39 for a colored evening school in Harlem. Adopted.

Commissioner Baker presented a report from the Auditing Committee, recommending the payment of sundry bills for printing, postage, and other incidentals of the Board. Adopted.

Commissioner Fuller presented a report from the Committee on Normal College, submitting a bylaw relative to licensing the graduates of the Normal College. Referred to the Committee on By-laws, Elections, and Qualifications.

Commissioner Dowd presented a report from the Finance Committee, authorizing the payment of a bill of John Harrison, for repairs to Primary School No. 37, Third Ward, \$24.37. Adopted. Also, authorizing payment of a bill of Thomas Falvey, \$112.48, for certain repairs, Primary School No. 33, Nineteenth Ward. Adopted.

Commissioner Dowd presented a report from the Finance Committee, submitting a statement of the financial operations of the Board for 1875. Adopted, and ordered to be printed. Commissioner Dowd presented a report from the Finance Committee, appropriating the school

moneys for 1876 to the titles of expenditures. Adopted. Commissioner Goulding offered a resolution relative to a Normal College class on Saturdays for male teachers. Referred to the Committee on Normal College.

As this subject relates to an annual expenditure of more than three and a half millions of dollars, and the existing course of proceeding in the audit and payment of claims incurred by the Board of Education has been pursued for nearly three years with the acquiescence of all parties, and as a departure from this course would be subversive of a system which was intended to reform, and has to a great degree already reformed, the previously existing irresponsible and loose methods prevailing in the affairs of the city, I should feel a very great reluctance to assent to any change, unless it was very evident that the law required it ; and as the Board of Education, or at least some of its members, seem to desire to have the system changed by an application to the Courts, I shall facilitate any action to procure an adjudication that will settle the question, both for the Board of Education and the Finance Department, at the earliest possible day; and meantime, in order that no inconvenience may accrue to teachers and others having claims, will continue in the usual manner to pay their salaries and claims when certified to me by the Board of Education.


