

SIR-875 deaths were registered in this office during the week ending at noon of Saturday, June 28, 1890, representing an annual death-rate of 28.22 per 1,000 on an estimated population of 1,617,997.

On motion, the Secretary was directed to transmit to the Comptroller the security deposits made

of the wall between said streets. The Secretary to notify the Finance Department of the action of the Board. From Counsel to the Corporation—Reporting that in his opinion there is no objection to granting permit to the Maine Steamship Company to erect shed on platform westerly of Pier 38, East river. On motion of the President, the application of the Maine Steamship Company was taken from the table, ordered to be placed on file and the following resolution adopted : Resolved, That permission be and hereby is granted to the Maine Steamship Company to erect and construct a shed upon the platform on the westerly or lower side of Pier 38, East river, erected by them over land under water belonging to the Corporation of the City of New York, under resolution of this Board adopted at a meeting thereof held November 10, 1887; the said shed to be crected subject to the regulations required by chapter 249 of the Laws of 1875, and chapter 567 of the Laws of 1887, and of sections 711, 772 and 774 of chapter 410 of the Laws of 1882, com-monly called the "New York City Consolidation Act," and in conformity with plans to be submit-ted and approved by the Engineer-in-Chief of this Department : all the work to be done under his supervision ; the said shed to be and remain only during the will and pleasure of this Board ; provided, however, that the said Maine Steamship Company shall, within five days after the re-ceipt hereof, file in this office a written agreement of acceptance of the terms of this resolution. ceipt hereof, file in this office a written agreement of acceptance of the terms of this resolution.




