The Commission created by chapter 550 of the Laws of 1880, to revise, vacate, or modify assessments for local improvements in the City of New York, met pursuant to adjournment.

The petitioner in this case had paid several instalments on account of the assessment, and we are asked to determine whether the percentage of reduction should be based on the original amount assessed on each lot, or on the balance remaining unpaid.

In the Matter of Matthew Byrne (page 305 of Minutes), we held that the true construction of the act creating this Commission was that it required us to deal "with the amount of the assessment as imposed, and to grant relief by reducing the assessment as may be just and equitable." For the purpose of facilitating the business of the Commission it has been its custom to fix the relief granted by a percentage, but this is only another form of reaching a conclusion as to the amount which should have been originally assessed on each lot had the assessment been just and equitable in the first instance.

The Matter of Hughes, 93 N. V., page 512, was decided after our decision of the Matter of Byrne, but we consider that this decision construed only the act of 1858, which is quite different in its terms and its intention from the act of 1880, under which we are acting in these matters, for while the act of 1858 provides only a strict legal remedy in the cases of fraud or substantial error, the act of 1880 is much broader in its terms, and enables the Commission to award such relief as it deems just and equitable under all the circumstances of the case. Under the act of 1858 no remedy existed for the repayment of money once paid to the City on an assessment, but the act of deems just and equitable under all the circumstances of the case. Under the act of 1858 no remedy existed for the repayment of money once paid to the City on an assessment, but the act of 1880 by its equitable terms allows repayment to be made under certain circumstances. It would certainly be most inequitable for us to award a smaller measure of relief to a property-owner who had paid a portion of his assessment, than to one who had made no payment, and we do not consider such action to be either within the spirit or letter of the act of 1880.

We think, therefore, that the percentage of reduction should be computed on the assessment as originally imposed; the balance remaining will be the amount which, under our decision, is properly assessed on the petitioner's lots.

From these conclusions it follows that the reduction in this matter, made by us on January 15.
