

# WEEKLY INCIDENT BRIEF - COVID-19

## 10/26/2020 – 11/02/20

### Incident Summary

NYC Emergency Management continues to coordinate with our partners at the City, State, and Federal levels as well as the private sector in response to COVID-19. Additionally:

- Per [CDC guidance](#), employers should not require a positive COVID-19 test result or a healthcare provider's note for employees who are sick to validate their illness, qualify for sick leave, or to return to work.
- Governor Cuomo [released a guide](#) to the state's "NY Forward Reopening" Plan.

- Governor Cuomo announced the implementation of a new [early warning dashboard](#) to monitor and review how the virus is being contained on an ongoing basis.
