



REPORTED MORTALITY* for the week ending November 8, 1884, together with the ACTUAL MORTALITY for the week ending November 1, 1884.

W. DE F. DAY, M. D., Sanitary Superintendent and Register: SIR—There were 628 deaths reported to have occurred in this city during the week ending Saturday, November 8, 1884, which is an increase of 6, as compared with the number reported the preceding week, and 107 more than were reported during the corresponding week of the year 1883. The actual mortality for the week ending November 1, 1884, was 628, which is 56.8 above the average for the corresponding week for the past five years, and represents an annual death-rate of 23.82 per 1,000 persons living, the population estimated at 1,370,687.
