Sanitary Bureau.

The following is a record of the work performed in the Sanitary Bureau for the week ending November 18, 1882.

The total number of inspections made by the Sanitary and Assistant Sanitary Inspectors was

1498, as follows, viz.:

2 public buildings, 738 tenement-houses, 87 private dwellings, 55 other dwellings, 7 manufactories and workshops, 12 stores and warehouses, 46 stables, 25 slaughter-houses, 1 lodging-house, 2 lard-rendering establishments, 1 brewery, 1 mill, 26 sunken and vacant lots, 66 yards, courts and areas, 75 cellars and basements, 149 waste-pipes and drains, 184 privies and water-closets, 7 streets, gutters and sidewalks, 12 dangerous stairways, 1 smoky chimney, 1 cesspool, and 10 other purisances.

The number of reports thereon received from the Inspectors was 499.

During the past week 118 complaints were received from citizens and referred to the Sanitary and Assistant Sanitary Inspectors for investigation and report.

42 permits were issued to the consignees of vessels to discharge cargoes, on vouchers from the Health Officer of the Port.

72 permits were granted scavengers to empty, clean, and disinfect privy sinks.
The Disinfecting Corps have visited 63 premises where contagious diseases were found, and have disinfected and fumigated 62 houses, 62 privy sinks, together with clothing, bedding, etc.
4 cases of contagious disease were removed to hospital by the Ambulance Corps.

Bureau of Vital Stati tics.

The certificates of 533 births, 55 still-births, 284 marriages, and 582 deaths, reported to have taken place in this city, were received by this Bureau during the week ending Saturday, November 18, 1882. This shows a decrease of 14 births, an increase of 37 marriages and 19 deaths, and the same number of still-births, when compared with the number received during the preceding week; but when compared with the corresponding week of the year 1881, there was an increase of 84 births and 25 marriages, a decrease of 97 deaths, and the same number of still-births. Compared with the mortality reported during the preceding week, the deaths from measles decreased 4; whooping cough, 4; typhoid fever, 4; cerebro-spinal fever, 2; croup, 4; pneumonia, 1; aneurism, 3; marasmus, tabes mesenterica and scrofula, 17; convulsions, 6; all diseases of the brain and nervous system, 4; Bright's disease and nephritis, 11; cyanosis and atelectasis, 3; surgical operations, 1; suicide, 2; while the deaths from small-pox increased 1; scarlatina, 4; diphtheria, 4; erysipelas, 1; malarial fevers, 4; puerperal diseases, 6; diarrhocal diseases, 5; inanition, 1; alcoholism, 5; cancer, 4; phthisis pulmonalis, 7; bronchitis, 3; heart diseases, 1; hydrocephalus and tubercular meningitis, 2; meningitis and encephalitis, 1; apoplexy, 2; cirrhosis and hepatitis, 1; gastritis, enteritis and peritonitis, 4; premature and preternatural births, 7; and drowning, 2. The number of deaths from rheumatism and gout was the same in the two successive weeks.

Of the total number of deaths reported for the week, 141 were in institutions, 280 in tenement-houses, 148 in houses containing three families or less, 8 in hotels and boarding-houses, 4 in rivers, streets, boats, etc.; 10 were on the basement floor, 111 on the first, 155 on the second, 81 on the third, 59 on the fourth, 20 on the fifth, 0 on the sixth; \$81 were stated to be residents of New York City, and I non-resident; 58 were stated to be single, 176 married, 80 widowed, and the condition of 268 was not stated; these were children who had not attained a marriageable age.

The total number of burial permits issued during the week are as follows, viz.: City deaths, \$82; still-births, 55; bodies in transit, 15; of the total burial permits issued for city and still-births 56 were upon certificates received from the Coroners; 533 births; 284 marriages; 55 still-births; 55 bed set 15; 15 applications for transit permits were recorded, indexed, and tabulated, 34 searches of the registers of births, marriages, and deaths were made, and 5 transcripts of the birth record, 11 of marriage, and 48 of death were issued during the week.

The mean temperature for the week ending November 18, 1882, was 42.1 degrees Fahr., the mean reading of the barometer was 29.959, the mean humidity was 88, saturation being 100, the number of miles traveled by the wind was 1,148, and the total amount of rain-fall was 0.35 inch depth of water, as reported by D. SIR—There were 553 deaths reported to have occurred in this city during the week ending Saturday, November 25, 1882, which is a decrease of 29, as compared with the number reported the preceding week, and 120 less than were reported during the corresponding week of the year 1881. The actual mortality for the week ending November 18, 1882, was 544, which is 7.2 below the average for the corresponding week for the past five years, and represents an annual death-rate of 21.85 per 1,000 persons living, the population estimated at 1,293,754.
