Improving Access to City Services

Annual Report 2009

Dear Friends,

As my two terms as Public Advocate for the City of New York are drawing to a close, I'd like to take a moment to reflect on some of our accomplishments.



Over the past eight years, my staff and I have worked hard to make city government work for you.

My ombudsman staff alone has handled more than 90,000 of your calls, problems ranging from arcane pre-school admission practices to food stamp eligibility to pervasive mold in public housing. Beyond the individual cases we handle, our policy and legislative accomplishments have undoubtedly reached countless other underserved New Yorkers. In the City Council, I have introduced or co-sponsored more than 300 bills. And my policy staff has conducted more than a hundred studies and investigations that have led to lasting change. Among other things, my office:


- Investigated child fatalities in city shelters, finding that 20 children in a three-year period had died of abuse or neglect. I introduced legislation that, in part, created a special training program for shelter staff. And, after my office identified a high turnover rate among child welfare attorneys, the city hired 25 additional lawyers for the Administration for Children's Services.
- Conducted food stamp investigations that helped accommodate working New Yorkers. Our advocacy resulted in the food stamp application being reduced from 16 pages to 4, evening and weekend food stamp office hours being adhered to, and a community-based outreach program that helped enroll over 75,000 New Yorkers in the program.
- Pushed the city Department of Education (DOE) to offer make-up sessions to students after my investigation showed that special ed services were withheld for up to 20,000 students. My office also pushed to prevent the illegal practice of forcing high school students to drop out. And, at the request of the State Assembly Education Committee, I assembled the Commission on School Governance to make recommendations about mayoral control of New York City public schools. In 2009, the Commission's recommendations were used by the State Legislature as a blueprint for its new school governance law.
- Introduced the Language Access in Pharmacies Act, which was signed by the Mayor in September, 2009. This law requires New York City chain pharmacies to translate medical instructions into the seven languages most commonly spoken by residents who have limited English proficiency. It ensures that nearly 2 million residents can make safer medical decisions. Because of my bill, New York City is the first locality in the United States to require translation services in pharmacies.
- Compiled a free Guide to Public Benefits for Immigrants, the first of its kind, available in English, Spanish, Korean, Chinese, Russian and Bengali. We've had requests for 60,000 copies.

Thank you for giving me the opportunity to do this and other important work.

As I look ahead, it's clear that the needs of vulnerable New Yorkers are sure to continue, especially in this troubled economy. Many turn to the Office of the Public Advocate as a last resort. The work that's done, however, is not always visible or even acknowledged. Our work often slips below the media's radar. But the fact remains that, over the last eight years, the Office of the Public Advocate helped improve the lives of New Yorkers. We identified needs. We offered solutions. And we got results.

About the Public Advocate's Office

The Office of the Public Advocate has dual roles in City government. The first is that of ombudsman, which means the office has a critical, charter-mandated constituent services function. An "ombudsman" is formally defined as a commissioner who acts as an independent referee between individuals and their government.

Exasperated, sometimes desperate New Yorkers turn to the Public Advocate's Office when they can't decipher arcane city rules or when they run into other bureaucratic brick walls, whether they involve public school enrollment or food stamp eligibility or snafus with utility bills. Over the course of eight years, ombudsmen and women have responded to more than 90,000 pleas for help.

The Public Advocate's second key role in City government is that of a watchdog over city agencies, a role that includes conducting investigations and recommending improvements when agency

performance falls short. Further, the Public Advocate, an ex-officio member of all Council committees, is empowered to introduce legislation. The Public Advocate has a say in city planning and the budget process and also is a trustee of the City's largest retirement system, the New York City Employee Retirement System (NYCERS).

The Office of the Public Advocate could help even more New Yorkers, given adequate resources, including an independent budget that is not subject to political whims or partisan reprisals.

In short, the Public Advocate plays a vital and sometimes pivotal role in effecting positive, progressive change for all New Yorkers. True to its name, this office really does advocate for the public. The net effect is to help make a great city even greater.

Commission on School Governance

In September 2008, Public Advocate Gotbaum released the Final Report of the Commission on School Governance. At the request of the State Assembly Education Committee, Gotbaum assembled the Commission to make recommendations about mayoral control of New York City public schools. The Commission met with more than 100 stakeholders on education around the city, and issued its official Findings and Recommendations in the fall of 2008. In 2009, the Commission's recommendations were used by the State Legislature as a blueprint for its new school governance law.

Law Requiring Pharmacies to Provide Translation Services for Prescriptions

In 2008, Public Advocate Gotbaum introduced a bill that would require city chain pharmacies to provide language assistance and translation services for non-English speakers. The Language Access in Pharmacies Act—which Mayor Bloomberg signed into law on September 3rd, 2009—also mandates that signs be posted to inform individuals of these services.

Guide to Public Benefits for Immigrants

Public Advocate Betsy Gotbaum produced and distributed a comprehensive <u>Guide to Public</u>
<u>Benefits for Immigrants in New York City.</u> The free guide provides valuable information on federal, state and city benefits, and is the first of its kind to specifically examine immigration status as part of benefit eligibility. The Public Advocate, in partnership with the New York Immigration Coalition, first released the guide in November 2008 in six languages: English, Russian, Chinese, Spanish, Korean and Bengali. About 60,000 requests have been made for copies of the guide.

City Services Satisfaction Project

In December 2008, Public Advocate Gotbaum and Mayor Bloomberg released the results of the largest municipal services survey ever conducted in the United States. The survey, spearheaded by the Mayor, Public Advocate, and the Fund for the City of New York, asked 100,000 New Yorkers their opinions of city services. The results have provided a quantitative measure of where city government can continue to improve service delivery.

Costco to Accept Food Stamps

After pressure and repeated urging from Public Advocate Betsy Gotbaum and Councilmember Eric Gioia, Costco announced that it would begin accepting food stamps at its New York City stores. With an increasing number of New Yorkers receiving and applying for food stamps, Gotbaum argued that, by changing its policy, Costco could improve its image and expand its customer base while providing a great service to struggling families.

Cleaning Up the "Bronx Swamp"

it would initiate a swift cleanup.

In April 2008, Public Advocate Gotbaum visited a stretch of filthy standing water in the South Bronx – termed the "Bronx Swamp" by local residents – to call on the city to take responsibility for its cleanup. With the detection of West Nile Virus by the city Department of Health (DOH), Gotbaum argued that the situation required immediate action. Soon after, the Mayor's office announced
