

SIR—There were 748 deaths reported to have occurred in this city during the week ending Saturday, May 14, 1887, which is a decrease of 12, as compared with the number reported the preceding week, and 123 more than were reported during the corresponding week of the year 1886. The actual mortality for the week ending May 7, 1887, was 746, which is 61.8 above the average for the corresponding week for the past five years, and represents an annual death-rate of 26.29 per 1,000 persons living, the population estimated at 1,475,440.
