In October 2021, OATH partnered with several Council and Assembly members to hold an event at the Brooklyn public library to educate residents how to respond to a summons.

In November 2021, OATH provided a virtual training to over 150 employees in the Department for the Aging on how to assist seniors who have summonses. The Senior Help initiative also brought *COURTEsy* (Court Education for Seniors) *program for senior centers throughout the 5 boroughs*.
